I am sending this letter in response to the Home Base Iowa Act, reporting on the substance of rules and procedures adopted to implement the provisions of this Act.

Pursuant to the Home Base Iowa Act, the Board of Nursing has enacted 655 Iowa Administrative Code, chapter 18, *Military Service and Veteran Reciprocity*.

Accordance with the Home Base Iowa Act, the Board of Nursing has also incorporated the following questions on all licensure applications; Are you a veteran?

The Board of Nursing in the past has issued licenses in a timely fashion to all applicants. Accompanying this letter please find the following report; *Number of Veteran Applications Processed.* The Pandemic and the processes which were in place leading up to July of 2021 did extend the number of days which licenses were issued. All licensing processes have returned to pre – pandemic practices.

In accordance with Chapter 18, please find the *Veteran Application Tracking* tool which addresses 18.2 *Military education, training and service credit* and 18.3 *Veteran reciprocity.*
