#### State Fiscal Year 2022

Beginning in July 2021, lowa began to experience severe storm systems which created high winds, heavy rains, flash flooding, and tornadoes resulting in significant damage to private/personal property across some lowa counties. Governor Reynolds proclaimed the following disaster emergencies.

This report covers expenditures for declared disasters from July 1, 2021, through June 30, 2022.

Some expenses from State Fiscal Year 2021 were expended in State Fiscal Year 2022 due to late invoices.

Some expenses from August 2020 and June 2021 proclaimed disasters were expended in State Fiscal Year 2022.
