Re: Report in accordance with Iowa Code § 272C.4(13)

Dear Governor Reynolds and Legislative Leaders:

This report is filed as required by Iowa Code section 272C.4(13), on behalf of the Board of Examiners of Shorthand Reporters. That section provides for a report from each licensing board designated in Iowa Code section 272C.1, providing information and statistics on credit received by individuals for education, training, and service pursuant to section 272C.4(11), and information and statistics on licenses and provisional licenses issued pursuant to section 272C.4(12).

Based on the provisions of Iowa Code section 272C.4(13), and the recommendation of the Board of Examiners of Shorthand Reporters, the Iowa Supreme Court adopted a new Iowa Court Rule 46.16 on December 18, 2014. Rule 46.16 implements Iowa Code section 272C.4(11) by addressing credit for education and training while in military service, and implements Iowa Code section 272C.4(12) by addressing certification of veterans already licensed as shorthand reporters in other states.
