Director Acton,

Iowa Code section 8.7 requires all gifts and bequests received by a department or accepted by the Governor on behalf of the State to be reported to the Iowa Ethics and Campaign Disclosure Board.

The law also requires the Board to submit to the Fiscal Services Division of the legislative Services Agency a written report listing all gifts and the purpose of each gift of bequest. The report must also include a listing of all gifts and bequests received by a department from a person if the cumulative value of all gifts and bequest received by the department from the person during the previous calendar year exceeds \$1,000.
