This letter and the attached document is in fulfillment of Iowa Code 15.343(3)"a" reporting the status of the Workforce Development Fund for the calendar quarter ending December 31, 2005.

During the 2nd quarter of the 2006 fiscal year 72 workforce development projects were awarded a total of \$1,001,814.00. These projects will result in 2805 individuals receiving enhanced skill training essential for Iowa businesses in today's globally competitive environment.

The quarter's activity consisted of:

- Four awards, totaling \$65,649.00, for consortium training projects involving two or more businesses having the same employee training needs;
- One award, totaling \$100,000.00, for business network training projects involving five or more businesses from two or more community college districts, which have identified a common training need;
- \$19,228.00 was awarded to six apprenticeship programs that provide a combination of classroom and on-the-job training to increase the skills of Iowa workers;
- \$816,937.00 provided for 61 incumbent employee training activities involving single businesses.

These projects are continued evidence of the successful partnership between Iowa's business community, community college network and the Department to delivery industry-driven workforce development programs maintaining Iowa's preeminence in the field.
