Summary of Project: These programs improve collaboration and coordination of cancer programming during the third year of a five-year project period. Activities will enhance cancer leadership and project outcomes through collaborative planning and implementation activities. Comprehensive Cancer Control programming will broaden its scope in policy, systems and environmental change with the implementation of SMART goals and objectives through high-impact population-based interventions. Collaboration with key internal and external partners and programs will continue. The Breast and Cervical Cancer Early Detection Program will provide cancer screening, patient navigation, diagnosis and referral to treatment, as needed, for a targeted population of 4,800 eligible low-income women ages 40 – 64, and will work to increase population-based screening across Iowa.
