Dear Secretary Marshall and Chief Clerk Brandsgard:

Attached is the Iowa Veterans Home's Annual Cost-Savings Report on ICN usage for FY '07. The report is divided into two categories: Administrative and Telemedicine

ADMINISTRATIVE

In addition to the 28 sessions listed in the report, IVH also approved 52 sessions for usage by other State agencies, colleges, libraries, etc. of our three ICN classrooms. We are pleased to be able to provide this public service to citizens of Marshalltown and the surrounding communities.

The Veterans Home is very appreciative of the programs that the University of Iowa Geriatric Education Center presents via the ICN, e.g., Geriatric Grand Rounds Series. Our medical/clinical staff has taken advantage of these quality, low-cost sessions, and has been able to obtain CME's and CEU's without leaving the facility.

TELEMEDICINE

A clinical work group continues to be involved in trying to increase telemedicine appointments for our residents. Our overall usage of telemedicine has significantly decreased over the past several years (we have a negative cost savings this fiscal year, the third year in a row). We had no telemedicine appointments for our residents in FY 07. This decrease is due to several factors:

- The VA did not renew their contract with the urologist who conducted the Urology Clinics because of budget constraints.
- Availability of physicians for a variety of other clinics.
- Scheduling
- Coordination

As stated above, a group of IVH administrative staff is working with Veterans Affairs Medical Center staff in an effort to stimulate increased telemedicine utilization for IVH residents, and to re-establish clinical lines of assessment.

IVH is involved in a collaborative effort with the VAMC in Knoxville and CIHCS in Des Moines in conducting outpatient psychiatric appointments for veterans not living at IVH. Twelve appointments were held in FY '07. The appointments are routine follow-ups for veterans living outside IVH and traveling from surrounding communities. There is no cost savings to IVH associated with these outpatient appointments. The clinics are coordinated through VA Knoxville and conducted with staff at the Des Moines VA facility. IVH provides skilled registered nursing staff to assist in the prescreening and assessment of the veterans; Knoxville reimburses us for our nursing staff's labor cost. The majority of veterans have provided positive comments about their appointments.
