Introduction:

Iowa Code 29C.20B(4) requires the Iowa Department of Human Services to report annually, by January 1 of each year, to the Legislative Fiscal Committee and the Government Oversight Committee concerning the activities of the Iowa Disaster Case Management Grant Program (IDCM) for the previous fiscal year.

Overview:

State Fiscal Year 2018

Beginning in July 2017, Iowa began to experience severe storm systems which created high winds, heavy rains, flash flooding, and tornadoes resulting in significant damage to private/personal property across some Iowa counties. Governor Reynolds proclaimed the following disaster emergencies.

This report covers expenditures for declared disasters from July 1, 2017, through June 30, 2018.

Some expenses from the March 2017 proclaimed disaster were expended in State Fiscal Year 2018.

The majority of expenses from the June 2018 proclaimed disasters will be included in State Fiscal Year 2019 annual report since the funds were expended in State Fiscal Year 2019.
