The Family Centered Program, Family Preservation, Treatment Foster Family Care, and Group Treatment were services offered under the Rehabilitative Treatment and Support Services (RTSS) Program. These services are no longer offered by Iowa Medicaid and have been replaced by the Remedial Services Program. Rehabilitation Support services were services offered under the Adult Rehabilitation Option (ARO) Program. These services are no longer offered by Iowa Medicaid and have been replaced by the Habilitation Services Program.
