- 1) Revenues are shown for months distributed to the DOT that occur the month after collection. So fiscal year reflects revenue receipt collection timeframe of June - May.
- 2) Due to accounting procedures related to when revenues are collected and distributed, the registration fees collected for TIME-21 during the last month of the fiscal year will be deposited in the next fiscal year. The amount transferred to TIME-21 for FY 2010 reflects the portion in excess of \$392.0 million collected from FY 2009 plus the amount in excess of \$392.0 million that was collected in FY 2010 through May.
