



SF 27 – Human Trafficking (LSB 1355 SV)

Fiscal Note Version – New Requested by Senator Kreiman

### **Description**

Senate File 27 clarifies and expands the definition of human trafficking. The Bill permits minors that are victims of human trafficking to receive reimbursement for certain expenses from the Victim Compensation Fund. The Bill also provides guardian ad litems for child witnesses of human trafficking.

### **Background**

#### **Correctional and Fiscal Information**

- Iowa's human trafficking law was enacted in FY 2007. There were no convictions in FY 2007 and FY 2008. However, expanding and clarifying the definition increases the likelihood of successful prosecutions under the law.
- 2. Human trafficking is punished as a Class D or Class C felony, depending on the circumstances. The average State cost for one Class D felony conviction ranges from \$5,600 (court costs, indigent defense, and probation) to \$12,800 (court costs with a jury, indigent defense, prison, and parole). Costs will be incurred across multiple fiscal years while the offender is supervised in the correctional system, either in prison or the community.
- 3. The average State cost for one Class C felony conviction ranges from \$6,200 (court costs, probation and indigent defense) to \$18,800 (court costs with a jury, prison, parole, and indigent defense). Costs will be incurred across multiple fiscal years while the offender is supervised in the correctional system, either in prison or the community.
- 4. The Victim Compensation Fund is currently experiencing financial difficulties.

### **Minority Data Information**

lowa's prison population was 8,740 offenders on June 30, 2008. Men were 91.3% of the population. According to the Department of Corrections (DOC), the racial composition of the prison system was: 72.3% white; 25.2% black; 0.8% Asian or Pacific Islander; 1.6% American Indian or Alaska Native; and 0.1% was unknown.

### **Assumptions**

#### **Correctional and Fiscal Impact**

- 1. The fiscal impact to the Victim Compensation Fund is expected to be minimal.
- 2. The fiscal impact to the State General Fund and counties for the expenses of providing guardian ad litems is expected to be minimal.

## **Minority Impact**

1. Offenders sentenced to prison for human trafficking may closely resemble the June 30, 2008, prison population.

2. Approximately 14.0% of lowa's population has at least one disability. The number of offenders convicted under this Bill who are disabled may be 14.0%.

## **Summary of Impacts**

# **Correctional Impact**

Expanding the definition of human trafficking may result in more convictions than current law. However, the correctional impact is expected to be minimal, because convictions are rare.

## **Minority Impact**

The minority impact is expected to be minimal, because convictions are rare under current law.

### **Fiscal Impact**

Senate File 27 is expected to have minimal fiscal impact to the Victim Compensation Fund and State and county General Funds.
