Keith H. Dunton, Former State Representative, Dies

Keith Holland Dunton, 70, of Thornburg, former State Representative, died late Saturday, April 6, at his home.

He was born March 20, 1915, in Deep River to Leroy and Sarah Faye Holland Dunton.

A graduate of Thornburg High School, he was a farmer and a Representative in the Iowa House for 20 years, where he chaired the Appropriations Committee and served on the Education and Transportation Committees. He represented Iowa, Keokuk and Washington Counties during his terms.

He married Ethel Cowan March 7, 1939, in Keota.

He lived in Deep River and the past 66 years in Thornburg where he was a member of the Thornburg United Methodist Church, Order of the Eastern Star of What Cheer, Universe Lodge 242 AF&AM at What Cheer, Elkahir Shrine of Cedar Rapids and the Elks Club at Oskaloosa.

He is survived by his wife; a daughter, Cynthia Kay Vogel; two grandchildren; a brother, William V. of Fountain Hill, Ariz.; and a half-brother, Philip of Texas; and a half-sister, Katherine Lynch of Iowa City.

Funeral services were held at 2 p.m., Wednesday, April 10 at the Harden Funeral Chapel at What Cheer with Rev. Kenneth Arentson officiating.
