**Iowa State Sen. Kyhl Is Dead**

PARKERSBURG—Veteran Iowa State Senator Vernon H. Kyhl, 65, died Monday morning at Grundy County Memorial Hospital in Grundy Center of cancer.

Kyhl, the president pro tem of the Iowa Senate at the time of his death, was in his seventh term as a senator from his district. The 19th District includes Butler and portions of Grundy, Franklin, Tama, Black Hawk, Bremer and Floyd Counties.

He had been unable to participate in the first session of the 65th General Assembly because of his illness.

Kyhl was a Parkersburg businessman who owned Kyhl Chevrolet-Buick Co. Farm and Home Supply at Marshalltown, and Farmech Manufacturing Company at Parkersburg. He owned farmland and was affiliated with Rasmussen Furniture in Waterloo.

He was first elected to the Iowa Senate in 1962 and represented four different constituencies during that time as a result of redistricting.

He served on the Parkersburg School Board for 23 years, 12 years as president and was a charter member of the Parkersburg Rotary Club. He was a member of the State Board of Alcoholism and of the Council of State Governments.
