He was a former state official and legislator from southwest Iowa.

Maurice A. Van Nostrand was born in Benedict, Nebraska on Feb. 9, 1925.

After attending the University of Nebraska, he served in the Air Force during World War II.

In 1946, he moved to Avoca, Iowa, where he operated grain elevators in Avoca-and Oakland for many years and started a cattle feeding operation in Oakland. During the same time, he was editor of

the Council Bluffs Nonpareil for six years.

During the 1960s, he served three terms in the Iowa Legislature. He moved to Des Moines in 1970. From 1971 to 1979, he was Chairman of the Iowa Commerce Commission and served as Governor Robert Ray's top advisor on energy

In recent years, he retired to southern California and then to Sun Lakes, Arizona

Survivors include his wife, the former Carol Rae Cummings, to whom he was married for 47 years.

Also surviving are three sons, Greg of Madison, Wisconsin, Kevin of Scottsdale,

continued to write editorials and in the 1967 session Carol traveled to Council Bluffs three days a week to put the editorial page together. Maurie served on the Board of Directors of the Salvation Army and the Pottawattamie County Health Center and was a member of the County Citizens Committee on Alcoholism and Carol served on the county Red Cross Board.

The Van Nostrand family...Greg born in 1949, Kevin (1952) and Jamie (1955)...were members of the Presbyterian Church, now the United Church of Avoca. Carol and Maurie served the church in various positions and were involved in many activities. In the school year of 1967/68 they were host family to Detlef Puhl, an American Field Service student from Germany...a relationship that is ongoing.

The family moved to Des Moines in December of 1970 and during Maurie's eight years on the lowa Commerce Commission he served as Governor Ray's energy advisor. He organized and served as Chairman for four years of the Energy Policy Council.

In 1979 Maurie resigned and took the position of VP-Public Affairs of AGRI Industries, a West Des Moines based regional grain marketing cooperative. Carol was accounts payable supervisor of a national HVAC contractor from 1970 until May of 1984. At that time they moved to California where Maurie had become a partner in 1983 of two wind energy companies that had roots in Iowa. 
FRANK C. VIERHUS

Frank C. Vierhus was a young man when he came to Avoca in the late teens. His sister, Katie (Mrs. S. M. Ferguson), was living here, and their parents, Mr. and Mrs. Frank Vierhus, had also moved to Avoca. During World War I Frank had been a student at the University of North Dakota and in its university military unit.

He worked for a time im the Kenkel Clothing Store, and then became associated with Henry Bornholdtin insurance and Federal land bank loans. In about 1920 he became a teller in the Avoca Statte Bank, whose president was Rudolph Stender. The bank became Frank's career. He was steadily promoted, and on the death of Mr. Stender he became president, remaining president until his death in 1968. He was responsible for the decision to build a modern and attractive building for the bank. The Firstar Bank now occupies it.

He became highly regarded in the local business and farming communities for llending a helping hand wherever possible. He personally put together the financing, erection, staffing and operation of Avoca's alfalfa mill, managed by Ronald Johnson and for many years providing an alfalfa haymarket for our farmers. He was responsible for interesting American Cyanimid in establishing its fertilizer plant in Avoca, now the Agri-FS, Inc. The Pittmann Seed Company came into being with his assistance. The nursing home in Avoca is also a product of his initiative. In his early Avoca days he was an outfielder on the Avoca baseball team. He loved music, pllaying clarinet in the town band, and later organizing a male singing quartet. He was a member of the American Legion, Mt. Nebo Lodge, the Scottish Rite, and Tangier Temple. He was a charter member of the Avoca Rotary Club.

Maurie and Carol were married in 1944. In addition to managing the Van Nostrand Grain Company, with Carol as bookkeeper in the early days, in 1961 Maurie helped organize and served on the board of directors of the original Avoca Nursing Home. He also had interests in the Oakland Feeding Corporation and the Van Nostrand Grain Company in Atlantic.

He served on the Fair Board in those early difficult years but it was fun, too. The wives were recruited to man the ticket booths for the carnival rides at the annual fair and there was always plenty to eat at somebody's house after

the evening board meetings.

While living in Awoca Maurie represented Pottawattamie county during the Sixtieth, Sixtieth Extra, Sixty-Second and Sixty-Third General Assemblies. He was very active in the Republican party heading lowa's organization for Barry Goldwater's presidential campaign in 1964. He served as alternate delegate to the 1964 GOP nominating convention in San Francisco and served as one of Iowa's 24 delegates to the 1968 convention in Miami. He also served on the steering committee of Bob Ray's successful campaign for governor in 1968.

Maurie joined the editorial staff of the Council Bluffs Nonpareil in June of 1964, became editorial page editor in 1965 keeping that position until resigning to accept an lowa Commerce Commission appointment by Governor Robert D. 
