Funeral Services Held for Former Rep. Leo I. Sanders

Funeral services for former State Representative Leo Sanders, 76, who died at 7:52 p.m. Friday at Holy Family Hospital, Estherville, were held Monday at 2 p.m. at the Presbyterian Church in Estherville with the Rev. Robert Karl Miller of the Christian Church of Estherville officiating. Burial was in the Oak Hill Cemetery.

Mr. Sanders was born March 16, 1894, at Osceola, the son of Mr. and Mrs. Luther T. Sanders. He received his education in the Des Moines schools and graduated from West High School in Des Moines.

He was married on Aug. 4, 1916, to Sarah Davis, in Newton. The couple lived in Des Moines until 1919, when they moved to Estherville.

Mr. Sanders was engaged in the wholesale ice cream business most of his life.

He was the Mayor of Estherville from 1956 to 1962, and represented the 5th District in the House of Representatives in Iowa for two terms, the last term ending in 1970.

He was the Past Exalted Ruler of the Elks Club in Estherville. and a past board member and vice-president of the League of Iowa Municipalities. He was a member of the Christian Church in Estherville, where he served on the church board.

Mr. Sanders is survived by his wife, Sarah; three sons, Robert Sanders, Cincinnati, Ohio; Jack Sanders, Iowa City; and William Sanders, Des Moines; one daughter, Mrs. Robert (Patty) Thompson, Sloux Falls, S.D.; grandchildren; six greatgrandchildren; one brother, Ralph Sanders, Estherville; and one sister, Mrs. Blanche Davis, Des Moines.

He was preceded in death by his parents, one sister and one brother.



Leo Sanders was born March 16, 1894, at Osceola, Iowa. The family moved to Des Moines in 1897. There Leo attended West Des Moines High. As a young man, he was an amateur boxer. Leo's ambition was to study law.

He started washing ice cream cans at his brother's factory to help pay his way through school. Leo became so interested in the ice cream business, he gave up school and spent most of his life in ice cream.

Sarah Davis was born November 28, 1893, at Evens, Iowa. Her family moved to Des Moines where she met and married Leo August 4, 1916, at Newton, Iowa. Their son Robert was born February 5, 1918, while still living in Des Moines.

They moved to Estherville in 1919, when Leo accepted a job with Mr. Graff. He later went to work for the Hutchinson Ice Cream Co. (now Borden's).

A son Lewis Jack was born January 17, 1923, and a daughter Patty Lee was born September 28, 1924. William Roger was born September 22, 1931. All their children graduated from Estherville High School.

Leo was the mayor of Estherville from 1956 - 1962. He represented the 5th District in the House of Representatives for two terms, the last ending in 1970. He did not seek reelection.

Leo and Sarah celebrated their Golden Wedding Anniversary August 4, 1966. They were members of the First Christian Church. Leo also belonged to the Elks and Masons.

Leo died March 5, 1971, at the age of 76. Sarah died February 20, 1973, at the age of 79. They are buried at Oak Hill.

Their children: Robert Charles married Mildred Shannon, Estherville. He made a career in the U.S. Army and is now working for the state of Ohio. They have 2 sons and 1 daughter. Lewis Jack married Joyce

Lawrence Sargent and Jennie Anderson were married January 13, 1913 in Estherville, Iowa.

Jennie Anderson, daughter of Ole and Hannah Anderson was born on her parents farm north of Estherville, January 3, 1893. Her six brothers and two sisters were also born on the farm. They were Albert, John, William, Isaac, George, Jacob, Josephine (Mrs. Frank Doyle) and Nettie (Mrs. Ed Koenecke).

Lawrence Sargent was born February 6, 1890 at Strawberry Point, Iowa to Mr. and Mrs. Ira H. Sargent (Anna). He had five brothers and three sisters so each Jennie and Lawrence came from a family of nine. They lived at Spencer, Iowa the first year of their married life where Lawrence was employed in a tile factory.

In 1914 they moved to the Ole Anderson farm where Jennie had been born and raised. They are the parents of three children: Lavon, born June 9, 1914, who moved to St. Paul, Minnesota and was an electrician. He was married to Vera Irmin, daughter of J. A. and Ella Irwin of Estherville and they had three sons, Roger, Jim and Larry.

Deloris was born December 28, 1915, married Glenn Bjorkman, and moved to Sioux City, Iowa and is employed at Driver's Union as head bookkeeper. They had a son Dale and a daughter Joyce Mrs. John Leckband, of Sioux City.

Averil, was born August 30, 1917 and married August C. Anderson of Estherville. They live in Ellsworth Township and are the parents of Jill and Jeff.

Lawrence and Jennie farmed until 1943 when they moved to Estherville. They attended the United Methodist Church and while farming Lawrence was a member of the Emmet Consolidated School Board for several years. He also was hired to grade some of the roads in Emmet Township with a horse drawn grader or drag. Jennie was active in rural women's organizations sponsored at that time by the Farm Bureau Extension Service. She also belonged to local community clubs.

Jennie inherited her parents fifty acres of land called the home place, and she and Lawrence purchased additional acres making it a total of 106 acres which is now owned by the third generation, their two daughters.

Lawrence died in 1946 at the age of 56 and Jennie died in 1957 at the age of 63.

Carl Sawyer

Carl Sawyer, oldest son of Alva and Ferme Sawyer, came to Emmet County, Estherville, Iowa June 1, 1924 after graduating from Urbana High School in Benton County. His folks had moved to Emmet County March 1, 1924.

Keven Sawyer is living at home and working. Shari Sawyer married Russell Richard and they are engaged in farming.

Verle, the second son graduated from Estherville High School in 1946 and was with the grards and in the Korean War. He was married to Priscilla Nelson on May 20, 1950 and they had three children. Jacquelyn married James Zweifel and they have two boys, Scott and Sean, and they live in Sutherland.

Scott Sawyer attends college in Penver, Colorado. Timothy was in the armed services in school in Alabama, and was killed in a motorcycle and car accident April 25, 1976 at the age of nineteen years. Priscilla was killed in a car accident September 25, 1963. Verle was killed in a car accident September 24, 1968. Carl Sawyer died August 29, 1959. Ruth continues to live on an acreage northwest of Estherville.

Spencer Alva Sawyer, with his wife Lela Ferne Ferguson Sawyer came to Emmet County in March of 1924. Alva came with the machinery and livestock on the Rock Island freight train, later Ferne came with their children, Lela Belle, Willard, J.D. and Don, leaving their eldest son Carl in Urbana, Benton County, Iowa to graduate from High School with his class of 1924.

The sign at the Rock Island depot WATCH ESTHERVILLE GROW seemed huge to them as they waited for their father to command get them in the horse and buggy. The road to the new home, west of golf links near Four Mile Lake was mud and it seemed a long way.

The family joined the Christian Church upon their arrival in the new community.

In 1928 Verdae was born. Their five children all graduated from the Estherville High School. Alva drove an Estherville School bus for twenty years and when
