
Harold Wolfe dies; former police chief

The committee unanimously approved the nomination of Powell last week but divided 12 to 4 in support of Rehnquist, a former Phoenix, Ariz., lawyer. The four Democrats on the committee who voted against Rehnquist's nomination are preparing a minority report to be filed later. They contend he has failed to demonstrate a

commitment to civil rights and civil liberties.

Senate leaders plan to bring the nominations up for debate Thursday and hope for a vote before the end of the week.

The committee majority report, drafted for submission to the Senate, said charges that Rehnquist is insensitive to the civil rights of minority citizens' are "utterly without factual or inferential support." It said that, although he opposed a public accommodations ordinance adopted by Phoenix in 1964, he had testified he no longer is against such measures and does not question the power of Congress to enact civil rights legislation.

Also, the report said, attempts to picture Rehnquist as opposed to school desegregation

on the basis of a letter he wrote - timony at committee hearings.

"The position of his 1967 letter," the report said, "is much narrower than his critics suggest. Specifically, his remarks in the letter and before this committee indicate he feels it would be undesirable to destroy the neighborhood school solely to achieve racial balance."

The committee said it had received letters from residents of Phoenix indicating that Rehnguist chose to live in the city "where his children attended schools with a significant enrollment of Mexican-American, Indian, and black children."

As for charges that Rehnquist engaged in attempts to harass black voters in Phoenix in the early 1960s, the committee said the evidence it received showed






