Retired businessman died Saturday

Former State Senator and an area businessman, John L. Buren, died Saturday at his home in Forest City following an illness of several months. He was 77 years old.

Funeral services will be held at 10:30 this Wednesday morning at St. James Catholic Church with Father John R. Kremer officiating. Burial will be in St. James cemetery.

"Chub," as he was known to all, was elected a state senator in November, 1964, and served a four-year term representing Winnebago and Hancock counties. He also was Democrat county chairman for six years.

"Chub" was thrust into the business world early in 1933 while a student at Columbia College in Dubuque when his father suffered a stroke and "Chub" had to come home to take over the family grocery business in Leland. After managing the business for four years, "Chub" bought the business and continued to operate it until 1946. In 1947 he purchased the Irving Ambrosion service station.

In 1950 he sold his business in Leland and purchased a half interest in the Helgeson Motor Co. at Lake Mills which at that time sold Kaiser and Fraiser automobiles along with International, Massey Harris and Oliver lines of farm machinery.

Three years later he sold his interest in the business to his partner, Truman Helgeson, and accepted employment at a salesman for the Eymann Implement Co. in Forest City. In 1956 Chub purchased the Ford dealership in Forest City, selling it in 1961 at which time he returned to Eymann's where he continued until his retirement in 1980.

In addition to his service as a state senator, "Chub" served in a variety of public capacities including six years on the Leland school board, six years on the Leland city council and five years on the Winnebago County Conservation board.

Because of his legislative experience, "Chub" helped to organize the "Iowans For Tax Relief" organization and was on the state board of directors for the group.

An avid outdoorsman, "Chub" was active in Ducks Unlimited and Pheasants Forever organizations.

As a young man he played semi-pro baseball with the "Lake Mills Cannery" and "Forest City Collegians" teams.

Mr. Buren was born June 10, 1913, at the home of his parents, W. P. and Mary Elizabeth (McGreevey) Buren in Leland. He attended the Leland school and was graduated from Leland high school in 1930.

He married Thora M. Berg of Scarville Oct. 5, 1933, at St. James church. They were parents of a daughter, Kathleen Ann, and a son, John Paul.

Survivors include his wife, Thora; a daughter, Kathleen Ann Bries of Denver, Colo.; a son, John Paul Buren of Mason City; five grandchildren, a brother, W. P. "Hap" Buren of Leland, and a sister, Margaret Buren of Leland.

He was preceded in death by his parents, a brother, Ben, and two sisters, Leona Carlson and Helen Langerud.
