Services for John L. Duffy, 70. of 220 Bryant St., former state representative will be at 10 a.m. Saturday at St. Columbkille's Church, with burial in Mt. Oliver Cemetery.

Duffy died at his home late Wednesday morning of an apparent heart attack. He was in his law office earlier, but became ill and returned home.

Born in 1899 in Dubuque, Duffy was the son of Thomas H. Duffy, who served as chairman of the Dubuque County - Central Committee of the Democratic Party for about 30 years.

Duffy's brother-in-law, was Louis Murphy, who was U.S. Senator from Iowa from 1933 to 1936, and for whom Murphy Park is now named.

Duffy served nine terms in the Iowa General Assembly. He first entered the Legislature in 1947 but dropped out four years later to take over the county attorney's post in Dubuque which he had held in the 1930s.

He returned to Des Moines in 1955 and successfully sought reelection every two years until he was defeated in the 1968 primary by Michael Blouin, the present incumbent.

During his stay in the House, Duffy actively engaged in the battle to eliminate some of Iowa's "blue laws," which limited various activities on Sundays.

He was a graduate of Columbia College (now Loras) and was a veteran of World War I.

He was a member of the American Bar Assn., the Dubuque County Bar Assn., St. Columbkille's Church and the Marquette Court of the Catholic Order of Foresters.
