

They moved to Excelsior Mining Camp in Mahaska County, Iowa for three years leaving in 1884 to homestead near Bath, South Dakota. Their oldest son John J. Morgan remained at Excelsior Mining Camp, Iowa because he was engaged to be married on January 24, 1885 to Elizabeth Roberts. She was the daughter of William and Catherine Thomas Roberts of Wales who had migrated to America and settled in Mineral Ridge, Ohio. William Roberts and his little family moved to Bevier, Missouri. Catherine Thomas Roberts died in Canton, Illinois while the family was moving. Elizabeth Roberts had gone to Excelsior Mining Camp, Iowa to visit relatives when she met John J. Morgan in 1884.

Mr. Morgan continued to work in the mine and as time went on nine children joined the family. Mr. Morgan did not want his sons to work in the mines so he purchased a farm in Garfield Township on which they were raised. He took care of the business and work and Mrs. Morgan was truly a homemaker and took care of the children all of whom they could be justly proud. Mr. Morgan served on the Elm Grove School board and the Beacon (Iowa) school board after his retirement from the farm. He was also a Township Trustee for Garfield Township and served on the election board. They attended Elm Grove Sunday School services while on the farm and later the Beacon Baptist Church. The children grew in a family of love and discipline, willing to do their share of work. Each member could recall the memories of the happy days in the home as well as the heartaches and sorrow. As time went by each of the children left to work and marry to make his own home but on special occasions the families would gather at the parental Morgan home for the day. Their children were: Elizabeth (Mrs. David R. Williams), Jenkin Morgan, William R. Morgan, Margaret (Mrs. William R. Wilson). Jennie (Mrs. Homer W. Moffet), Edna (Mrs. D.W. Dayton), Llewellyn Morgan, Miss Leona Morgan and Ruth (Mrs. Paul W. Collins). When Mr. and Mrs. Morgan wanted to retire they sold their farm and moved to Beacon, Iowa where they lived until their deaths. Mr. Morgan died on September 22, 1934 and Mrs. Morgan died on May 9, 1950. They are both buried at the Forest Cemetery at Oskaloosa, Iowa. Most of the members of the John J. Morgan family remained in the Mahaska County, Iowa area among their families and friends. Now the younger members of the family are taking jobs in larger cities, following a career in the service, attending college with a career in a chosen field thus finding homes in various parts of the country. Wherever they locate you will find a family who will carry-on the traditions of his ancestors, a neighbor in time of need and a citizen true to his country.

MORGAN, ELDON MONK & ZANA IRENE WITT

Eldon Monk Morgan, born July, 1890, was like his father Saul Hartley Morgan, born in February, 1853, a resident of White Oak Township. My father's grandfather, Lewis Bailey Morgan was born in Virginia in 1812 but moved with his father and mother, David Morgan and Francina Hartley Morgan, to Danvilee, Illinois where David was a Cooper (a barrel maker). John Morgan, the Raider, was a cousin of Lewis Bailey Morgan but to lighten the burden of that, Lewis' wife's mother, Lydia Beard was said to be related to William Jennings Bryan's family.

Lewis Bailey Morgan has always been considered one of the more interesting members of the family, whose origins are said to be in Wales. Lewis was co-owner of the Galena Lead Mines in Illinois with two partners, Antoine Lore and Selestine Keltenback. Interestingly enough, he named two of his sons after his former partners, gave a third the name of Christopher Columbus, and only Saul Hartley had a non-attention-getting christening. Lewis sold his interests in the Galena mines, moved to Fairfield, Iowa and opened the first grocery store there. He sold that, bought out a family named Troy of White Oak Township and became the second settler and largest land owner in that part of Mahaska County. A Southern sympathizer, during the Civil War, Lewis buried gold coins in leather bags in an area around the family main house, then went to the barn and hung himself. According to legend he was not a man who feared to be different, so the suicide was inexplicable. I understand that people still come to the old Morgan land with electronic gear hoping to unearth the Morgan gold which, as far as the family knows, never surfaced. Lewis left his wife and sons well off, despite what he buried and after his wife. Sarah Ann Smith Morgan, a relative of Andrew Jackson, died in January, 1894, the family wealth declined. All the sons squandered their inheritances.

Eldon was the fourth child, third son of Saul Hartley Morgan and Mary Jane Monk Morgan. The Monk family were said to have left Scotland as religious refugees and lived in Holland.

After the Revolutionary War, the Monks immigrated to Canada, later Wisconsin, and finally Iowa, where Mary Jane Monk was born in May, 1856. She married Saul Hartley Morgan on January 1, 1882, and they lived and raised their family on the outskirts of Rose Hill where, I think it is safe to say, they became movers and doers in the area, goodness, generosity, and inate kindness which culminated in their son, my father, Eldon Monk Morgan.

Zana Irene Witt Morgan was born in August, 1895 to William J. Witt, born August 1846 in Knox County, Illinois and Annie Pierce Thomas Witt, born August, 1852 in Pennsylvania.

The Witt family history, earliest recorded, began with William Witt, born in France in 1675. The name is thought to have been De Wit and changed when William's family, Huguenots, fled from France in the 17th Century. William settled in Virginia and adopted his nephew, Richard Oney Witt, as his son. Richard was the progenitor of this branch of the Witt family.

His son, Hezekiah, had nine children; the eigth was Jessee Witt. Born in Virginia in May, 1760, Jessee was a private in the Revoluntionary War, first serving under command of Colonel William Davies of the 10th Virginia Regiment, in January, 1777, and later transferred to the 14th Virginia Regiment, May, 1779, under command of Captain John Overton. Jessee Witt was discharged in September, 1779. He married a much younger woman, Ruth Whit, born in 1770. Jessee's father, Hezekiah, was said to have large land holdings near Raleigh, North Carolina. Jessee and Ruth left Virginia, lived in Rutherford County, North Carolna, then to Overton County, Tennessee and eventually to Henderson, Knox County, Illinois.

Richard Witt, a son of Jessee and Ruth, and his wife Mary, had ten children, one of whom was William Jasper Witt, Zana Irene Witt's father. He married Annie Pierce Thomas in September, 1873. Prior to that he

had served in Co. A, 65th Illinois Infantry during the Civil War. He and Annie Pierce Thomas had five children of whom only two, Clara and Zana, survived. William Witt came to Iowa in March, 1868, settled in Mahaska County on a farm in Monroe Township until he moved with his family to Rose Hill in December, 1914.

Annie Pierce Thomas Witt, mother of Clara and Zana, died in May 1935 at her home in Rose Hill. Legend had it that she was descended from the family of General Benjamin Pierce whose second son, Franklin, became the 14th President of the United States. Annie Pierce Thomas was the daughter of Owen and Sarah Thomas of Norristown, Pennsylvania. A child of two, she came with her two brothers to Monroe Township,

in Mahaska County.

Her daughter, Zana Irene, married Eldon Monk Morgan on May 18, 1918. They insisted that they did not elope; however neither set of parents were informed until after the ceremony. Nine days later Eldon followed his two older brothers into the army, saw duty in World War I in France, and was discharged in February, 1919. He and Zana, who taught school for many years, settled in Rose Hill, which was to be their home for the next 30 years. Eldon was a rural mail carrier with the second longest mail route in the United States, at the time of his retirement. At age 70 he ran for the Iowa Legislature, and won, as a Democrat-the first from Mahaska County since Iowa had become a state. Zana excelled at teaching, good works, church and family activities.

Zana died November 2, 1968 in Oskaloosa where she and Eldon had moved in the late 1940's. Eldon died March 7, 1981 in Connecticut where he had lived with the couple's only daughter, Kathryn Ann Morgan Ryan, for

the last five years of his life.

MORGAN, JOHN D.

John D. Morgan the son of David E. Morgan and Christine Bruhn was born April 8, 1913; his birthplace was the same as where his father was born in Garfield Township Section 35.

John graduated from Beacon High School. He also attended Fremont School. while at Fremont, David and John delivered milk

from their Rosebud Dairy.

The Morgan family, which consists of David E., Christine E., Hannah A., and John D. Morgan, purchased a Rose Hill Farm in 1939 in White Oak Township 4. They oper-

ated the Rosebud Dairy.

On October 12, 1943 John D. married Relda White at the Oskaloosa Christian Church. She was the daughter of Orah and Maude Crane White. Relda was born July 17, 1912 in Garfield Township Section 35 at the same place where her mother Orah was born. She had four sisters: Ruth Stull (deceased), Dorothy Schultz and Arllene Vander Martin. Relda graduated from What Cheer in 1931. She taught 10 years in Keokuk and Mahaska Counties in country schools before her marriage to John D. Morgan. They resided at Rose Hill. While at Rose Hill three children

were born:

Janice D. was born on April 10, 1946 at Mahaska County Hospital. Janice attended Rose Hill School where John was a director. She and the other two children attended Elm Grove School. John was director and president of the school board.

Janice worked at Downing Coffee Shop until her marriage to David G. Taylor of Chicago, Illinois, on August 31, 1968. On January 9, 1971 a son was born named John Eric Taylor. The family lives in Joliet, Illinois, and operate their own pest control business called J.D. And Son. They enjoy square dancing. John goes to Illinois School for the Deaf. He is very active in sports. John spends time back at Grandpa John's farm during the summer. Janice graduated in 1964.

Charles S. was born December 28, 1950, at Mahaska County Hospital. Charles attended country school all eight grades. He graduated from Oskaloosa High School in 1969. Charles entered the Army in May of 1970 and was discharged in November of 1971. He spent 13 months overseas in Germany as a clerk typist. Since 1975 when the Rosebud Dairy was discontinued, he has worked for Supersweet Feeds in Oskaloosa. In 1978 he served as Worthy Patron of Vega Chapter O.E.S. #532 of Oskaloosa. In 1980 he served as Worshipful Master of his Council Lodge #644 AM/FM and at the time is secretary of the lodge. He also farms 200 acres at Rose Hill and is in partnership with his dad who has 150 acres. He lives at the homeplace.

Delores J. was born September 22, 1953 at Mahaska County Hospital. Delores attended all 7 grades before the closing of the country schools in 1966. She graduated from Oskaloosa High School in 1971. Delores has been active in the Order of Rainbow for Girls, first as a member when she served as Worthy Advisor in May of 1973. She also served on the advisory board and as a Mother Advisor of the Order of Rainbow Girls. Delores is a member of Vega Chapter O.E.S. #532. She has worked in the public since 1974. First at Dee's Floral & Crafts for over 3 years, then at Drug Fair. She presently works at Pamida Inc. She is the department head of housewares and appliances. She has been there since March of 1978.

Delores helps with the Miss Mahaska Pagent Board. In April of 1982 she purchased her home in Oskaloosa.

In the spring of 1954 the Morgan family moved to the present location RR# 5. The farm home is the same place Orah and Relda White were born. John did custom trucking and farmed. Then they started their own Rosebud Dairy.

On December 1, 1973 Relda died at Mahaska County Hospital as a result of a massive stroke. She had heart trouble the two years before. She is buried at Forest Cemetery in Oskaloosa.

At present John keeps himself active in farming. He enjoys raising turnips and sweet corn to give to other people.


