John Brockmeyer, 93, Dies At Pleasantville, Service Here

John H. Brockmeyer, formerly of Lime Springs and Cresco, died Friday at a Pleasantville, Iowa, nursing home. He had been fairly well until the very last. In two months, he would have had his 94th birth-

Funeral services were conducted Monday, July 16, at 11:00 a.m. at the United Methodist Church, Lime Springs. Officiating was the pastor Rev. Dwight Grosvenor, with Mrs. Abner Buresh the organist. Pallberaers were Arnold DeJoode, Jeffrey Nelson, Charles Becker, John Hinners, Neal Hinners and Harold Kuntz.

Interment was beside his wife, Clara, at Howard Center Cemetery, rural Cresco, where military honors were accorded by the Lloyd L. Horton Post No. 545 of the American Legion, with Commander Eugene Munkel in charge and Chaplin Walter Harwood presenting the flag to Mrs. Wilma Hinners, daughter of Mr. Brockmeyer. He was born in Clayton County near Colesburg, Iowa, September 14, 1890, to John Henry and Anna Woeste Brockmeyer. He received his elementary education in rural school in Delaware County and high school training at Charles City College. He attended Coe College, Mount Vernon, Iowa, for one year.

He served in the U.S. Army from February, 1918 to June, 1919, and was still in Europe when the Armistice was declared.

In 1920 John started farming near Colesburg and moved to a farm north of Davis Corners in Howard County in 1932 where he lived until moving to Cresco in 1968. A member of the Zion Methodist Church, Colesburg, he served as secretary of the Sunday School and also as superintendent before transferring his membership to the Lime Springs Methodist Episcopal Church where he served on the board of trustees.

A member of the American Legion, he was the commander of both the William F. Brockmeyer Post of Colesburg, named for his brother, and the Lloyd L. Horton Post of Lime Springs.

As a member of the Farm Bureau for 61 years he served as president and voting delegate. He helped organize and was president of the Howard County Experimental Farm for 20 years and helped organize and was president of the Howard County Soil Conservation Service.

John also served on the township and county Agriculture Conservation, and Stabilization Committees.

He was a trustee of Colony Township, Delaware County, and was elected clerk of Howard Center Township in Howard County for many years.

Grace was the daughter of Michael J. and Mary Jane Sexton Drew of Decorah, Iowa. She was a teacher in the area. Two children were born, Pearl Marie and Paul Anthony. Later, on moving to Cresco, Ray was employed as a harness maker and a clerk in the Kalishek Hardware store for many years, then for Howard County as a dynamiter and later on building bridges. He worked at Goodrich and Searcy and then served the City of Cresco as Street Commissioner for several years. He returned to farming in 1948. The family lived southwest of Cresco, south of Cresco, later at Ridgeway, Iowa and then moved to Canton, Minnesota where the parents, Ray and Grace, passed away in later years. John and Clara Brockmeyer and their three daughters, Wilma, Lois and Zeida, moved to a 130 acre farm in Howard Center township, Howard County, Iowa, March 1, 1932, from Colesburg, Delaware County, Iowa.

John was in the group that succeeded in getting REA to Howard County and his was one of the first farms on the western edge of Howard Center to be electrified.

He served on the County Farm Bureau board for many years and was among the first county stock holders in the Farm Bureau Insurance Company.

He was instrumental in getting the Howard County Experimental Farm organized and

He was involved in the organization of the Farm Service Co-op (now C&H Farm Ser-

He served two terms as Howard County representative in the Iowa State Legislature in Des Moines.

His first year in Howard County, when he planted corn on his farm, well meaning neighbors laughed saying he couldn't grow corn, but he had a good crop and continued to raise corn crops with proper fertilizers as recommended by the Iowa State Extension Service office.

He was a veteran of WWI serving in Europe and was a long time member of the Lloyd L. Horton Legion Post in Lime Springs, Iowa.

He served in the Lime Springs Methodist Church in various ways.

John and Clara moved to Cresco after selling their farm to Roger Foote who recently sold it to the Exchange State Bank of Lime Springs. They lived in Cresco until 1980 when they entertained the Pleasantville Care Center, Pleasantville, Iowa.

Clara died in October, 1982 and John in July, 1984. Both rest in the Howard Center township Cemetery.

For some years John and Clara were partners with their daughter, Lois and William DeJoode, on the farm raising hybrid hogs. Some years later, daughter, Wilma and Harmon Hinners, operated a grade A (bulk milk) dairy in partnership with her parents.

The daughters are now located — Wilma in Brush, CO; Lois in Pleasantville, Iowa and Zeida Clark in Mesa, AZ.

BRONNER, JOHN FAMILY

John Bronner, with his brothers, emigrated from Germany in the 1850's. He homesteaded a farm in Albion Township. On June 15, 1861 he was married to Mary Dempewolf, who also emigrated from Hanover, Germany. She was born July 30, 1843, and lived until April, 1910. This young couple resided and farmed the same place all their married life. This farm is still in the Bronner family, now occupied by their fourth and fifth generation, Mr. and Mrs. Brent Bronner and two daughters, Sarah and Robyn.

Mr. and Mrs. John Bronner were regular attendants and members of the original Zion Evangelical Church; which is now Zion United Methodist. It is located across the road from their farm. Their first home was a log cabin built near a spring south of the present dwelling. As their family grew, a larger home was required. Then a two-story was built nearer the road. This had to be

replaced, too.
