Was Longtime County Supervisor, Legislator

Funeral services for W. E. Penn Eckels, longtime Britt farmer, will be held Thursday at the Britt Methodist Church at 2 p.m.
 The Rev. Warren S. Paige, church pastor will officiate and interment will be in the family lot in Glenwood Cemetery at Goldfield. The Grupe Funeral Home is in charge of arrangements.
 William Edgar Penn Eckels was born the son of Samuel and Ella Korman-Eckels on October 28, 1882 at New Kingston, Penn. He was educated in the New Kingston schools and completed his education at Kost Normal at Mechanicsburg, Penn.

He moved to Golydfield, in 1902. He was united in marriage to Myrtle McCutcheon on Feb. 28, 1906, at Goldfield.

Mr. Eckels owned and operated a meat market for several years and also farmed in the Goldfield area. The family moved to Hancock County in 1917 and settled on a farm northwest of Britt.

Mr. Eckels was active in community and church affairs. He was Hancock County Supervisor from 1934 to 1946 and a State Representative from Hancock County from 1946 until 1954. He also served as a trustee of the Methodist church and as a director of the Hancock County Mutual Insurance Assn. He was at the present time serving as treasurer of the Masonic Darius Lodge No. 431 of Britt and until recently had been a member of the Hancock County Board of Review. Mr. Eckels was a member of The Methodist Church, Odd Fellows Lodge and a 50 year member of the Masonic Lodge.

After being in failing health for the past few months, Mr. Eckels died at the Hancock County Memorial hospital on Monday morning.

Survivors include two daughters, Mrs. M. F. (Louise) Greiman of Garner; Mrs. Alfred (Inez) Bottaro of West Covina, Calif.; one son, Forrest of Britt; five grandchildren and four great-grandchildren. Also surviving are two sisters, Mrs. Mabel Line, West Chester, Pa. and Mrs. Anna Melester of Lancaster, Pa.

He was preceded in death by his parents; his wife, who died on Jan. 29, 1961; one infant daughter; one infant son, one brother, Cleveland Eckels and one sister, Mrs. Tirza Newsbaum.

W-CL School Vote On Monday, May 24, Has Good Support

Apparently the proposed construction of a music building addition to the Crystal Lake junior-senior high building has majority support of the residents of the district since only nine persons showed up at the information meetings held Monday and Tuesday nights.

Supt. Homer Baxter reported that four were at the meeting in Woden and five at Crystal Lake and informal discussions were held.

The Woden-Crystal Lake district will vote Monday, May 24, at the school house in Woden from noon until 7 p.m., on approving the expenditure of \$25,000 for the addition. The money will come from current funds.

40 Protests for Board of Review

The county board of assessment and review has received 40 protests in regard to property valuations and will give consideration to them after May 20, the deadline for protests.

Thirty-three of the complaints are on farm property. The board had expected more, Assessor Fred Missal commented. The board will visit each of the properties in question with a representative from the Clemminshaw Appraisal firm which did the revaluation this past year.

The boards work was reduced when the appraisal firm held its open house early this year and made some of the revisions in valuations from their original figures.
 According to Missal there has been no wholesale changes by the board of review, since the board does not act on protests until after the May 20.

W. E. (Penn) Eckles was born near New Kingston, Pennsylvania, October 28, 1882, and passed away at Britt, Iowa, on May 17, 1965, at the age of 82 years.

Mr. Eckles was educated in the schools of New Kingston and Kost Normal, Mechanicsburg, Pennsylvania. He came to Iowa in 1902 and settled near Goldfield; farmed for several years, owned and operated a meat market in Goldfield for four years.

He married Marian W. McCutcheon, Eagle Grove, Iowa, in 1906, and to them three children were born: one son, Forrest; two daughters, Mrs. M. F. Greiman of Garner, and Mrs. Alfred Bottora, El Monte, California.

Mr. Eckles came to Hancock County in 1917 and settled on a 320 acre farm, which he owned and operated in partnership with his son. He was County Supervisor for 12 years, and chairman of the board for nine years.

He was a member of the Methodist Church, Masonic and I.O.O.F. lodges. Mr. Eckles, a Republican, served in the Fifty-second, Fifty-second Extra, Fifty-third, Fifty-fourth, and Fifty-fifth sessions of the General Assembly as a state representative from Hancock County.

Survivors include his son, two daughters and two sisters.

Willis Charles Edson was born September 25, 1874, in Wilton, Illinois, son of Charles and Elizabeth Edson.

Willis Edson was educated in rural schools. He attended Buena Vista College, Iowa State College and the University of Iowa. He received his Doctor of Laws degree in 1901.

On November 11, 1911, he married Ethelyn Bailie of Storm Lake.

Mr. Edson began practicing law in Storm Lake in 1902 after teaching school in Calhoun and Sac counties. He was Buena Vista county attorney from 1908 to 1912. He was also city attorney and mayor of Storm Lake for several years. Mr. Edson served as State Representative in the Thirty-eighth, Thirty-ninth, Fortieth, and Fortieth Extra sessions of the General Assembly. He was Speaker of the House in 1925. Willis Edson was Republican candidate for Lieutenant Governor in 1936.

Surviving are his widow, Ethelyn; two sons, Robert C. of Storm Lake, and James of Omaha; and three daughters, Mrs. Margaret Ayers, Mrs. Max Dillon and Mrs. James Hamilton all of Storm Lake.

He attended Clear Lake schools and graduated in 1970 from Forest City High School. After graduation Mike worked at Paul's Mobile Home Sales in Mason City. While there, he met Karen Marie Moore from Des Moines and united in marriage 2/26/72 at Union Park Christian Church in Des Moines.

Karen was born 1/16/52 in Des Moines, Iowa, to Francis William Moore and Luella Marie Smith Moore. She has two sisters - Belinda Willett and Mary Goodrich. Forrest Eckels, the son of Marian (McCutcheon) and William Penn Edgar Eckels, was born January 7, 1913 at Goldfield, Iowa. He had four brothers and sisters: Louise, Inez, Mervin and Luella Belle; however the two babies named died in infancy. Forrest attended country school in Orthel Township #5, graduated from Britt High School in 1930 and Britt Junior College in 1932.

Forrest was united in marriage to Bernice DeBoer of Wesley, Iowa on August 19, 1937 at the Woden Christian Reformed Church. Bernice is the daughter of Claus and Bendina (Peters) DeBoer. She has six brothers and sisters: Anne, Esther, Herman, Clarence, Maurice and Theodore, who died at age six weeks. Bernice received her education in Kossuth County in Wesley Township #1 and was graduated from Wesley High School in 1934.

So many changes have taken place in our lifetime. We were raised in homes without electricity, running water or central heating. We had very little money. Our first baby, Wayne, was born at home for a cost of \$25.00. We knew the throes of a depression, but we had plenty to eat. We had a large garden and canned many jars of fruit, vegetables and meat. We had a warm home, heated by wood, cobs and coal.

Forrest, at one time, walked behind a one-row cultivator pulled by horses; a far cry from the air-conditioned tractors and twelve-row cultivators that are available today. When we were first married, we had a beef herd, a dairy herd, a flock of chickens, and hogs. At the present time, our son, Wayne, has specialized in hogs.

The Eckels are active in their church and community. They are members of the Woden Christian Reformed Church. Forrest has held many offices in the church, including, superintendent of Sunday School, on the consistory board and the recent church building committee. They are active in the Gideon Society. Both have been involved in the Hancock County Farm Bureau and Farm Bureau Women's Committees. Both are life members of the County Historical Society and Forrest is presently serving as the president. Through an early ancestor who fought in the Revolutionary War, Forrest became eligible for membership in the Sons of the American Revolution

ECKELS, PENN

The Eckels family, who were Pennsylvania Dutch, have been in the United States for a long time. An ancestor fought in the Revolutionary War.

William Edgar Penn Eckels, son of Samuel and Ella (Corman) Eckels, was born October 28, 1882 in Kingston, Pennsylvania. Penn was one of five children, namely: Mabel, Penn, Tirza, Cleveland and Anna. Penn took a Normal Training course in Pennsylvania, but never taught school. He came to Goldfield, Iowa in 1902 and worked as a hired man on a farm. He was married to Marian McCutcheon of Goldfield on February 28, 1906.

Marian, the daughter of William and Martha (Stevenson) McCutcheon, was born June 10, 1883 at Goldfield, Iowa. She had nine brothers and sisters: John, Jennie, Mary, Hugh, William, Nellie, Bessie, Luella and Martha.

The Eckels moved from Goldfield to the Britt area in 1917. Penn purchased a farm in Orthel Township. In 1920 the farm was sold, but he got the farm back a couple years later. Penn, Marian and the family moved back onto this farm in 1924, where they continued to live until Marian and Penn passed away.

Penn and Marian were blessed with five children: Louise, Forrest, Inez, and two babies who died in infancy, Mervin and Luella Belle.

Penn Eckels held the elective offices of Hancock County Supervisor for twelve years and State Representative for eight years.

Marian was of predominantly Scottish ances-

try. Her father lived up to his Scottish blood. He had two pipes. The smaller one he used at home and the larger one he took along when he went up town and "mooched" tobacco from his friends. Marian's mother, Martha, only weighed two pounds when she was born. At one time she was lost in the blankets on the bed. The older children sat on the bed, but Martha survived and grew to be a large lady, bringing ten children into the world.

Marian had a 2-yr. Normal Training course in Goldfield, which enabled her to teach school, having to walk in bitter cold weather to a cold-one-room school house and teaching all eight grades.

The Eckels were members of the Britt Methodist Church. Penn was the School Director in Orthel Township for many years. He belonged to the Odd Fellows, Masons and the Hancock County Farm Bureau. Marian belonged to the Eastern Star.

Marian Eckels passed away February 28, 1961. Penn died four years later on May 17, 1965. They are buried in the Goldfield Cemetery.
