...those who don't. In the 30 to 39 year age group the rate is 2.8 times that in non-pill users.

Keep in mind that the incidence of heart attacks in women below 40 is relatively rare and below 30 almost nonexistent. Even 10 times a year incidence isn't very important.

The use of the pill in most younger women is safe. The Food and Drug Administration has suggested that women over 40 should use some other method of birth control. That recommendation may be premature and reviews by other groups that are sure to come, plus new studies may change this view.

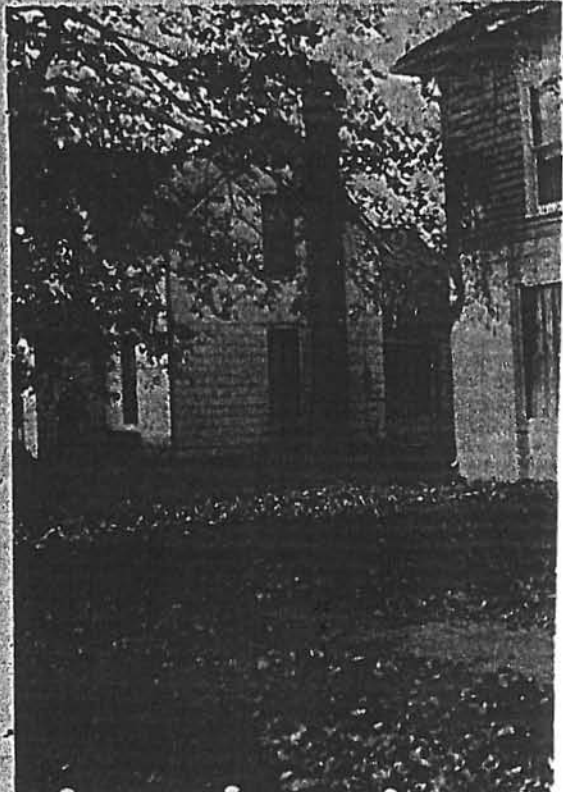

Dairy barn will be rebuilt

KEOSAUQUA — The dairy barn at the Van Buren County Care Facility near Keosauqua that burned Monday will be rebuilt, according to county supervisors.

Supervisors Arnold Barker of Keosauqua, Tom Nutt of Douds and William Marsh of Farmington spent much of Tuesday at the county home consulting with administrator Kenneth Kerr and others concerning rebuilding plans.

The county home operates a profitable grade A dairy farm with a herd of 30 cows. None of

the cows was in the barn at the time of Monday's fire, although a bull and 10 calves were evacuated.

Cause of the fire which apparently started in a hayloft is still under investigation.

A \$561,000 building program is already under way at the county home. Supervisors credit the fire departments of Stockport, Keosauqua, Doud, Birmingham and Farmington with saving other nearby buildings and equipment from burning.

He was also a member of the Independent Order of Odd Fellows, the Knights of Pythias, and the Benevolent and Protective Order of Elks. He was a charter member of the New London Country Club. In his politics, Dr. Lessenger was a Democrat. Of Baptist faith, he was active in the councils of his church for many years. In 1908-09, he was president of the Baptist Young People's Union of Southeast Iowa. The doctor's hobby was collecting pipes, and he had a collection of three hundred, coming from all over the world. For outdoor recreation, he liked hunting and fishing.

On September 18, 1912, Dr. Earnest J. Lessenger married Florence M. Tibbetts, daughter of George and Nancy-Jane (Craven) Tibbetts. Mrs. Lessenger's father was born in Horfiell, New York, and her mother in Pennsylvania. Mr. Tibbetts was a locomotive engineer all his life, with the Erie Railroad, and the Chicago, Burlington and Quincy Railroad. For many years he was engineer on a fast mail route through Iowa and made his home at Ottumwa, and later at Burlington. Both he and his wife are now deceased.

Dr. and Mrs. Lessenger were the parents of two children: 1. Mary Jane, now the wife of Owen Williams of New London, Iowa. He is city mail carrier, while she teaches English in the high school there, being a graduate of the University of Iowa, with a Bachelor of Arts degree. Mr. and Mrs. Williams have two children: Gary, born in 1939, and Samantha Jane, born in 1945. Mary Jane (Lessenger) Williams is a member of the P.E.O. Sisterhood. 2. Earnest Jay, Jr., who also holds a degree of Bachelor of Arts from the University of Iowa. During World War II, he enlisted in the United States Navy Air Corps, and served in the south Pacific, commissioned a first lieutenant. Discharged in 1946, Earnest J. Lessenger, Jr., returned home and entered radio work for a time, then returned to the University of Iowa where for a time he studied law. He returned to radio work, however, was manager of station KOKX in Keokuk, then moved to Memphis, where he became sales manager for the largest station in Memphis. He married Virginia Rast of Memphis, Tennessee, and they are the parents of two children: John, born in 1946, and a daughter, Eve Jane, born in 1950. Earnest Jay has now returned to the Navy as lieutenant commander.

Mrs. Florence Tibbetts Lessenger is active in local affairs, being worthy matron of the Order of the Eastern Star, and a member of the White Shrine. Dr. and Mrs. Lessenger made their home at 213 East Main Street in New London.

On March 8, 1950, Dr. E. J. Lessenger died at Mayo Clinic, Rochester, Minnesota where he had gone for surgery. Death was due to a heart attack. He was buried in the family lot at Aspen Grove Cemetery, Burlington, Iowa.

HENRY THOMAS, secretary and treasurer of Eggart and Thomas, Inc. of Mason City, distributors of Goodyear tires, automobile and home accessories and appliances, and proprietors of an automotive and recapping service, was born in Colfax, Iowa, August 23, 1904. He is the son of Henry A. and Mary E. (Wharton) Thomas. His father, the late Henry A. Thomas, who was the owner of a hotel in Colfax, died December 15, 1918.

Henry Thomas attended elementary school in Col-

fax and for one year was a student at the Colfax High School. He then transferred to East High School in Des Moines, from which he was graduated in 1922. During 1927-28 he studied at the Bentley School of Accounting and Finance in Boston, after which ill health necessitated his spending a winter in Arizona. In 1929 Mr. Thomas came to Mason City and became associated with Joe Daniels, Goodyear tire distributor. He remained with this concern until 1935. From 1935 to 1941 he served as purchasing agent for the S. and R. Chevrolet Company in Mason City, and from 1942 to 1945 as senior accountant for Frank J. Enbusk, Inc., Certified Public Accountants. In 1946 Mr. Thomas bought a part interest in Joe Daniels' Goodyear and automotive agency. In October, 1948, he and a partner, Mr. Eggart, bought out Mr. Daniels and became sole owners of this automotive agency, which is now known as Eggart and Thomas, Inc. Mr. Thomas serves as secretary and treasurer of the new enterprise, which employs ten people. It handles Goodyear tires, automobile and home accessories and appliances and has a recapping service. Mr. Thomas was a director of the Exchange Club, and is a member of the Executive Club, Euchre and Cycle Club, the Mason City and Clear Lake Chamber of Commerce, and the Mason City Country Club, and fraternally is affiliated with the Benevolent and Protective Order of Elks. His great hobby is photography, and he and his wife are ardent collectors of antiques.

On September 1, 1945, Henry Thomas married Greta Chappell, the daughter of Dr. E. E. and Itonia (Barnes) Chappell. Mrs. Thomas is a graduate of Wheaton College. Mr. and Mrs. Thomas have one son, Henry Edward, born August 13, 1947.

W. DEAN AUBREY—In the coal mining industry of Iowa, notably in the Ottumwa area, W. Dean Aubrey has become a conspicuous operator. His career has been colorful, ranging from service with the United States Marines, through labor union activities to his present identification with coal mining. He is a native of Muntersville, Iowa, born on September 28, 1904, son of William and Rasa (Chisman) Aubrey, his father now being retired from most business activities.

W. Dean Aubrey was educated in the public grammar and high schools, from which he was graduated in 1924. In preparation for his career, he went to Penn College, where he majored in commercial administration. However, when he became of age he enlisted in the United States Marine Corps, and participated in tours of duty from 1925 to 1932. In what was still the period of national depression, he, in the latter year, left the service to join up with the activities of the Congress of Industrial Organizations, with which he remained associated in Ottumwa for five years. Later his work was in connection with the coal mining industry and in it he became thoroughly interested. From 1937 to 1946, he was connected with various coal mines in Iowa. In 1946, in partnership with two brothers, the Lick Creek Coal Mine and the Muntersville Coal Company were purchased, which have since been operated on an active scale.

In Ottumwa, Mr. Aubrey has an established reputation as a public-spirited citizen, co-operative with projects intended to promote the best interests of the city. In 1944 he was named a member of the Ottumwa Park Board, and he serves on the Rent Control Advisory Board. A staunch Democrat, he was elected to the Iowa General Assembly as a member of the House of Representatives, Fifty-third Session. Mr.

Aubrey is a director of the Ottumwa Community Chest, is affiliated with the Fraternal Order of Eagles, and is a member of the Democratic party. He worships in the faith of the Methodist Episcopal Church.

KATHERYN CLANCY METZ—If not born to the "Fourth Estate," it has been in this field of endeavor that Mrs. Katheryn Clancy Metz has been identified prominently over the most of her life. After a brief career as an educator, she became first editor and then publisher of the "Lamoni Chronicle," an influential newspaper of southern Iowa which will soon celebrate the second decade of her service at the helm, guiding its course throughout a rather stormy period in American annals. She has not found her duties incompatible with marriage and the rearing of a family, nor with giving leadership to organizations and movements. As a writer she has also contributed articles to national magazines, the most quoted being "Petticoats and Politics" in the "Country Gentleman."

As Katheryn Clancy, Mrs. Metz was born in Lucas, Iowa, June 20, 1904, the daughter of John T. and Iona (Bagley) Clancy. Their daughter was prepared for higher education in the high school of Attica, and matriculated at Graceland College, where she was graduated with the degree of Associate of Arts, class of 1925. In 1926 and 1927, she was a teacher in the public schools of Marysville.

In 1930, Mrs. Metz became the editor of the "Lamoni Chronicle," and on March 6, 1950, its publisher, when she purchased the paper from W. H. Blair. To this exacting profession, Mrs. Metz has given exceptional and efficient devotion. With her purchase of the "Lamoni Chronicle," she has become probably the only woman publisher of an Iowa weekly. She not only is a chronicler of the news, but an interpreter thereof, wielding an influence that contributes to the best interests of the community, and Decatur County, and as well to the intelligent understanding of what is going on in the world. Mrs. Metz is also the author of a widely-read column, "Between You and Me." One of her better known achievements is her service, for six months in 1949, as "exchange editor" in Mexico. She was sent on this assignment by the Iowa Press Association, and the Cadena de Periodicos Garcia Valesca, a Mexican syndicate publishing nineteen daily newspapers and five magazines, sent a man representative to Iowa to work on several newspapers while Mrs. Metz was engaged in Mexico. This exchange was made in an attempt to solidify the Western Hemisphere by explaining to the readers the customs of the people by representatives of their respective countries. It is significant that a group of weekly editors from the Middlewest, so often called isolationist, was the first to make a concrete effort to do something about better relations. Mrs. Metz realizes full well the advantages of keeping in touch with colleagues in her profession, especially those of her own sex, and is a popular figure in the Iowa Press Women's Club, a director of the Fifth District, and member of the National Federation of Press Women. Her influence in politics as a Republican and public-spirited citizen, is indicated by her current membership in the Iowa

General Assembly, House of Representatives. She has introduced and backed progressive legislation and has won high rating by her associates. A prominent club-woman, Mrs. Metz is affiliated with the local groups, the Federation of Women's Clubs of Iowa, and the Business and Professional Women's Club. She belongs to Lodge No. 282, Order of the Eastern Star, and to the Reorganized Church of the Latter-day Saints.

On December 15, 1926, Katheryn Clancy married John L. Metz, and they are the parents of two children: 1. Gayle, who married Walter Johnson. 2. Jeanne, who married Alfred Decker.

HARRY NIELSEN—The career of Harry Nielsen has been connected with agriculture for the most of his mature years. After a brief period engaged in a different type of enterprise, he found he liked the business with which he was familiar from boyhood, and in the Blencoe area he has followed general farming for more than the past quarter of a century. During this time he has become a prominent figure in agricultural organizations and public offices, currently being a member of the State Legislature.

Born at Walnut, Iowa, on May 3, 1895, Harry Nielsen is the son of Carl and Martina (Christiansen) Nielsen. Reared on a farm, he attended rural and Little Sioux schools, Harrison County. He was associated with his father's agricultural interests until a year or two after he became of age, and rented a farm of two hundred acres, raising mainly wheat and corn. He sold his holding in 1918 to join the Army but the Armistice was signed before he was inducted and he joined his brother-in-law in the hotel business at Onawa, county seat of Monona County. In 1922, however, he returned to agriculture in the Blencoe section, where he cultivates some two hundred acres of his own land, and rents five hundred and sixty more, growing, on a large scale, wheat, corn, alfalfa and other hays, with smaller amounts of other crops. His step-son is a partner in the business.

Harry Nielsen is thoroughly up-to-date in his agricultural pursuits, a member of the Farm Bureau and also in close contact with fellow operators, and is a board member of the Blencoe Farmers Elevator. Public-spirited, he has served as township trustee for six years, is a member and current president of the Blencoe School Board, and in 1948 was elected to serve as a Representative, for 1949-50, in the Iowa State Legislature. He is a Democrat in politics, a subject of which he has long been a student, and is influential in party councils and campaigns. Fraternally he is affiliated with the Modern Woodmen of the World. He is of the Congregational faith.

On July 22, 1922, Harry Nielsen married Irene Miller, daughter of David and Burzilla (Conger) Miller, her father a railroad man. Mr. and Mrs. Nielsen are the parents of two children: 1. Jack, born in April, 1923, who is a dirt contractor; he married Marcella Shanklin, and they have two children: Jacqueline, and Wilbur Scott. 2. Kathryn, who was born July 14, 1931, and married James Howschultz. Mr. Nielsen has three step-children: 1. Kenneth Perry, a farmer; he married Lucy McHugh, and they have two daughters and one son: Joan, Judy and Patrick. 2. Earl D. Perry, associated in business with his step-father; he married Dona Crabb, and they are the parents of two children: James and Lyle. 3. Janyce, who married T. R. Caritt, a farmer, and they have two daughters: Patricia and Sally.
