## Harlan Foster

Harlan E. Foster, 89, died at Henry County Memorial Hospital Sunday morning, June 22, 1975.

The son of Charles and Armina Foster, he was born March 10, 1886, near Hastings, Neb.

He lived for 40 years on a farm in Henry County which had been in his family since 1853. He was engaged in livestock and general farming until moving to Mt. Pleasant in 1953.

An Iowa State Representative from 1936 to 1942, he served as State Senator from 1942 to 1950. He was a member of the Prairie Gem Methodist Church and an honorary member of the Mt. Pleasant Kiwanis Club.

On Sept. 26, 1909, at Sinton, Texas, he was married to Nellie L. Ross who died on March 4, 1975.

Surviving are three children, Mrs. John (Frances) Brown of Mt. Pleasant, Floyd of Crawfordsville and Mrs. George (Dorothy) Baier of Detroit, Mich.; seven grandchildren; 11 great-grandchildren; one brother, Lloyd Foster of Los Angeles, Calif.

One brother and one sister also preceded him in death.

Funeral services will be 2 p.m. Tuesday, June 24, at the Crane-Ewart-Young Funeral Home. The Rev. Mark Hagy, pastor of the Wesley United Methodist Chapel will officiate with interment in Forest Home Cemetery.
