Briefly describe what the minimum wage law is, does it cover full-time as well as part-time employees and at what age does it begin? Are all businesses, including hospitals, obliged to honor this law.

There is a different minimum wage for all varieties of employment and the basis for determining these varied minimum wage scales is dependent upon many factors, including the employer's gross annual income, net profit, number of employees, etc.

In instances where the minimum wage law is applicable, both full-time and part-time employees are cov-

ered. Employees are primarily covered at age 18, although there are exceptions.

Regarding hospitals, the varied minimum wage laws affecting the medical field are very complex.

The answers to your questions are general, but as was stated earlier, a variety of factors are involved. May 15, 1886, near New Hampton, the son of Bartholemew and Magdalena Alleman Blatti. He attended Chickasaw County Schools and was a graduate of the Oliver Business College at New Hampton. He was married to the former Atense R. Klatt on January 1, 1913. The couple lived in the New Hampton area after their marriage and Mr. Blatti served as a Chickasaw County Supervisor and also as a State Representative in the Iowa Legislature, in addition to being engaged in farming. He was a member of Trinity Church, Arcana Lodge 274, Ancient Free and Accepted Masons, New Hampton, the Elks, and the Knights of Pythias.

Survivors include his wife; a son, Alindo Blatti of New Hampton; four grandchildren and eight great-grandchildren.

He was preceded in death by his parents, brothers and sisters.

To Exchange Old Food Stamps For New

"Food stamp recipients will be able to exchange old stamps for new ones as old stamps expire on August 31. Dennis M. Doyle, administrator of the Food Nutrition Service, U.S. Department of Agriculture, announced Friday.

"Until August 31, food stamp recipients may use old stamps in authorized food stores," Doyle said. "After that date, recipients will be able to use old stamps at local food stores."
