and later became county
commander and district
commander. He was also a
Fourth Degree member of the
Knights of Columbus and was
a past district deputy of this
organization. Mr. Gardner
was very active in many civic
affairs in Waverly.

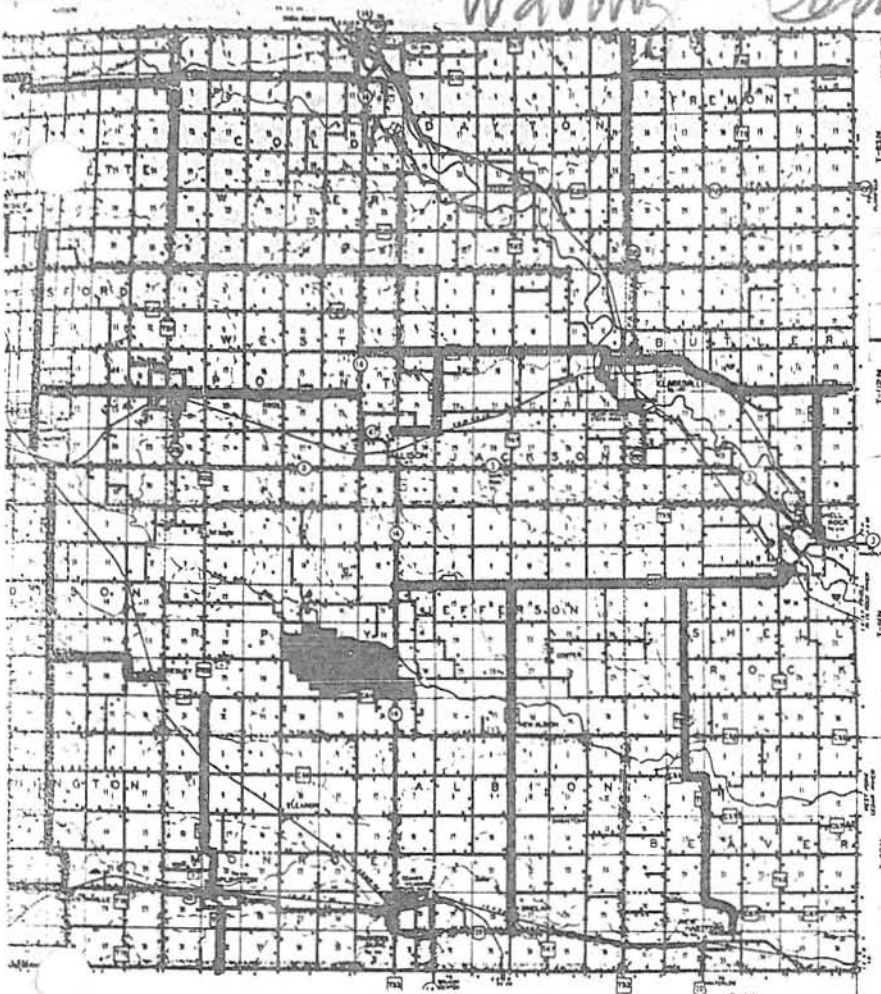

Bremer Co. Landfill Plan Goes to DEQ

Bremer county supervisors
Monday approved submission
of the Bremer County
Sanitary Landfill Plan to the
Department of Environmental
Quality for state approval of
the operation.
The landfill in Warren
township has now been in
operation for over two years
with minimal problems. After
its first year of operation the
landfill became a model
project visited by represen-
tatives from many other
midwest counties and com-
munities interested in
establishing a similar method
of waste disposal.
All such landfills will have
to be approved by the DEQ by
this July to continue in
operation.
In other action the super-
visors amended their joint
agreement with Chickasaw
