F. M. Beatty, Local Attorney, Dies On Sunday

Frank M. Beatty, a Sigourney practicing attorney for over 53 years, died at the Keokuk county hospital, Sigourney on Sunday at 6 p.m. Funeral services will be this afternoon (Wednesday) at the Sigourney Presbyterian church.

Mr. Beatty has been seriously ill at his home the past few months, and re-entered the Keokuk county hospital recently.

Mr. Beatty, 81, was born March 18, 1882 near Thornburg, son of James and Sarah Murphy Beatty. He graduated from Thornburg high school, and when a young man taught school in South Dakota. He received his bachelor of arts degree from Iowa Wesleyan college of Mt. Pleasant; and master of arts degree, and bachelor of law degree, from Northwestern University of Evanston, Illinois.

In 1910, the year he received his law degree, he entered law practice in Hedrick. On being elected Keokuk county attorney a year later he moved to Sigourney, and was a partner for 12 years with D. W. Hamilton, who was later district court judge.

A republican, Beatty was elected Iowa State Senator from the 12th district in 1926, and served eight years in all, being re-elected for a second four-year term in 1930.

He married Lois Gibbons of Thornburg; and Mr. and Mrs. Beatty were the parents of a daughter, Sarah Beatty, of Denver, Colorado.

He was a member of the Sigourney Presbyterian church, and served as elder and deacon; a member of the Sigourney Masonic lodge since 1923, and also a 32nd degree Mason in Iowa Consistory of Cedar Rapids, and a member of Kaaba Shrine of Davenport. He was a member of the Iowa Bar association, and the Keokuk county bar association.

Surviving are his wife and daughter. He was preceded in death by his parents, a brother George, and a sister, Anna.

Funeral services this afternoon (Wednesday) at 2 o'clock were at the Presbyterian church, conducted by the Rev. James Glass, pastor. Casket bearers were Keith Dunton, Edward Holland, Roy Fox, Gerald Denison, George Thorburn, C. M. Wylie, Howard Life, and J. E. Willcockson. Burial was in Sixteen cemetery near Thornburg. The funeral was in charge of Holm Funeral home of Sigourney, and Geyer-Lewis Funeral home of Albia.

Brucellosis Testing To Be Completed By May 31 In County

Testing of cattle in Keokuk county for brucellosis is expected to be completed by May 31.

The cooperation from herd owners has been excellent and the veterinarians have worked hard to reach this goal, stated Dr. K. R. Hook, federal veterinarian.

It is estimated over ninety percent of the cattle in the county have been completed. Only one herd remains in Clear Creek township. In the other 14 townships all but two are over 85 percent tested.

Most of the remaining cattle should be tested before the end of March to avoid conflict with field work, stated Dr. Hook. Owners that have not yet been approached to test their cattle are advised to contact their veterinarian.

Herd owners are reminded to have their calves vaccinated against brucellosis. This is a requirement on all calves born after July 4, 1963 if they are to be sold later as breeding stock.
