World Horizon

When Paul writes to his "pen-friends" at Rome (15:22-29) of a projected trip to Jerusalem and Spain, taking in Rome on the way, he was laying out a trip to the east and west ends of civilization, the jumping-off places. His plan was as ambitious as if a modern evangelist would write to some church in India: "I aim to visit Iceland and Japan, and call on you on the way out."

William Carden, 84, Passes Away Following Illness

William Carden, son of Wm. and Isabelle (Miller) Carden, was born Aug. 24th, 1865, near Middletown, Ia., and died at his home in Winfield Saturday, March 18, 1950. He received his education in the public schools and in Parsons College at Feifield.

On Nov. 18, 1891, he was united in marriage to Miss Fannie DeLashmutt of Des Moines county. One child was born to them in 1893 but died in infancy. One adopted daughter, Miss Thelma Carden, together with the widow still survive. Mr. Carden was the youngest of a family of seven boys and one girl, all of whom preceded him in death. Several nieces and nephews still survive.

He had been active in the Presbyterian church all his life, having served this congregation for 42 years as Sunday school superintendent and as an active elder for 50 years. He had also been moderator of the Presbytery and vice moderator of Synod—offices which rarely are filled by laymen of the church. He organized the first Christian Endeavor society in this church and never lost his interest in youth.

He had served his fellow men in various other capacities which are worthy of note:

He was in the state legislature for 6 years and in the senate for 8 years. He had been an active trustee of Parsons College for the last 35 years and had been Vice President of the local Farmers National Bank since its organization in 1916. After teaching school and being associated with Cranes in Mt. The Church at the Hub Of the World

THERE IS NOTHING at all in the New Testament to indicate that the church at Rome was considered, by Paul or any one else, as The Church, or the Mother Church. There is no claim that it was founded by St. Paul, still less by St. Peter.

It grew, as other churches grew, by infiltration. Christians who moved to the big city would get together, and there the church would be. Yet, of course, the Roman church was important.

It was important because it was at the hub of the civilized world. Paul did not seem to mind it in the least, that he could work only inside his prison, or "confined to quarters."

Writing from his jail cell to the Philippians, he mentions converts from the army and from the imperial slaves. "Caesar's household" in Phil. 4:22 does not refer

the church. He organized the first Christian Endeavor society in this church and never lost his interest in youth.

Hauter, a former minister here, gave the sermon while the prayer was given by Rev. E. D. Byrd who represented Iowa Presbytery. The benediction was given by Dr. J. W. Bean, a former pastor nad present vice-moderator of the Synod of Iowa.
