OSCAR JOHANNES GRAU

MR. SPEAKER: Your committee appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable Oscar Johannes Grau, begs leave to submit the following memorial:

Oscar J. Grau was born on a farm north of Newell on June 19, 1890, the third son in a family of three boys and five girls, to Hans J. and Anna E. Bodholdt Grau.

Mr. Grau's early education took place at the country school located one mile east of the home farm. This was followed by several winter courses at a private school, a commercial course at Grand View College, Des Moines,

Iowa, during 1909-1910 and then completion of the two-year agriculture course at Iowa State University, Ames, Iowa, in 1913.

He was married to Christena Bodholdt of Waterloo, September 15, 1915, and to this union were born three children: Donald B., Robert B. and Doris.

Mr. Grau, a native of Newell, had resided in Buena Vista County all of his lifetime. After completion of his education, he began farming for himself in the Newell area where he developed a herd of polled shorthorn cattle. He was a charter member of the Farm Bureau and served as county president in 1931. While president of the county Farm Bureau, the Farm Service Company was organized. In 1936 he was named temporary chairman of the Farm Bureau Rural Electric Committee. The Buena Vista County REC was incorporated January 18, 1937, and Mr. Grau was one of the original signers. At the board's first meeting he was elected president and served the organization in that position for 12 years. In May, 1937, the REC board voted to become a member of the Central Electric Federated Cooperative and he was named Buena Vista county representative on the board.

From 1948 to 1954 he served as the mayor of Storm Lake. He was past rice president for Development of Buena Vista College as well as serving as a college trustee for several years.

Upon his instigation in 1947, he joined four other men in the organization of a corporation to build a radio station in Storm Lake. Station KAYL went on the air in 1948 with FM being added in 1950. He served as corporation president until the Cornbelt Broadcasting Company was sold in 1972.

Mr. Grau had been a resident of Storm Lake since 1940 when he retired from active farming in Coon Township.

He was a member of Lakeside Presbyterian Church where he had served as an elder, a Scottish Rite Mason, member of the Shrine, longtime member of the Storm Lake Chamber of Commerce, Elks Lodge, Order of Eastern Star and Phi Kappa Delta Honorary Forensics fraternity. For more than twenty-five years he served as president of the Buena Vista County Mutual Insurance Association, beginning in 1944.

A Republican, Mr. Grau was a State Representative for Buena Vista county during the Forty-fifth, Forty-fifth Extra General Assemblies, serving on the committee that wrote the three-point tax law—income, sales and corporation income tax—which has since been the basis of state treasury income. He was chairman of the subcommittee promoting the police radio system and was instrumental in the location of the police broadcast station in Storm Lake.

His wife, Christena, preceded him in death in 1967. In 1969 he married Alma Bodholdt of Newell.

Mr. Grau died at the Buena Vista County Hospital July 28, 1974, after a lengthy illness.

Hans Grau Family

he Hans Graus were a pioneer family in Buena Vista County. Hans Grau and his wife, Anna Bodholdt Grau, were both born in Denmark. They immigrated to the United States, coming to Newell in 1885. They bought land in Coon Township from the original homesteaders. The family lived on this farm for many years. They raised eight children: Alfred, George, Oscar, Marie, Emma, Sarah, Laura and Ester. 
the Grau family.

Oscar Johannes Grau

scar Johannes Grau was born June 19, 1890, at the Grau farm in Coon Township, Buena Vista County. He was the fifth of the eight children of Hans Jorgen and Anna Bodholdt Grau. He attended Buena Vista County schools and Iowa State College. In 1915 he began farming on the home farm where he developed a herd of Polled Shorthorn cattle.

On September 15, 1915, he married Christena Bodholdt, the daughter of Hans and Marie Nielsen Bodholdt of Waterloo. She was a graduate of West Waterloo High and Iowa Normal School in Cedar Falls and had taught at Vinton and Charter Oak before her marriage.

O. J. Grau was a charter member of the Farm Bureau and served as county president in 1931. During his presidency the Farm Service Company was organized.

He was elected to the Iowa House of Representatives in 1934 and served on the Committee that wrote the three point tax law — income, sales and corporation income tax — which has since been the basis of the state treasury income. He was chairman of the sub-committee promoting the police radio system and was instrumental in the location of the police broadcast station in Storm Lake.

In 1936 Grau was named temporary chairman of the Farm Bureau rural electric committee. In 1937 he was elected the first president of the Buena Vista County REC and served in that position for 12 years. He was also the Buena Vista County representative on the Central Electric Cooperative

In 1940 he retired from farming and moved to Storm Lake. From 1948 to 1954 he served as the mayor of Storm Lake. He was vice president for development of Buena Vista College and served as a college trustee for several

In 1947 he was instrumental in the organization of radio station KAYL and served as corporation president until Cornbelt Broadcasting was sold in 1972. For more than 25 years Grau served as president of the Buena Vista County Mutual Insurance Association. He was a member of Lakeside Presbyterian Church where he served as an elder, and was a Scottish Rite Mason.

Christena Grau died on July 4, 1967. In October 1969 O. J. Grau married Alma Jensen Bodholdt of Newell. He died on July 28, 1974. Oscar and Tena Grau had three children.

Donald Bodholdt Grau was born June 12, 1916. He graduated from Newell High School and Iowa State College with a degree in engineering. In March 1942 he was married to Muriel Hofstad. He served in the Air Force in World War II. After working as an engi-neer, farmer and Chamber of Commerce Secretary in Storm Lake, Des Moines and Dubuque, he was ordained by the Dubuque Theological Seminary and until May 1983 served as pastor of the Bethlehem UCC Church of Lancaster, Wisconsin. He is now living at Park Rapids, Minnesota. Don and Muriel have two children. Ronald was born June 16, 1943. He attended the University of Iowa. Cheryl was born February 5, 1945. She attended Drake University and is married to Stephen Sypal. They have three daughters, Brenda, Karen and Kristen, and live in Des Moines.

Robert Bodholdt Grau was born January 27, 1918. He graduated from Newell High School and Iowa State College with a degree in forestry. He was the pilot of a B-25 in North Africa during World War II. In 1948 he began his own sawmill and logging operation in Elkader. In January 1955 he married Ruth Button of Waterloo. They have four children. Scott was born November 24. 1955. ill Green was born November 14, 1906, on a ranch at Stratford, Texas, to Burk and Emma Barton Green. He was graduated from Dalhart, Texas, High School. After graduation he worked for Western Union and

the First National Bank of Dalhart, Texas, then moved to Amarillo, Texas, to work in the First National Bank and to play clarinet in the Amarillo Symphony. He was so fascinated with music that he gave up his bank job to follow a former band and newspaper man to Weeping Water, Nebraska, so he would be near the University of Nebraska where he would continue his musical studies toward a Bachelor of Arts Degree. During that time he led several town bands and played in the Lincoln Municipal Band to help defray costs of his education. That was his position when he met Karl L. King of Fort Dodge. Dr. King hired him to come to Fort Dodge in 1936 to play the city concerts and a very heavy schedule of Fair dates over the State of Iowa. At that time, he needed fifteen hours of education to complete his under-graduate degree. Dr. Henry Olson of Buena Vista persuaded him to come to Buena Vista college, to do this work. He returned to Storm Lake in 1942 to become Director of Instrumental Music in the Storm Lake Public Schools until December of 1943 when he left for service in the United States Army. In November of 1945 he was discharged from service and returned to this position and served until 1950 when he transferred to the Buena Vista College position which he held until his retirement in 1975. At that time Buena Vista conferred a degree of Doctor of Music on him. He was chairman of the Fine Arts

Department and Professor of Mu sic when he retired. His graduate work was done a

the University of South Dakot (M.A.); Summer schools at the Eastman School of Music, Roches ter, N.Y.; Summer Seminars ir San Miguel, Mexico and the University of Copenhagen, Denmark Private study included clarinet with Harry E. Warfel; clarinet with Charles E. Ewing (formerly solo clarinet with Arthur Pryor's Band); Clarence Warmelin, Chicago, Illinois; and Violin with Carl Frederick Steckleberg. Professional playing experience included the Amarillo, Texas Symphony, The Lincoln, Nebraska Municipal Band under Arthur Babich and Wm. T. Quick; Solo Clarinetthe 105th A.G.F. Band-World War II; B-Flat & E Flat clarinet with Karl L. King's Fort Dodge Municipal, and Fair Band for thirty-six years and several concerts with Monohan Post Band at Sioux City. Conducting experience included Conductor and Assistant Conductor of Lincoln, Nebraska Municipal Band; Conductor of Will Green's Concert Band, Lincoln, Nebraska (a professional organization that played radio engagements and the Nebraska State Fair); town and school bands in Iowa and Nebraska. In addition to directing the instrumental music in the Storm Lake Public Schools and Buena Vista College, he directed the Storm Lake Municipal Band for twenty years and was Director of the Karl King Municipal Band of Fort Dodge from 1971 until his death in June of 1977.
