CHARLES A. BENSON

Charles A. Benson, son of August and Sara Elizabeth Jacoby Benson, was born April 22. 1888, on a farm in Highland Township, Clayton County, Iowa. He passed away at Central Community Hospital, Elkader, Iowa, on March 6, 1980, having reached the age of 92

He lived his entire life on the family farm and together with his brethers, Oscar and Adolph. farmed in partnership. Besides farming, he was active in many community and state affairs. In 1918 he helped form the layton County Farm Bureau and was a charter member of same.

In association with the Elkader Lodge No. 72 A.F. and A.M. he became a 32nd degree Mason, a past worthy patron of Charity Chapter Order of the Eastern Star and was awarded the Grand Cross of colors for his work with Rainbow Girls. In addition, Mr. Renson became a member of the Iowa Consistory Scottish Rite of Free Masonry and El Kahir Temple of Cedar Rapids, Iowa.

In early 1900 he began a life devoted to polities as Clavton County Clerk of Court. In 1926 he was elected to the Iowa State Senate. serving two consecutive terms. Mr. Benson continued an active interest in politics throughout his life.

During World War II he was a member of the Clayton County Appeal and Draft boards and in the 1950s was a member of the Federal Land Bank of West Union, Iowa, serving as president of the board for a period of time.

Mr. Benson was baptized in the Marion Lutheran Church at Gunder, lowa; confirmed at the Highla : Lutheran Church where he taught Sunday School for many years and held various offices. Later in life he became a member of the Peace United Church of Christ in Elkader, Iowa.

He was preceded in death by his parents; a sister, Mrs. Hilma Erickson in 1930; a brother Adolph L. Benson, January 4, 1959, and Oscar A. Benson, December 14, 1963.

He is survived by a sister, Mrs. Jerda Cheeseman: three nephows, Robert, Dale and Byron Cheeseman; two nieces, Iowa Erickson Larson and LaVon Erickson lyens, and 14 grandnephews and neces.

Funeral services and burnal were conducted by the Rev. Duane Berg at the Illghiaud Lutheran Church on March 8, 1980.

RAY SPERBECK, editor, owner and publisher of the Swea City Herald in Kossuth County, is a native of Iowa, learned the printer's trade when he was a boy, and printing and newspaper work have constituted the chief means by which he has fitted himself into the niche of useful occupation in the world.

He was born at Milford, Dickinson County, Iowa, February 8, 1888. His parents, C. F. and Mahala (Jenkins) Sperbeck, are living retired at Spirit Lake. His father was born in Wisconsin and his mother in Dickinson County, Iowa. During his active career his father was a railroad engineer.

Ray Sperbeck attended school at Milford and learned the printer's trade at Estherville in Emmet County. It was in 1909 that he located at Swea City and bought the plant and equipment of the *Herald*, and has succeeded in a reasonable degree in making that paper an important institution in the life of the community.

Mr. Sperbeck married Miss Mamie Bruce, also a native of Iowa. They have one daughter, Jeanne. Mr. Sperbeck conducts a paper independent in politics. His personal thought and tendencies in political matters have socialistic leanings. He and his wife have been quite active in the educational interests of their home town.

REV. WILLIAM H. KENT is a notable representative of the modern minister of the Gospel. Liberally educated, broad-minded, tolerant, sympathetic, a scholar, an eloquent speaker, he is well qualified for leadership and has proved his effective power for work among men not merely as a minister but in his contacts man to man.

Mr. Kent in his career has been pastor of metropolitan churches, but for several years has been located at Nashua, Iowa, where he is pastor of the Congregational Church, and is also pastor of that famous institution known as the Little Brown Church in the Vale.

Mr. Kent was born near Freeport, Illinois, October 6, 1868, son of Daniel and Mary (Gable) Kent. His mother was born in Pennsylvania, of German parentage. She died when her son William was an infant. Daniel Kent during hisearly life sailed on whaling vessels to all parts of the world. Later he settled down to farming. During the Civil war he was in the Army of the Potomac and after the war moved to Kansas, taking up Government land, and one of his sons is now a farmer in Phillips County, that state. From Kansas they moved to Nebraska, and it was in Nebraska that William H. Kent received his first school advantages. In 1897 he was graduated A. B. from Redfield College. His college expenses were met by the exercise of his talents as a penman. He taught penmanship classes in the high school at Redfield and also had charge of the penmanship department and taught mathematics in the college. Other educational experience was acquired as a country school teacher. During his college days, looking to the future, he resolved to enter the ministry. In 1902 he was graduated Bachelor of Divinity from the Chicago Theological Seminary and in 1904 was ordained. His first pastorate was at Edelstein, Illinois. He was pastor of St. Paul's Church on the West Side of Chicago and later was member of the staff of the new First Congregational Church on the West Side, one of the very large religious institutions of that city. For six years he was a pastor at Milford and was then made assistant superintendent of the Iowa Conference, in charge of work in the eastern part of the state, with headquarters at Cedar Rapids. This office he held six years. From there he came to his present work at Nashua and the Little Brown Church in the Vale. During 1929 Mr. Kent was called upon to officiate at the marriage of 244 couples.

Young people and their interests and problems have always deeply interested him and much of his best work has been done among the young. Mr. Kent has some interesting literary gifts, and has been a writer of numerous stories, including a small volume of fiction entitled Tacky Jim.

He married Miss Bessie Murray, of Edelstein, Illinois. Six children were born to their union: William; Mary, a graduate of Coe College of Cedar Rapids; Kenneth, in the freshman class at Coe; Virginia, Ray and Kathryn, all at home at Nashua.

Mr. Kent is a member of the Scottish Rite Consistory of Masons at Sioux City, and he and his wife belong to the Eastern Star. He is a Republican, and at times has been called to the public platform to speak on current issues, and he delivered some addresses in behalf of the League of Nations and the World Court. His war service consisted not only of speaking, but in practical forms of aid to the Government. For a number of years he has been a poultry fancier and is regarded as an expert in the poultry business. During the war he conducted a number of poultry demonstrations for the Government in Dickinson and Paulding counties. At one time he conducted a hatchery, selling several thousand chicks each season.

CHARLES AUGUSTUS BENSON, who is serving as a member of the Iowa State Senate, in which he is serving his second term, has communal and material interests that make him intrinsically loyal and progressive in his official capacity, and his election to the Senate and his service therein are the more interesting to record by reason of the fact that his native county is included in his representative district and that in the county

he has long been a leading exponent of modern agricultural and live stock industry, his fine farm estate in Clayton County being situated seven miles northwest of Elkader, the county seat, and on rural mail route No. 3 from that city.

Senator Benson was born on the parental home farm near Elkader, Clayton County, April 22, 1888, and is a son of August Benson, who was born in Gothenberg, Sweden, and gained there his early education, he having acquired definite pioneer prestige in Clayton County, Iowa, where he achieved large and worthy success in farm enterprise and where his sterling character brought to him the fullest measure of popular confidence and good will.

Charles A. Benson was reared to the sturdy and invigorating discipline of the home farm, and in the meanwhile he profited by the advantages of the public schools of his native county, where he thus continued his studies until 1902. He thereafter was actively associated with the work and management of his father's farm until 1907, when he went to Des Moines and entered the Capital City Commercial College. In that institution he was a student one year, and he then returned to the home farm. In 1911 he became a student in Iowa State College, at Ames, in which he was graduated as a member of the class of 1914. After thus fortifying himself in scientific and practical knowledge that was cer-tain to be of inestimable value to him in his further alliance with progressive farm industry he returned with his well earned diploma to the parental home. In the autumn of the same year he was appointed deputy district clerk of Clayton County, and of this office he continued the incumbent until March, 1917. In the meanwhile he had been associated with his father and brother in acquiring additional farm land in Clayton County, and after completing his service as deputy district clerk he resumed his active association with the management of the now large and valuable landed estate acquired by the family. He has proved much of a leader in the advancing of the standards of agricultural and live stock industry in his native state and has been specially influential as a breeder of fine Shorthorn cattle. He is secretary of the Clayton County Farmers Association and also of the County Fair Association, is president of the Clayton County Shorthorn Association and is a director of the Iowa Shorthorn Breeders Asso-He has been active and influential in ciation. the councils of the Republican party in this part of the state and in 1924 he was elected to the State Senate, the popular estimate placed upon his service having been shown in his reelection in 1928. As a legislator he has made earnest and successful effort to promote the passage of laws and measures that shall advance the civic and material prosperity of his native state, and has done much for the benefit of his constitutent district. Senator Benson is affiliated with the Masonic fraternity and he and his wife are com-

municants of the Lutheran Church. Their attractive rural home is known for its generous hospitality and good cheer, and Mrs. Benson is its gracious and popular chatelaine.

GUSTAV A. SUNSTRUM. The late Gustav Sunstrum was for years one of the outstanding citizens of Oskaloosa, whose attention was not only given to his large mercantile interests, but also to other matters of great and general importance. His keenness of business perception and cooperation in public effort, his acceptance of his duties as they came, combined with his broad and abundant sympathies, brought him appreciation from a wide circle. Whatever he undertook was managed on sound business principles, was carefully calculated and worked out for better conditions where there was need of improvement. Clearsighted, prompt in action, his careful thought was given to all subjects wherein the city's good was concerned, as well as that of his private affairs.

Gustav A. Sunstrum was born in Fillipstad, Sweden, March 7, 1868, and was graduated from his home schools July 16, 1882. In May, 1887, he came to the United States and located at Marshalltown, Iowa, and, after a couple of years of varied employment he took a clerkship with a clothing firm, and a little later came to Oskaloosa and spent four years in the employ of a clothing firm of this city. It was during this period that he married Miss Ida McCreery at Waukee, Iowa. She was born in Jefferson County, Iowa, a daughter of Landy and Parlee (Stubbs) McCreery. Mr. McCreery was born in Indiana, of Scotch parentage, and Mrs. McCreery was born in Tennessee, but was taken to Iowa at an early day by her parents.

Following their marriage Mr. and Mrs. Sunstrum left Iowa, going to Missouri, thence to Marysville and Albia, Iowa, and then for five years they were at Aberdeen, South Dakota. Mr. Sunstrum there established himself in the clothing business, having decided upon devoting himself to the clothing industry. In 1914 they returned to Oskaloosa, and here he engaged in the clothing business, opening a fine establishment and conducting it until his death December 26, 1928. Always industrious and thrifty, a man with a real talent for business, he was accepted as public spirited, as well as substantial and successful.

Two sons were born to Mr. and Mrs. Sunstrum: John F. married Miss Nell Barnes, a member of an old Oskaloosa family. They live at Oskaloosa, and have two children, Billie B. and Gus Frederick, both at home. The second son, William A., is an efficient public accountant of Chicago, Illinois. Mr. Sunstrum held membership in the Kiwanis Club, the Chamber of Commerce, the Benevolent and Protective Order of Elks and the Knights of Pythias. For a number of years he was interested in the Iowa Chain of Bakeries known as the "Bake Rite Company,"
