

Hugh J. Tamisiea dies; legislator, Dean of the Bar

Hugh Justin Tamisica, 87, Dean of the Harrison County Bar Association, died on Sunday, July 20, in Omaha.

The son of Charity Ann Brown and Frank Tamisiea, he was born in Missouri Valley on September 23, 1898. Hugh received his preliminary education in the public schools of Missouri Valley. and in 1916 was graduated from Missouri Valley High School as valedictorian of his class.

He received his collegiate training in the College of Liberal Arts at the University of Iowa, from which he was graduated with high distinction in 1922. He received his Doctorate in Law from the College of Law, University of Iowa in 1924,

While in law school, he was a member of the Board of Editors of the Iowa Law Bulletin.

After graduation, he entered into the practice of law, with his father, the late Frank Tamisiea, under the firm name of Tamisiea **HUGH TAMISIEA**



Frank Tamisiea 1860-1942




Frank Tamisiea was born in Dubuque, Iowa, and came to Honey Creek, Iowa, more than one hundred years ago. His grandparents emigrated from Alsace-Lorraine, France, after the French Revolution, came to New York and later settled in Iowa. He founded the original law firm of Tamisiea and Tamisiea in 1892, and practiced law in Missouri Valley for nearly fifty years. He was Dean and President of the Harrison County Bar Association at the me of his death. He received his academic training at the Normal College in Dixon, Illinois, and later was graduated from the College of Law, University of Iowa, at Iowa City. He was one of the first students from western Iowa to attend the University of Iowa. His son, Hugh, joined the firm in 1924, and is still practicing law. Charles L. Smith III, a distant relative, joined the firm in 1970. The law firm is one of the oldest under one family name, in the state of Iowa. Frank Tamisiea was City Attorney, City Clerk, Drainage Attorney, president of the Library Board, Railroad Counsel, a lifetime member of the Missouri Valley Volunteer Fire Department, and held many other positions of trust and responsibility in Iowa.

Charity Ann Brown(e) Tamisiea was born near Shelby, Illinois in 1867, came by covered wagon to Loveland, Iowa when she was two years old, and subsequently moved to Missouri Valley over one hundred years ago. She married Frank Tamisiea December 19, 1894. They had five children namely: Frank Harold Tamisiea, who died in 1897, Baby Tamisiea who was born dead, Hugh J. Tamisiea, Ruth M. Tamisiea and Dean Brown(e) Tamisiea. All are deceased, with the exception of Ruth M. and Hugh J. She was active in the Red Cross, American Legion Auxiliary, Federated Women's Club, Daughters of the American Revolution, Presbyterian Church, and all types of community activities. She reached the age, within a few weeks, of one hundred years, and was mentally bright and alert to the very end.

Hugh J. Tamisiea, Their Son

Hugh, their son, is a graduate of the University of Iowa and has a Bachelor's Degree (with high distinction) and an earned Doctor's Degree in law. He was a member of the



State Legislature, pervisor of the Census, Corporate Counsel, Assistant Attorney General, Drainage Attorney, City Attorney, President of the School Board, and of the Library Board, a member of the first Hospital Board, and has served as an Elder in the First United Presbyterian Church. He also was one of the first Lieutenant Governors of Kiwanis in 1928-1929. He is a Past Grand Patron of Iowa of the Order of the Eastern Star and an International Past Most Worthy Grand Patron. This order has more than four million members and forty thousand chapters, widely scattered over the world. He presided over the International Convention held in Miami Beach, Florida, in 1961. This was attended by sixteen thousand members. Hugh has practiced more than fifty-six years as a lawyer, the longest of any lawyer in the history of Harrison County. He is a lifetime member of the Harrison County Historical Association, a sixty year member of the American Legion and of Valley Lodge 232 A.F. and A.M. and is a member of the Abu Bekr of the Shrine of the Sioux City Consistory. He and his sister have travelled extensively in the United States, Canada, the British Isles, Europe, including a trip behind the Iron Curtain, the islands of the Caribbean and Hawaii. He is unmarried.


Ruth M. Tamisiea, Their Daughter

WILLIAM TATE FAMILY

Edward Tate came from England to Camanche, Clinton County, Iowa about 1861. There, he married Hannah Dannatt, daughter of a local farmer, and they had one son, William Thomas. In 1865, Edward met an untimely death in a fall from the back of a moving wagon. He was leading another

team of horses, which became frightened by another vehicle, and jerked him from the wagon under their feet. His widow and son continued to live in Camanche where Hannah earned their living as a dressmaker and William became a farmer. William married Emma Haskins in 1884, but she and the baby died in childbirth later that wear.

baby died in childbirth later that year.
In search of a new beginning, William Thomas moved west to Harrison County im 1890. There, near the village of Reeders Mills, he met Nettie, the charming daughter of Nathaniel Vanarsdale, the local blacksmith, and his wife Margaretta. Grandpa Vanarsdale shod the horses of the local citizens, as well as those of the Mormons as they passed through on their westward trip. In 1893, William and Nettie were married and settled on a farm one and a half miles south of Reeders Mills in the Mount Hope school district. Nettie was a dressmaker and milliner by trade, and had graduated from Woodbine Normal School. William and Nettie farmed for nearly thirty years, and were active in the Progressive Farmer's Club, the Masons and the IOOF. To this union were born five children, John Horton dying in infancy. Before their parents retired to live in Logan, the three eldest children, Mary, Hattie, and Roy, established their own homes and families. After moving to town from the farm, William was the meat cutter at the Hetrick Grocery Store. Carmaleta, the youngest, graduated from high school, and attended business school in Omaha. After business experience there, she returned to Logan to be the bookkeeper at McKenney-Seabury Chevrolet, until she moved to Santa Cruz, California in 1956.

Mary married Jesse Haight amd moved to Chicago. After his death in a train accident, in 1927, she became active in several ladies ready-to-wear stores. Their children are Rubert, married to Helene Ericksen, and Lornis, married to Rudy Komuchar. Hattie married Ray Brownell. After he died in a car accident, she married Jesse Damielson, a native of Crisp. They made their home in Des Moines.

William LeRoy married Clara Ellerbeck, daughter of William and Hannah Mundt Ellerbeck in 1919. They farmed at Logan amd Modale all their lives, and were active in church community activities. Their children are Deane, who married Patricia Canfield; Verda, who married Steve Wolfe; Helen, who married David Glidden; and Thelma, as Mrs. Calvin F. Johnsen is the only one of the Tate children to continue to live in Harrison County. This family is active in the church, school, farm and community activities in the Logan community.

Harrison County has long been the home of my family. My father, Wilson Holbem's family has been here since Great-Grandpa Ehlert emigrated from Germany and homesteaded the acres of Willow Creek bottomland near Magnolia in the 1870's. Grandpa Edwin Holben came from Canada with his parents at six months. Grandma Nellie Ehlert Holben was born on the Willow Creek farm and lived there until she and Grandpa retired and moved to Logan. Dad Wilson was born on that same farm. My mother, Reva Boyd Holben's family settled here in the 1860's when Great-great-Grandpa Boyd came here from Crawford County, Pennsylvania. Great-Grandpa Huffaker moved to Harrison County from Mills County, Iowa, bringing his family.
