's Boy Scouts Go "All Out" to Celebrate 42nd National Scout Week

Boy Scout Week, in observance of the 42nd anniversary of the organization, will strike its peak in Traer this morning when LeRoy Haenze, chief of Traer, will be honored with a highly-prized "God and Country" award at special ceremonies at 10 o'clock Sunday at the church.

Mr. and Mrs. Reuel LeRoy recently achieved the award, one of the highly-prized awards awarded any Boy Scout in the United States. He is the first in the Tama district of Traer to be honored in recognition of his outstanding accomplishment by the national organization. William Martin, Boy Scout executive in this area, here from Marshalltown to the Rev. Paul Somerville, pastor in making the award. Uniformed scouts will attend morning service in a group in the church in the annual custom and arrangement among the churches.

The observance of Boy Scout Week began Wednesday and

continues through next Tuesday, Feb. 12. Traer scouts are wearing their distinctive uniforms and have decorated the display window at the Holst Implement store. They are members of Troop 304 which has for many years been under the local sponsorship of the Traer Lions club and affiliated with the Tall Corn Area Council.

In the east half of the window, they have arranged scouting equipment, featuring camping material. They are privileged to use the camp area on the Edgar Sears place north of Traer and near the Clark State Park. Several scouts annually earn their way, with the assistance of the Lions club, to Camp Mitigwa, near Boone, for the yearly outing of scouts from the Tall Corn area.

Mr. Wilson was born in Franklin, Ind., Sept. 5, 1869, and was 6 months old when his parents, James and Nancy Allen Wilson, moved to Illinois for a few years' stay. When Walter was 4 the family came to Iowa, making the trip in a prairie schooner which was ferried across the Mississippi river at Burlington. The family settled on a farm on the Tama-Black Hawk county line, half a mile from the Grundy line, in 1873. As a boy Walter herded cattle on unbroken and unfenced prairie. He was reared on the homestead, attended the State Normal school at Cedar Falls, graduating in 1892. He also attended the University at Iowa City, and received the bachelor of arts degree in 1894.

Before marriage he was a teacher a few years in Hamilton county, in the Hudson school and in the school of his home district. On Mar. 1, 1898, he married Sarah Sophie Keeler, daughter of the B. L. Keelers, on the Keeler homestead in Buckingham township. Walter had bought a farm in Hamilton county, and they farmed it until 1905, when they purchased

Lots of Hay Goes Up in Flames as Truckload Burns

Ninety-five bales of clover hay were destroyed, and the truck transporting it was badly damaged by fire on highway 63, north of Toledo, about 10 o'clock yesterday morning. The two-ton truck owned by Sam Bryan, of Toledo, and driven by his son, Carl, was moving the hay owned by Fred Uchytel from the former John Meisner estate farm, northeast of Toledo in Carroll township, to the Carl Walz farm, 2½ miles southeast of Tama, which Fred is to operate this year, because of the sale of the Meisner place. Charles Uchytel was riding in the cab with the driver.

Just as the truck drove onto highway 63 from a side road at the intersection south of the Harry Lane farm corner, Fred Uchytel, from the rear-view mirror in the cab, discovered fire in the hay behind them. They pulled out on the shoulder on the west side of the pavement. The fire was beyond their control, but they telephoned for the Toledo fire company. All of the hay was destroyed five tires on the truck and the truck box were destroyed, and the rear side of the cab was damaged. The driver has no idea how the hay was ignited.

A son Edward, and a daughter Ella, preceded Mrs. Evens in death.

The Wilsons were parents of three children, all living: Carl, and Mrs. Roland (Iris) Bohnsack, of Traer, and Dorothy, a teacher in the high school at Medford, Ore. Dorothy is on her way home to attend the funeral, and will arrive Saturday morning.

There are six grandchildren. Mrs. Wilson, who survives, one of Traer's most notable women for many years, went to the state hospital at the same time as her husband. It is expected she will be able to attend her husband's funeral tomorrow. While still on the farm in Buckingham, Walter was induced to become the Republican candidate for the Republican nomination for Tama county representative in the lower house of the Iowa general assembly. He was elected, and re-elected for three additional terms.

He was the second president of the Tama County Farm Bureau, elected in 1919. He was one of the organizers in 1919 of the Buckingham Grain company, which is still prosperous today. He was director and the secretary of the company for 30 years, retiring in 1949. For 25 years he was president and a director of the Farmers Lumber company of Traer. He was active in the Traer Methodist church many years, serving as a trustee and in other offices. He was a 32nd degree Mason, and a citizen of high principles and character.

Mr. Wilson was the last of his family. He had ten brothers and a sister, and outlived the last of these by 17 years. Walter's paternal grandfather was born in the last years of George Washington's life.

Geneseo Church Sets Date of Dedication On Sunday, May 18

A lot of work remains to be done on the new addition of the Geneseo Methodist church, but the Geneseo folks have set the date of dedication—May 18—which is Rural Life Sunday, and have booked their guest speakers for the occasion.

There will be three services. The Rev. John C. Buthman, district superintendent, will preach in the morning. Bishop Charles W. Brashares, of Des Moines, will speak and formally dedicate the building in an afternoon service at 2:30. Former pastors of Geneseo will speak at an evening service.

A new water softener was installed last week in the church. An electric refrigerator and a 10-burner bottled gas stove have been received for the kitchen. Sinks and cupboards are yet to be installed.

Other work to be done includes the laying of the tile floor in the upstairs Sunday school rooms, and the installation of the light fixtures. The lights for the auditorium of the church have been on order many weeks.

Some varnishing remains to be done. On the outside, the new addition has received only a prime coat of paint.

The Geneseo church will be one of the few new building projects in the United States in recent years in which the final cost will be less than the estimates. The reason is that several thousand dollars worth of labor has been furnished by the people of the Geneseo community.

He had also served four years as a member of the official board of the Methodist Church.

Surviving are his widow, one daughter, three sons and seven grandchildren; also two sisters, Mrs. F. F. Lynes, Long Beach, California, and Mrs. Jennie Lynes of Waverly, who is the mother of W. S. and J. K. Lynes, members of the Fifty-fifth General Assembly. One sister preceded him in death.

W. WALTER WILSON

MR. SPEAKER: Your committee, appointed to prepare a suitable resolution commemorating the life, character and public service of the late Honorable W. Walter Wilson begs to submit the following memorial:

W. Walter Wilson was born in Franklin, Indiana, September 5, 1869, and passed away February 6, 1952, at the age of 82 years, 5 months and one day.

He was the son of James and Nancy Allen Wilson. When Mr. Wilson was four the family came to Iowa, making the trip in a prairie schooner

which was ferried across the Mississippi River at Burlington. The family settled on a farm on the Tama-Black Hawk County line in 1873. As a boy he herded cattle on unbroken and unfenced prairie. He was reared on the homestead, attended the State Normal School at Cedar Falls, graduating in 1892. He also attended the University at Iowa City, and received the Bachelor of Arts degree in 1894. Before marriage he was a teacher for a few years in Hamilton County, in the Hudson School and in the school of his home district.

On March 1, 1898, he married Sarah Sophie Keeler. Mr. Wilson had bought a farm in Hamilton County and farmed it until 1905, when he purchased a farm in Tama County near Traer, Iowa. He was active in farming until March 1, 1926, when he retired to Traer.

The Wilsons were parents of three children, all living; Carl and Mrs. Roland (Iris) Bohnsack of Traer, and Doothy, a teacher in the high school at Medford, Oregon.

While still on the farm in Buckingham, Mr. Wilson was induced to become the Republican candidate for Tama County Representative in the lower House of the Iowa General Assembly. He was elected and served in the Fortieth, Fortieth Extra, Forty-first, Forty-second, Forty-second Extra and Forty-third sessions of the Legislature.

He was the second president of the Tama County Farm Bureau elected in 1919. He was one of the organizers in 1919 of the Buckingham Grain company, serving as secretary of the company for 30 years, retiring in 1949. For 25 years he was president and a director of the Farmers Lumber Company of Traer. He was active in the Traer Methodist Church many years, serving as a trustee and in other offices. He was a 32nd degree Mason, and a citizen of high principles and character.

Therefore, Be It Resolved by the House of Representatives of the Fifty-fifth General Assembly of Iowa, That in the passing of The Honorable W. Walter Wilson, the State has lost an honored citizen and a faithful, useful public servant, and the House, by this resolution, would express its appreciation of his service, and tender its sympathy to the members of his family.

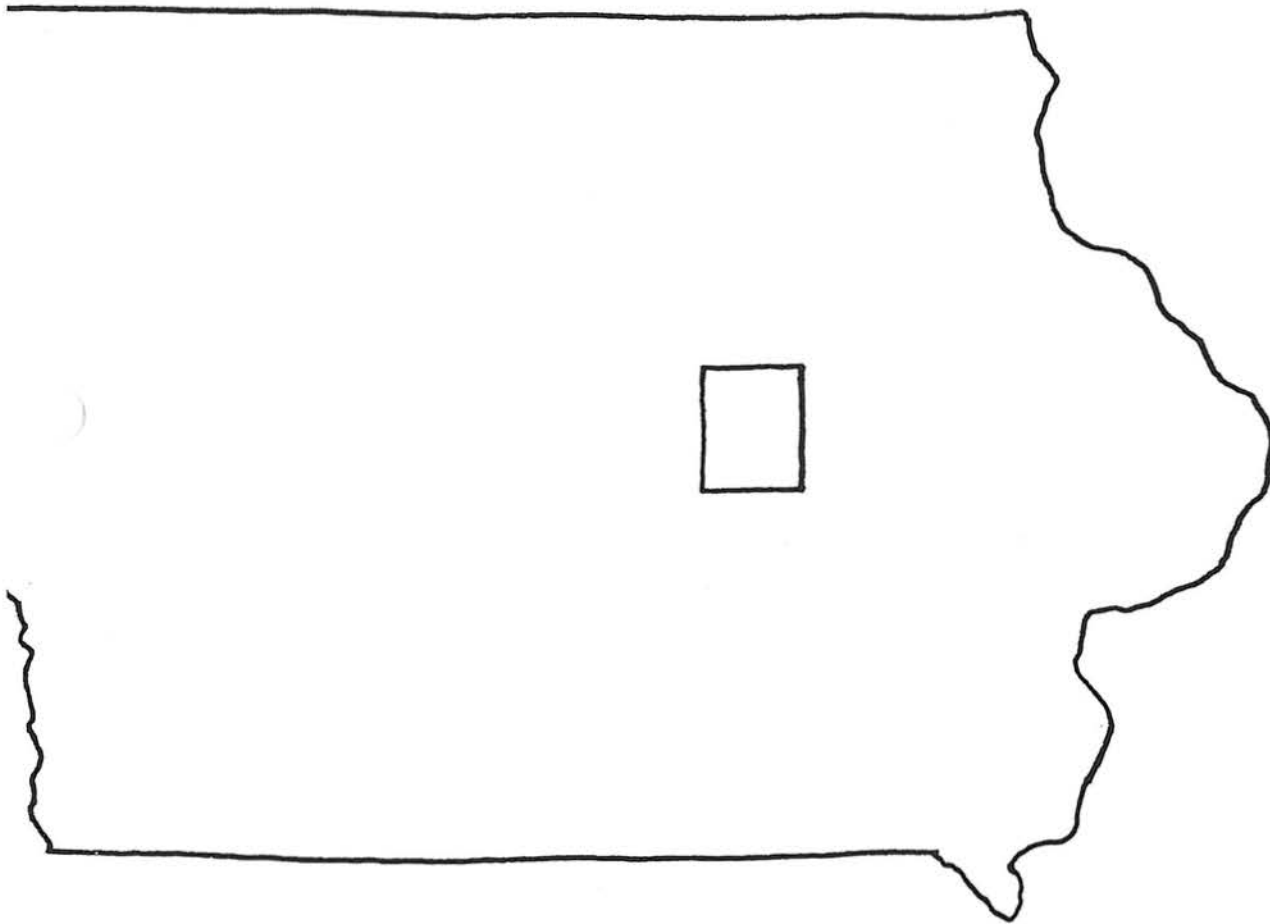
