# C. P. JOHNSTON SERVICES HEID Today At Home, 2 o'Clock

## Burial In Hillside Cemetery, Died Monday

C. F. Johnston, prominent Sheffield business business man for 57 years, died at his home here Monday morning at 10:15, at the age of 79, from a heart ailment.

Funeral services will be held this afternoon (Thursday) at the Johnston home at 2:00 o'clock, with interment in the family lot in the Hillside cemetery. Rev. O. R. Jones will officiate. The stores and business places of Sheffield will close during the services.

Charles Frederic Johnston was born January 17, 1866, in Franklin county. Iowa, near Hampton. He was the son of James J. and Elizabeth Bradfute Johnston, who settled in the county 90 years ago. When a young man he attended country school and graduated from Hampton high school in 1887. Mr. Johnston came to Sheffield and established a real estate business dating table service will be brought from September 26, 1888, and took up the study of law in the office of D. W. Henley in Hampton and the Iowa State University. He was admitted to the bar in 1891.

> On June 29, 1892, he married Delle Haecker of Hampton, who survives him. They celebrated their Golden Wedding anniversary three years ago. Also surviving are a son, Charles F. Johnston, Jr., of Dixon, Ill., and a daughter, Mrs. R. H. Krause, of Rockford. Michigan, and four grandchil-

During his young manhood Mr. Johnston took an active part in local and state politics. He served as a delegate to state and national conventions, was mayor of the town, a member of the school board on which he served as president, is a past president of the Sheffield Community Club. He was a member of the House of Representatives in 1896, 97 and 98; and a member of the Senate for two sessions in 1924 and 26. While a member of the Senate he was named on a 4-man committee which was sent to Washington in the interest of World War 1 postwar state problems. The past two years he had been afflicted with a heart ailment although he had continued active. He was greatly interested in civic affairs and community improvement. Monday morning he arose as usual, and feeling tired decided to rest on a downstairs lounge. He was talking with his wife, and began to go to sleep, from which she could not arouse him.

Mr. Johnston lived his entire life a resident of Franklin county.



Mr. President: Your committee, appointed to prepare a suitable memorial commemorating the life, character, and public service of the late Honorable Charles Frederic Johnston of Sheffield, Iowa, begs leave to submit the following report:

Charles Frederic Johnston was born in Franklin county near Hampton, Iowa, January 17, 1866, the son of James J. and Elizabeth Bradfute Johnston. He attended rural school and graduated from Hampton high school in 1887; located at Sheffield and established a real estate business dating from September 26, 1888. At the same time he took up law in the office of D. W. Henley in Hampton and the Iowa State University. He was admitted to the bar in 1891. June 29, 1892, he was married to Delle Haecker of Hampton, who survives him. He is also survived by a daughter, Mrs. R. H. Krause, of Rockford, Michigan, and a son, Chas. F. Johnston, Jr., of Dixon, Illinois.

Senator Johnston served as a member of the Iowa House of Representatives in sessions of 1896, 1897 and 1898, and of the Iowa Senate in 1924 and 1926. His record in the legislature was distinguished and outstanding.

Senator Johnston served as delegate to both state and national Republican conventions; served as mayor of Sheffield; the local school board and other local committees and organizations. He traveled for seven years as an internal revenue collector.

Senator Johnston, with his brother, George Johnston, established the Citizens Bank in Sheffield. He was a member of the Methodist Episcopal Church and several fraternal organizations, and spent his entire life a resident of Franklin county. He died at his home at Sheffield, Iowa, November 26, 1945.

Therefore, Be It Resolved by the Senate of the Fifty-second General Assembly of Iowa, That in the passing of Senator Johnston the state mourns the loss of a valuable and honored citizen; a man who devoted many years of his life to public service.

Be It Further Resolved, That a copy of this memorial resolution be printed in the Journal of the Senate and that the Secretary be directed to send enrolled copies to the members of the family of the deceased.

#### HISTORY OF FRANKLIN COUNTY.

Lewis Shroyer came to Franklin county in the spring of 1855, and first stopped at Maysville, where he worked at carpenter work two years, that being his trade, when he went to Mayne's creek, and run a saw mill eight years, after which he obtained an interest in it. In the spring of 1865, he moved to the farm where he still lives. He was born in West Virginia in 1832. His parents were natives of the same State, the father born in 1807, the mother in 1810 and were married in 1830. In 1838, they emigrated to Delaware Co., Ind., where the father died in 1876, the mother in 1849. Lewis grew to manhood in that county, receiving his education in the log school house of that day, and followed farming and carpentering. He was married in the fall of 1856. to Joan Jones, born in Virginia in 1834. They have four children-D. W., Clara J., Martin L. and Victor E.

James J. Johnston, a native of Ireland, came to America at the age of sixteen, in company with a cousin, going first to Canada. He then spent three years in New York, took a trip to New Orleans, and in 1855 went to Washington Co., Iowa. In the fall of 1855 he came to Franklin county and located on section 2, Reeve township, where he has since resided. He was born in 1823 in Ireland, where his parents remained until their death. James was married Aug. 31, 1854, to Elizabeth Bradsute, born in Green Co, Ohio, Oct. 8, 1829. They have had seven children-John E., David F., Ralph W., James H., Charles F., George A. and Jennie E. Mr. and Mrs. Johnston are members of the Congregational Church at Hampton. He is a republican in politics and his neighbors have,

at different times, honored him with local offices. In speaking of pioneer days, Mr. Johnston gives the following: When I came to Iowa, in the spring of 1855, there was not a mile of railroad west of Dubuque, and when we wanted flour we usually had to go to Cedar Falls, a three days journey, and when we raised anything to sell it had to be taken to that place We also had to dress our own pork and haul it to Cedar Falls or Waterloo. I sold pork, the year before the war, at that town, for \$2 per hundred and my wheat for thirty-three and one-third cents per bushel. These are facts, which perhaps my grandchildren will hardly believe, unless I here record it in history.

During the next decade, among those who made settlement in the township were: John Imlay, J. M. Soper, Albert Pickering, Amos Shephard, George W. Wilton, Amos B. Hudson, Garrett Luke, Isaac Way, Philip Kratz, Mrs. Susan Cole, John Meyer, O. D. Andrews, A. D. St. Clair and Warren S. Towle.

J. M. Soper is an old settler of Reeve township. He is one of the leading farmers in the county, and for many years has been engaged in buying and selling stock, which he still follows, and in which he is very successful. He was born in Franklin Co., Vt., in 1815, and is a son of Joseph and Elicta (Mansfield) Soper. His father was a captain in the war of 1812, and his grandfather a soldier in the war of the Revolution. When J. M. Soper was six years of age, his parents removed to Franklin Co., N. Y., where he spent his boyhood and received a liberal education. The country being new and heavily timbered, he worked hard at clearing land wife of the subject of this review. Mr. and Mrs. Eberhart are the parents of a daughter, Mary Elizabeth, now the wife of Clarence Moore.

Mr. Eberhart is a republican in his political views and interested in the growth and development of Franklin county. During a period of residence here covering twenty-six years he has become widely and favorably known, his upright and honorable life commanding for him the respect and confidence of all with whom he comes in contact.

#### CHARLES FREDERIC JOHNSTON.

Charles Frederic Johnston, a prominent attorney and banker of Franklin county, is the sole proprietor of the Citizens Bank of Sheffield, a private concern which was organized in 1899 and is one of the leading institutions of the county. He has likewise been a leading figure in local politics, representing Franklin county in the lower house of the state legislature during the twenty-fifth and twenty-sixth general assemblies. His birth occurred on the old Johnston homestead a mile and a half east of Hampton, January 17, 1866, his father being James J. Johnston, of whom extended mention is made on another page of this volume.

Charles F. Johnston spent his boyhood on a farm and acquired his early education in the district schools, while subsequently he attended the Hampton high school, from which he was graduated with the class of 1887. During the winter of 1885-86 he taught in a country school. Following his graduation he studied law under D. W. Henley, who later became a member of the firm of Henley & Bedell and afterward was the senior member of Henley, Bedell & Andrews. On the 26th of September, 1888, Mr. Johnston came to Sheffield and opened an office of his own. In 1889 he pursued a law course in the State University of Iowa, passed the examination before the supreme court of the state and was admitted to the bar in 1891. Throughout the intervening twenty-two years he has been successfully engaged in the practice of law at Sheffield, Iowa. He served as mayor of the city in 1890 but resigned this office and went to Hampton, where he was engaged in the practice of law at Sheffield, Iowa. Johnston, had charge of affairs at Sheffield. His success in a professional way affords the best evidence of his capabilities in this line. He is a strong advocate with the jury, and concise in his appeals before the court. Much of the success which has attended him in his professional career is undoubtedly due to the fact that in no instance will he permit himself to go into court with a case unless he has absolute confidence in the justice of his client's cause. Basing his efforts on this principle, from which there are far too many lapses in professional ranks, it naturally follows that he seldom loses a case in whose support he is enlisted. Mr. Johnston is also the sole proprietor of the Citizens Bank of Sheffield, a private concern which was organized in 1899. His brother George A. was associated with nim as partner in its conduct for several years until his death February 7, 1910. Since March, 1911, W. H. Reynolds has been cashier of the bank, which is one of the leading institutions of Franklin county and one of the foremost in the state for a city the size of Sheffield. It has been built up and managed on a sound, conservative and is recognized as a safe and solid institution in every par-36 icular.

In 1892 Mr. Johnston was united in marriage to Miss Delle Haecker, a native of Franklin county and a daughter of Henry and Barbara Haecker. She was graduated from the Hampton high chool with the class of 1888 and followed the profession of teaching prior to her marriage. She is still a faithful worker in the cause of education and was named a member of the Better Iowa School Comnission by the state superintendent of public instruction. Her cooperation is ever given on the side of mental and moral uplift and her efforts have not been without result. By her marriage she has become the mother of three children, namely: Charles Frederic, r., who is a member of the freshman class at the University of Wisconsin in Madison; Winifred, who is seven years of age; and one on who died in infancy.

As stated above, Mr. Johnston has been a prominent figure in ocal political ranks. He represented Franklin county in the lower louse of the state legislature during the twenty-fifth general assembly and acted as chairman of the elections committee, also helping to nake the new 1897 code. While a member of the lower house of the wenty-sixth general assembly he served as chairman of the railroad committee of the house of representatives and was strongly recomned as speaker of the house. In 1898 he was appointed deputy evenue collector for fourteen counties in the northern half of the tate, ably serving in that capacity for six years or until 1904. He is

Woodmen of America, while his religious faith is indicated by his membership in the Methodist Episcopal church, in which he has served as president of the board of trustees for fifteen years. Both he and his wife have spent their entire lives in Franklin county and are among its best known and most highly esteemed residents. At this point it would be almost tautological to enter into any series of statements as showing Charles F. Johnston to be a man of broad intelligence and genuine public spirit, for these have been shadowed forth between the lines of this review. Strong in his individuality, he never lacks the courage of his convictions, but there are as dominating elements in this individuality a lively human sympathy and an abiding charity which, as taken in connection with the sterling integrity and honor of his character, have naturally gained for him the respect and confidence of men.

#### WILLIAM SENF.

William Senf, living retired in Latimer after many years of close connection with business interests of the city, was born in DuPage county, Illinois, December 31, 1869. He is a son of August and Mary (Schermer) Senf, natives of Germany. The father came to America when he was twenty-one years of age and located first in Cook county, Illinois, whence he moved to DuPage county. In 1890 he came to Franklin county, Iowa, and located in Marion township, where he resided until he retired from active life. He and his wife are now living in Latimer. Among their eleven children are included the following: Henry, of Minnesota; Louisa, deceased; William, of this review; Annie, the wife of F. H. Menning, of Latimer; and Herman and Louis, both deceased.

William Senf was reared in DuPage county and in 1892 established himself in the hardware business in Latimer, this county, and operated this enterprise for ten years thereafter, building up a large and representative patronage. When he disposed of this business he bought a grain elevator, which he conducted successfully for eleven years, or until he retired from active life in 1913. He owns a fine house in Latimer and two hundred acres of excellent land in Wisner township.
