LEGION TO OBSERVE BIRTHDAY MARCH 16

National Commander Will
Speak Over NBC From
6 to 7.

Saturday, March 16, there will be a national broadcast through the N.B.C. from 6 to 7 o'clock p. m. Addresses by National Commander Frank N. Belgrona Jr., National Auxiliary President Mrs. A. C. Carlson, Chef de Chemin de Fer, Forty and Eight, John D. Crowley; memorial services, varied musical and entertainment features in celebration of the American Legion's 16th birthday which had its first meeting for organization in Paris, France. Following this, Legion Posts were organized in most all counties throughout the United States.

Forty ex-service men met in the Cresco court house April 30, 1919, and organized themselves as the Return Soldiers, Sailors and Marine Club with the understanding they would affiliate with some national organization later. G. E. Lyons was elected President and T. R. Perry, Secretary.

July 4, 1919, application was made to state committee for a charter in the American Legion under the name of Howard County Post No. 135. This name was changed to Cresco Post No. 135 April 1, 1922.

Charles H. Wallace, a well-known and prominent Howard County resident died Tuesday night at his home in Saratoga. He was 76 years old, and was born November 15, 1858 in New York state.

Mr. Wallace has been prominent in county affairs, having served as supervisor from 1909 until 1917, or for four terms. In 1918 he was elected to the office of state representative from this county and he served one term in this capacity.

He is survived by his wife and one son, Frank Wallace of Saratoga. Funeral services will be conducted on Friday, March 15 at the home with Rev. Bodenham of Riceville officiating. Burial will be at Saratoga. Friends of the family are requested not to send flowers.

Charles H. Wallace, a well known resident of Howard county, passed away at the family residence in the village of Saratoga at 10 p. m. Mar. 12, 1935.

In December 1933 he went to the University Hospital at Iowa City and underwent a very unsuccessful operation. Since that time he has been a great sufferer.

Charles H. Wallace was born at Manlius, Onondaga county, New York, Nov. 15, 1858. When eleven years of age his mother died; shortly after he came to Howard county Iowa with his father, Henry Wallace and settled on what has ever since been the Wallace homestead. He received his education in the country schools. He was a student all his life, and by constant reading and study kept abreast of the time. He was married to Delia M. Miller on Nov. 15, 1881 and to this union were born two children, Grace H., who passed on, at the age of 18 years, and Frank M. Wallace. He is survived by his wife, son Frank, his daughter-in-law and two grandchildren, Arthur and Mildred Wallace.

In 1901 he united with the Congregational church of Saratoga, and for several years was the superintendent of the Sunday school.

He was a member of the Masonic order.

For nine years he was county supervisor from the third district of Howard county and represented his county as Representative in the 38th General Assembly. His honesty and integrity were never questioned.

HONORABLE CHARLES H. WALLACE

MR. SPEAKER: Your committee appointed to prepare suitable resolutions, commemorating the life and service of the Honorable Charles H. Wallace, late of Howard county, beg leave to submit the following memorial:

Charles H. Wallace was born in Manlius, Onondaga county, New York, November 15, 1858, and passed away at the family residence in the village of Saratoga, March 12, 1935.

When Mr. Wallace was eleven years old, his mother died and shortly after that he came with his father, Henry Wallace, to Iowa and settled on the farm in Saratoga township which has ever since been known as the Wallace homestead. His start in education was obtained in the local country schools, which proved to be sufficient start for a splendid mental development.

He was married to Delia M. Miller on November 15, 1881, and to this union were born two children, Grace H., who passed on at the age of eighteen years, and Frank M. Wallace. He is survived by his wife, his son, Frank, his daughter-in-law, and two grandchildren, Arthur and Mildred Wallace.

In 1901 he united with the Congregational church of Saratoga and for several years was the superintendent of the Sunday School. He was also a member of the Masonic Order.

Most of Mr. Wallace's life was spent in farming on the old homestead. After turning the active management of the farm over to his son, he built a comfortable home in the friendly village of Saratoga where he continued to live until the final summons came.

He served as county supervisor from the third district of Howard county for nine years, and during those years carefully guarded the interests of the people of the county. He took a special interest in government—local, state, and national, and by constant study kept very conversant with the everchanging governmental problems.

He was Howard county's representative in the Thirty-eighth General Assembly and here, as in other tasks he undertook, he rendered faithful, conscientious and valuable service which endeared him to the home people, and won the confidence and admiration of his colleagues.

He was truly a worthy friend and neighbor.

Therefore, Be It Resolved by the House of Representatives of the Forty-sixth General Assembly, That the foregoing memorial be adopted as its appreciation of the life and character and public service of the Honorable Charles H. Wallace.

Be It Further Resolved, That a copy of this resolution be spread upon the records of this House, and that the Chief Clerk be instructed to send an enrolled copy to the family of the deceased.

He was a member of the Board of Trustees of Penn College for years, and for a time was a member of its Executive Committee, and treasurer. He was a ready public speaker and a useful citizen. Politically he was a Democrat and in 1932 was elected senator and served in the Forty-fifth and Forty-sixth general assemblies.

CHARLES H. WALLACE was born in Onondaga County, New York, November 15, 1858, and died at Saratoga, Howard County, Iowa, March 12, 1935. His mother having died when he was eleven years old, he soon thereafter accompanied his father, Henry Wallace, in the latter's removal to and settlement on land in Saratoga Township, Howard County, Iowa. Charles received his education in local country schools. He was a student all his life and was a well informed citizen. He followed farming on the original Wallace homestead until his retirement a few years before his death when he removed to the village of Saratoga. He served as a member of the Board of Supervisors of Howard County for nine years, 1909 to 1918, being chairman of the board the last five years, and in 1918 was elected representative and served in the Thirty-eighth General Assembly. Politically he was a Democrat.

JAY IRA NICHOLS was born on a farm near West Liberty, Iowa, May 13, 1855, and died in West Liberty April 26, 1935. Burial was in Oak Ridge Cemetery, West Liberty. His parents were Ira and Elizabeth (Luse) Nichols. He obtained his education in country public schools supplemented by brief attendance at Iowa City Academy, and a short business course. He was a farmer and livestock producer throughout his active life, and was the owner of a good 300-acre farm near West Liberty. He helped organize the local Farm Bureau and was its president nine years, was president of the Union District Agricultural Society, and was a member of the Muscatine County Board of Supervisors for five years, 1897-1901. In 1901 he was elected representative from Muscatine County and was re-elected in 1903 and served in the Twenty-ninth, Thirtieth, and Thirty-first general assemblies. In 1906 he was elected senator and served in the Thirty-second and Thirty-third general assemblies. He was a Methodist, a Republican, and a useful public citizen.

J. R. BRADLEY was born in Morgan County, Indiana, November 25, 1852, and died in Salina, Kansas, April 16, 1935. Burial was at Salina. He removed in his young manhood to Appanoose County, Iowa. Later he engaged in business in Seymour which he continued several years. In 1885 he was elected representative from Wayne County and served in the Twenty-first General Assembly. In 1886 he removed to Salina, but continued to keep in touch with his former friends in Appanoose and Wayne counties. He met his death by reason of a fire in the residence of his daughter, Mrs. Ruth Lynch, where he made his home.

Granger, a daughter of Aaron F. Granger, who removed from Delaware county, New York, to Chickasaw county, Iowa, in 1872, settling in Deerfield township. Subsequently, however, he made his way to Minnesota and thence to Canada, in which country he spent the remainder of his life. Mr. and Mrs. Larrabee have become parents of six children, as follows: William A., at home; Fred F., who is deceased; Nellie, the wife of John North, of Alta Vista, Chickasaw county; Alice L., the deceased wife of Lee Beard; Hettie A., the deceased wife of Glen Tedey; and Harry S., who went to France with the United States forces and died four days after arriving in that country. Fred F., Alice L. and Hettie A. all died of influenza within a week.

Subsequent to his marriage Mr. Larrabee began farming on the old homestead, which he purchased at that time from his father. In later years he has bought other lands and his holdings now comprise two hundred and forty acres. In 1894 he removed to his present home farm and has thereon since resided. In 1914 he built upon this farm the largest and one of the finest barns in Chickasaw county, the dimensions of which are forty-four by one hundred and four feet. He has added all other buildings and modern equipments, including the latest improved farm machinery, and everything about his place indicates his progressive spirit and his indefatigable industry, which is one of his dominant characteristics.

In his political views Mr. Larrabee is a republican and for many years he has served as a member of the school board, proving ever a stalwart champion of the cause of education. He has not sought or filled other public offices, however, yet his aid and support can be counted upon for any measure that tends to benefit the community in which he lives or advance its upbuilding. While born in Illinois, practically his entire life has been spent in Chickasaw county and his memory forms a connecting link between the primitive pioneer past and the progressive present.

HON. CHARLES H. WALLACE.

Hon. Charles H. Wallace, member of the state legislature from Howard county, is now living retired from business cares in Saratoga, although he is still the owner of valuable farm property. He was born in the state of New York, November 15, 1858, and is a son of Henry and Huldah Wallace. The mother died in the Empire state, after which the father removed to the west and spent his last days upon the farm now owned by his son Charles.

It was in 1870 that Charles H. Wallace accompanied his father to Iowa, at which time the latter purchased a farm on section 32, Saratoga township, Howard county. Charles H. Wallace was a youth of but eleven years at that time. He pursued his education in the public schools and worked with his father upon the home farm through the period of his boyhood and youth. He is still the owner of this place, known as The Oaks, which now comprises two hundred and forty acres of excellent land, and for a long period he was active in farm work but is now living retired, leaving the care of the place to his son. In business matters he was ever found reliable, and his straightforward dealing as well as his energy constituted a factor in his growing and substantial success.

In 1881 Mr. Wallace was united in marriage to Miss Delia Miller, a resident of Saratoga township, where her parents, Mr. and Mrs. Albert Miller, were well known farming people, then owning what is now known as the Alfred Miles farm in the town of Saratoga. Two children were born to Mr. and Mrs. Wallace: Grace H., who passed away at the age of eighteen years, and Frank M., who was married in 1917 to Elsie Mae Kakac, a daughter of Thomas Kakac, conducting a general store at Saratoga, and they now have an interesting little son, Arthur Lee.

Fraternally Charles H. Wallace is connected with the Masonic lodge at Riceville, Iowa, and also with the Modern Woodmen of America. His religious faith is that of the Congregational church, and his wife is also a member of that church. In politics Mr. Wallace is a democrat, giving earnest support to the party, and he has been called upon to fill several local positions. For the past nine years he has been a member of

the board of supervisors of Howard county, and in 1918 higher political honors came to him in his election to the state legislature, of which he is now a member. Since taking his place in the general assembly he has given earnest consideration to all the vital questions which have come up for settlement and upon any important problem his position is never an equivocal one. Howard county numbers him among her representative and honored citizens.

GODLOVE G. LUKES.

Godlove G. Lukes, who follows farming on section 25, Utica township, Chickasaw county, was born February 13, 1892, in the county which is still his home, his parents being Joseph J. and Anna (Nohale) Lukes, the former a native of Winneshiek county, Iowa, and a son of Martin Lukes, who at an early period in the development of that section of the state took up his abode in Winneshiek county, coming to the new world from Bohemia. Joseph J. Lukes after his marriage removed to Chickasaw county, settling in Utica township upon a farm adjoining the town of Protivin. Here he acquired two hundred acres of land, forty of which he owns and farms. The other one hundred and sixty acres of the tract he has sold to his son, Godlove G. Lukes. For many years he has been numbered among the progressive agriculturists of this district, where his carefully directed labors brought to him the measure of success which now enables him to live practically retired.

Godlove G. Lukes was educated in the public schools of Protivin, and his training was that of the farmbred boy who divides his time between the work of the schoolroom, the pleasures of the playground and the cultivation of the fields. When he had attained his majority he was married on the 1st of October, 1912, to Miss Cecilia T. Novak, a daughter of Louis Novak, a native of Winneshiek county, whose father, Thomas Novak, settled in that district when it was largely an undeveloped region, coming to this country from Bohemia. Mrs. Lukes' father now lives retired in Protivin but for a long period was identified with farming interests in this section of the state.

Soon after his marriage Mr. Lukes settled upon his present home farm of one hundred and sixty acres, which he rented from his father that year. In the fall of 1913 he purchased the property and since buying the place has built thereon a large modern barn and other farm buildings and made thoroughly up-to-date improvements, including a wind brake and orchard. He now has one of the excellent farm properties of Utica township and by the consensus of public opinion he is classed with the progressive agriculturalists of this section of the state. He breeds polled Angus cattle and Duroc-Jersey hogs and makes stock raising one of the important features of his business. At the same time he annually produces large crops, conducting the development of his fields along the most progressive lines.

To Mr. and Mrs. Lukes have been born four children, namely: Helen T., Robert L., Daniel J. and Joseph G. In his political views Mr. Lukes is a democrat and he has served as a member of the school board but has never been ambitious to hold public office. He and his family are of the Catholic faith and he has membership with the Modern Woodmen of America. A well spent and useful life has gained him classification with the representative citizens and successful farmers of Chickasaw county.

JAMES W. ROBERTS.

James W. Roberts, who successfully follows farming on section 17, Forest City township, Howard county, was born in Dodge county, Wisconsin, January 18, 1856, a son of William and Jane (Doyle) Roberts, who were natives of Wales and came to the United States in young manhood and womanhood. They settled in Dodge county, Wisconsin, where they were married and resided until called to their final rest. The father devoted his attention to agricultural pursuits and was the owner of a farm of two hundred acres,
