

Brooks was a native of Virginia, was a determined opponent of slavery and moved to Ohio, where in addition to preaching as a minister of the Methodist Church he conducted a station on the underground railway to aid the escape of slaves to Canada. Rev. L. C. Brooks was born in Ohio, and devoted many years to the ministry. He died in 1893. He was a Republican in politics, a member of the Masonic fraternity and the Independent Order of Odd Fellows. Rev. L. C. Brooks married Lina Alford, who was born in Ohio, daughter of Robert P. Alford and his wife, Ann Kilgore. Robert Alford was an Ohio farmer.

Arthur Alford Brooks is one of a family of eight children, six of whom are living. His father by a first marriage had two other children, J. L. Brooks, a contractor at Lancaster, Ohio, and William McKendree Brooks, who is pastor of the Methodist Episcopal Church of Audubon, Iowa. The children of L. C. and Lina (Alford) Brooks are: R. A. Brooks, of New York City; M. C. Brooks, a Methodist minister and district superintendent of the Liberal District of the Southwest Kansas Conference; Arthur Alford; W. G. Brooks, superintendent of schools at Burlington, Iowa; F. D. Brooks, assistant prosor of psychology in Johns Hopkins Univer-

Arthur Alford Brooks was educated at Cornell College in Iowa, graduated with the A. B. degree from Baker University of Kansas, and after his ordination to the ministry and some work as a preacher he attended the University of Chicago. Rev. Mr. Brooks had his first pastorate in 1907 at Davenport, Nebraska, where he remained three years. Following that came one year at Superior, Nebraska, six years at Hastings, five years at Fort Dodge, Iowa, and three and a half years at Lincoln, Nebraska. These terms each represented a calling to a larger and more important service, and in 1925 he accepted assignment to Grace Methodist Episcopal Church at Des Moines. Here his ministry has been exceedingly fruitful, and one of the largest and most beautiful churches in the capital city has been erected for his congregation, which now has a membership of 2,400.

Rev. Mr. Brooks has done a great deal of Chautauqua and Lyceum work while in the ministry. He is a fine speaker, a man distinguished by depth of thought and high purpose and ideals. He is a member of the University Club at Des Moines, the Kiwanis Club and the Prairie Club, and served four years as national chaplain of the Travelers Protective Association. He is a York and Scottish Rite Mason and Shriner, and served as grand orator of the Grand Lodge of Masons of Nebraska, and also as grand prelate of the Grand Commandery of Nebraska

of the Grand Commandery of Nebraska.

Rev. Mr. Brooks married in 1910 Clara M.

Mason, of Brookvale, Colorado. Mrs. Brooks
finished her education in Hardin College at Mexico, Missouri. She is a daughter of Robert and
Franka L. (Burger) Mason. Her father spent

many years as a freight and passenger agent for the Frisco Railway Company. Mr. and Mrs. Brooks have a family of three children: Arthur A., Jr., born in 1913, Lee Culver, born in 1916, and Theodore Lincoln, born in 1919.

Hon. Thomas J. Wilson. An old and honored family name of Iowa that has been intimately identified with the history of this state for almost ninety years is that of Wilson. Prominently identified with early Indian history as a factor in peaceful settlement and relations, it is a matter of fact that the name of Michael Wilson is a venerated one among the descendants of Chief Keokuk and Chief White Cloud because of his friendly attitude toward the Indian and his effort for governmental kindness toward them half a century ago. Primarily the Wilsons were farmers, and their land interests are still large in Washington and Mahaska counties, where the family is still represented, a leading member being found in Hon. Thomas J. Wilson, chairman of the Mahaska County Board of Supervisors and an ex-member of the Iowa State Legislature. He is a very prominent and substantial citizen of Oskaloosa who, both in private and public life, has maintained the family prestige and has added a large measure through his personal achievements.

Thomas J. Wilson was born in Washington County, Iowa, October 23, 1854, of Scotch-Irish ancestry, and a son of Michael and Catherine A. (Hood) Wilson. Michael Wilson was born in Maryland and came to Iowa in 1840, and very soon had large holdings in Washington and Mahaska counties. As already intimated, he was a friend of the Indian, and among other work in behalf of the Red Men was the settlement of the difficulties between Chief Keokuk and Chief White Cloud which had arisen over land disputes. He spoke the language of the Indians, and understood their problems better, perhaps, than any man of his period and locality. Michael Wilson and his wife had three sons and one daughter, namely: C. J., who is an attorney in active practice in Washington, Iowa, and is a colonel on the staff of Governor Hammill; Thomas J., whose name heads this review; W. W. Wilson, who is a farmer in Washington County, Iowa; and Mrs. Alice Shaver, who resides in Washington, Iowa.

Thomas J. Wilson attended public schools in

Thomas J. Wilson attended public schools in his native county, and was reared a farmer, and he has continued his connection with agriculture ever since, being one of the most successful farmers of Mahaska County. For some years, however, he has resided at 411 South Market Street, Oskaloosa.

On May 30, 1876, Mr. Wilson married in Washington, Iowa, Miss Frances Davis, who was born in Vinton County, Ohio, a daughter of Thomas and Elizabeth (Hood) Davis, and a member of an early family of that state. Seven children were born to Mr. and Mrs. Wilson, only two of whom survive, Kittie and Clara, and both are at home.

During 1911, 1912 and 1913 Mr. Wilson was a member of the Mahaska County supervisors, and later served his county in the State Legislature during the Thirty-sixth, Thirty-seventh and Thirty-eighth sessions, and was instrumental in securing the passage of the Equal Suffrage Bill. In 1923 he was again elected to the county board, on which he has served continuously ever since, and of which he is now chairman.

Fraternally Mr. Wilson holds membership with the Knights of Pythias and the Benevolent and Protective Order of Elks. He and his family are active members of the First Methodist Episcopal

Church of Oskaloosa.

It has always been the contention of Mr. Wilson that agriculture calls for our best thought and effort; that farming is the biggest and most important job on earth because every other man's job depends upon the job of the farmer. If the farmer quits, the merchant, the manufacturer, the railroad employes from its president down, and the working men in all lines will have to quit. The whole machinery of human endeavor and human government, even life itself, depends upon the farmer, therefore he must have consideration.

HON. PETER MALCOLM. Probably no department of the state government at Des Moines comes more frequently in direct touch with the farm and farmers of Iowa than the division of animal industry, of which the chief is Dr. Peter Malcolm, formerly state veterinarian and a very accomplished member of his profession, who has

been in Iowa for many years.

Doctor Malcolm was born at Saint Mary's, Ontario, Canada, in 1867, a son of William and Catherine (Craig) Malcolm. His parents were born and married in Scotland and immediately after their marriage came to America and settled in Ontario. His father was a stone mason by trade and that was his occupation, though he also owned and occupied a farm. Both parents were very active Presbyterians and the father was a Conservative in politics, a man of broad reading and information and took an in-telligent part in civic affairs. He served on his city council and was a member of the school board. In the family were five children, the two now living being Dr. Peter, and Mary, who remains in Ontario.

Dr. Peter Malcolm had a high school educa-He worked on his father's farm and as a boy showed a keen interest in all the troubles of the farm animals. Veterinary medicine seemed to be the natural choice for a professional career and he entered the veterinary college at Toronto, perhaps the outstanding school of veterinary science in America. He was graduated in 1890 and for about a year practiced at Saint Marys.

Doctor Malcolm in 1892 became a citizen of Iowa, locating at New Hampton. He carried on a general practice over that section of the state for nearly thirty years. In July, 1920, his attainments led to his selection for the office

of state veterinarian. In 1923 he was made chief of the division of animal industry, with which the office of state veterinarian was consolidated in the same year.

Doctor Malcolm married, in 1893, Miss May Wing, who was born at New Hampton, Iowa, His father, H. J. Wing, was a pioneer settler there and for many years operated a bus and dray line. Doctor and Mrs. Malcolm have one son, Henry Craig, who was educated in the high school at New Hampton and attended Iowa State College at Ames. He is now with Swift & Com-

pany at Los Angeles, California.

Doctor Malcolm and wife are active Presbyterians and both have membership in the Order of the Eastern Star, of which Mrs. Malcolm is a past matron. Doctor Malcolm is a stockholder in the Masonic Home at New Hampton. He is a York Rite Mason, also belongs to the Knights of Pythias and is a Republican. While living at New Hampton he served four or five terms as a member of the city council. He is a member of the Iowa Veterinary Medicine Association, the American Veterinary Association and an hoporary member of the Eastern Iowa Veterinary Association. He occupies one of the offices in of the Eastern Star, of which Mrs. Malcolm is Association. He occupies one of the offices in the State Capitol Building at Des Moines and has six persons working in his division.

ROBERT S. MOTH, physician and surgeon, has practiced at Council Bluffs since 1910, coming to lowa after several years of successful experience in his profession in Chicago, where his father was long an honored representative of the medical

profession.

Doctor Moth was born in the Chicago suburba community of Winnetka, December 26, 1881, so of Dr. Morris J. and Lora (Shibley) Moth. father was born on a Wisconsin farm and be mother in the City of Albany, New York. D Morris J. Moth was a graduate of Hahneman Medical College of Chicago and for several year a member of its faculty. He practiced his profession in Chicago for a quarter of a century He was a Republican in politics, a member the Masonic fraternity and the Congregation Church. There were three children: Harris wife of Willis S. Hilpert, a doctor of philosop and a chemical engineer living at Winnetka, I nois; Dr. Robert S.; and Margery, wife of Dr. James P. McCormick, a physician at Edmonton Canada.

High School, Boston, in 1893, and from the Medical School of Harvard University in 1898. He was house officer in Long Island Hospital, 1896-97; assistant superintendent of Lake Geneva Sanitorium, 1901-05; assistant superintendent Independence State Hospital, Independence, Iowa, 1905-07; medical superintendent State Hospital for Inebriates, Knoxville, 1910-15; medical superintendent Cherokee State Hospital, Cherokee, 1915 to the time of his death. He was commissioned a major in the Medical Corps of the U. S. Army in September, 1918. He had membership in many medical societies and stood high as a neurologist and psychiatrist and in the administration of hospitals.

James A. White was born in La Salle County, Illinois, September 4, 1859, and died near South Amana, Iowa, April 9, 1932. Burial was in St. Mary's Cemetery, Williamsburg. His parents, Peter and Sarah White, removed their family to a farm near South Amana in 1861. James attended country schools, Grave's Academy in Iowa City, and Notre Dame University, Notre Dame, Indiana. He followed the occupation of farming and stock raising, and stock shipping. In 1902 he was elected clerk of the District Court of Iowa County and was reelected in 1904. In 1908 he was elected senator in the Iowa and Johnson counties district and was re-elected in 1912, serving in the Thirty-third, Thirty-fourth, Thirty-fifth and Thirty-sixth assemblies. He was a Democrat in politics.

THOMAS J. WILSON was born in Washington County, Iowa, October 23, 1854, and died in Oskaloosa April 12, 1932. Burial was in Forest Abbey, Oskaloosa. His parents were Michael W. and Catharine (Hood) Wilson. He was educated in common school and on reaching manhood became a farmer. In 1882 he removed to a farm in Mahaska County about seven miles southwest of Oskaloosa. For twelve years he was a township trustee. In 1910 he was elected a member of the Mahaska County Board of Supervisors and served three years. In 1914 he was elected representative, and was twice re-elected, serving in the Thirty-sixth, Thirty-seventh and Thirty-eighth general assemblies. The last few years of his life he lived in Oskaloosa.

WARD WILSON was born on a farm two and one-half miles west of Traer, Iowa, on September 17, 1865, and died at his home on the same farm April 21, 1932. Burial was in Buckingham Cemetery. His father was James Wilson, U. S. secretary of agriculture, and his mother was Esther (Wilbur) Wilson. He was educated in a country school and in the Iowa State College of Agriculture at Ames. For several years he practiced the profession of veterinary surgeon in his section, and was engaged in farming and the breeding of Short Horn cattle and Clydesdale horses. In 1906 he was elected representative and was re-elected in 1908, serving in the Thirty-second and Thirty-third general assemblies.

#### HONORABLE THOMAS J. WILSON

MR. SPEAKER: Your committee, appointed to prepare memorial resolutions commemorating the life, character and public services of the Honorable Thomas J. Wilson, a former member of the General Assembly of Iowa, begs leave to submit the following:

Thomas Jonathan Wilson was born in Washington county, October 23, 1854, and came to Mahaska county in February, 1882, to take up residence on a farm near Eveland, Iowa. He served as township trustee for twelve years, was a member of the Mahaska County Board of Supervisors for a number of years and numerous other county activities. He was elected as a member of the House of Representatives in 1914 and served through three sessions of the legislature, the Thirty-sixth, Thirty-seventh and Thirty-eighth, and was returned to the County Board of Supervisors in 1924, serving with distinction until ill health forced him to resign in 1929.

He was actively associated with the highway development progress in his county and assisted in the first graveled highway in the county; he was always interested in the betterment of Mahaska county and the state.

He is survived by his wife, Mrs. Frances E. Wilson, and two daughters. Funeral services were held at the home on Thursday afternoon, April 4, 1932, and burial was in Forest Abbey, Oskaloosa, Iowa.

Therefore, Be It Resolved by the House of Representatives of the Forty-fifth General Assembly, That in the passing of the Honorable Thomas J. Wilson the state has lost an honored and valuable citizen, a man of high ideals in Christian living and useful citizenship.
