COUNTY ATTORNEY GILLILLAND DIES

County Attorney Gilliland passed away at his home in this city Tuesday afternoon while sitting in his rocker. He had been in declining health for some months and in the past few weeks had failed rapidly. He was 72 years old and a member of a prominent pioneer family of this county and had rendered distinguished public service throughout his life. He had served in both the House and Senate of the Iowa legislature and was for some time a member of the state board of regents of the Iowa State University. He was at present county attorney and throughout his entire life was an ardent and active republican.

He is survived by his wife one daughter, Mrs. J. J. Keegan of Omaha and one son Whitney of Milwaukee, Wis. Funeral services are being held this Thursday afternoon from the Congregational church and burial will be made in the Glenwood cemetery.
