### HONORABLE FRED W. JONES

MR. SPEAKER: Your committee, appointed to prepare suitable resolutions commemorating the life, character and public services of the Honorable Fred W. Jones, a former member of the General Assembly of Iowa, begs leave to submit the following:

Fred W. Jones was born in Mitchell, Mitchell county, Iowa, on January 10, 1868, and passed away at Spirit Lake, Iowa, on June 13, 1937, at the age of 69 years.

He came to Dickinson county with his parents and assisted his father on the farm in Milford township until he purchased a farm of his own adjoining the old home. He was married to Miss Cora Miller, of Bentley Creek, Pennsylvania, on December 12, 1893, and to this union two children were born: Lewis W. Jones, of Spirit Lake, and Beulah, now Mrs. Glen Rodger, of Maywood, Illinois.

Fred W. Jones served his township as assessor for six years and was elected sheriff in 1899, his administration of this office was so successful that he was re-elected five times, serving thirteen years. In 1913 he was elected to the state legislature, serving from 1913 to 1916. For years he served as director of the First National Bank of Spirit Lake, Iowa. He served as a member of the board of supervisors for twelve years. During all his life he was actively engaged in farming and cattle feeding.

Fred W. Jones was made a Master Mason in Gloaming Lodge, Milford, Iowa, in 1891, and at the time of his death held membership in Twilight Lodge at Spirit Lake, Iowa. He was also a member of Spirit Lake Chapter of Royal Arch Masons and of Twilight Chapter, O. E. S.

Therefore, Be It Resolved by the House of Representatives of the Fortyeighth General Assembly, That in the passing of the Honorable Fred W. Jones, the state has lost a valuable and honored citizen, and the House would tender by this resolution, its sincere sympathy to the surviving members of his family in their sorrow, and

Albert W. Kendall was born in Clinton county, Iowa, on May 3, 1857. He resided there with his parents.

He was married January 25, 1882, to Miss Anna Margaret Kehn. They established their home on a farm which they purchased near Delmar in Clinton county. They retired to Maquoketa in Jackson county in 1917, where he resided until his death. Mr. Kendall died in his eighty-first year, on Friday, March 31, 1939, after a brief illness. He leaves to mourn besides his wife, ten children, Howard, Mrs. Ben Jacobsen, Bert, Olive, Alfred, Ernest, Floyd, Mrs. A. L. Pool, Mrs. T. P. Cassin, and Mrs. Sylvia Witzke. Mr. Kendall was well informed on farm problems and a keen business man and until lately maintained his interest in community and political affairs. He was a member of the First Methodist Church.

### HONORABLE D. W. KIMBERLY

The hearts of the citizens of Iowa were saddened when they learned on November 11, 1937, of the death of Senator D. W. Kimberly. Despite the fact that it was generally known that Dee was ill, his friends and acquaintances were unprepared for the sad news of his death.

Senator Kimberly was born at Deadwood, South Dakota, on August 6, 1878. At the age of six his parents moved to West Liberty, Iowa, where he spent the early years of his life on a farm, before moving to Davenport. He graduated from the Springdale high school and Bryant and Stratton Business College in Chicago. His marriage to Elsie King took place on August 7, 1905.

Senator Kimberly was first elected to the legislature as Republican representative from Scott county in the year 1914, and he held the record for the longest continuous service of any member of the Iowa legislature, having been elected to the Iowa Senate in 1918, and serving in that capacity at the time of his death. However, the length of service was not as important as the fact that his record merited for him the honor and

#### PAUL EUGENE KEMPTER

Born March 18, 1910 in Bellevue, Iowa to Blandina (Kegler) and Paul Kempter, Paul Eugene was the couple's only child. He grew up in Bellevue and was educated by that city's public school system. His parents owned and managed the Kempter-Gallagher Furniture Store and the Kempter-Gallagher (now Kingery-Gallagher) Funeral Home in Bellevue. Although Paul helped with both businesses while growing up, he did not choose to follow in his parents' footsteps. In 1927 Paul entered Notre Dame School of Law in South Bend, Indiana and graduated in June 1934.

While a sophomore, Paul met Edna Loraine While a sophomore, Paul met Edna Loraine Schuster. She was a student at St. Mary's College, also in South Bend, and was an education major from Joliet, Illinois. She graduated in 1931, returned to Joliet, and taught freshman English until Paul's graduation from law school. They were married in the log chapel on the Notre Dame campus on August 11, 1934. Paul began his law practice with the Internal Revenue Service in Des Moines but left after a year and a half to join the practice of a law firm

year and a half to join the practice of a law firm in Clinton, Iowa. He moved to Bellevue and started his own law practice there in 1939.

At the onset of World War II, Paul enlisted in

At the onset of World War II, Paul enlisted in the Army and completed Officers Candidate School. He served overseas with the military police in England, France, and Germany. His knowledge of French and German were valuable both in procurement of housing and in the initial questioning of prisoners brought back from the front by supply convoys.

Paul returned to the states in 1946 and once

again began his practice in Bellevue. The couple adopted two daughters, Mary Patricia in 1948 and Mary Jeanne in 1950.

The Korean conflict once again saw Paul cal-led to active duty and in 1951 the family moved to Michigan where Paul was attached to the newly formed Air Force base near Oskota. The summer of 1952 saw the family transferred to Fair-banks, Alaska and a fighter-jet base newly built there. Paul mustered out of the service in 1952 in Seattle, Washington.

No longer enjoying travel by himself, ill health, and a desire to escape Iowa winters saw Paul move to Ottawa, Kansas in 1985. There he met and, on April 24, 1987, married Maria Wil-

Paul died July 22, 1988 at the University of Kansas Hospitals, Kansas City, Missouri at the age of 78. David Robert Kendell was born April 5, 1919 in Piqua, Ohio, the son of Herbert Weaver Kendell, M.D. (1876-1947) and Llora Worley Kendell (1878-1971). Dr. Kendell (Ohio Medical University) practiced as a most respected physician of the control of cian and surgeon, having his own hospital, in Covington, Miami County, Ohio. Llora, a former Latin and music teacher (graduate of Earlham College), was a busy and compassionate mother of nine children.
