REMAINS OF JOHN F. WADE ARE LAID AT REST

Impressive Services at St. Patrick's Church at Dougherty Marks the Last Rites Over the Beloved Late State Official.

Services befitting the splendid character of the man were held with marked pomp and solemnity at the Catholic church in Dougherty at 10 o'clock this morning when a solemn Requiem Mass was said preceding the burial of the late John F. Wade. From every corner of the state friends of the deceased were in attendance. More than a hundred from Mason City were present, a special train on the Northwestern carrying a large number. The assemblage filled the capacious St. Patrick's edifice and many stood in the aisles and at the entrance. Preceding the service of the mass, offices of the dead were chanted by the attending clergy, a proceeding unusual and beautiful. The solemn Requiem Mass was said by the Reverend Father E. J. Dougherty, assisted by Fathers Mulvaney and Fitzpatrick. The officers of the mass being the Most Reverend Archbishop J. J. Keane, assisted by Fathers Rohlman and Drumm with Rev. Father Reiley master of ceremonies.

The Archbishop presided at absolution and delivered a beautiful sermon which was listened to most closely by every auditor. A short service at the grave in the picturesque church yard preceded the interment. Visiting clergy who assisted at the services were the Most Reverend J. J. Keane, Very Reverend D. M. HOPE IS STILL BUOYANT-THAW

Fugitive-Inmate of New York Asylum Enjoyed Reading Newspapers at Breakfast Table.

Concord, N. H., Sept. 18.—Hope is again buoying the fluctuating fortunes of Harry K. Thaw, the fugitive from the New York asylum for the insane. He got sundry crumbs of comfort from a great pile of New York papers which were stacked in front of him at his breakfast table this morning, and he was gleaming the news voraciously, mainly the Washington dispatches.
May Be Long Case.
These dispatches were saying that if Thaw's case went to the United States supreme court years might roll by before a decision would be handed down. Thaw is hopeful that Governor Felker will decide the extradition at once so it will not be necessary to press the habeas corpus writ in the federal courts.
Thaw's lawyers are unable to find a case where a person of Thaw's position was ever extradited.

POLICE NEWS.

LIVING GOING UP? WE'LL LOOK AT THE OFFICIAL REPORTS

Bacon Has Gone Up 128.5 Per Cent as Compared With Ten Year Period Which Ended in 1899—Other Increases.

PRICES HIGHEST EVER IN IOWA.

Government Figures Show That Meal on June 15 Was Most Expensive in Thirty-Three Years.

The meals you ate on June 15, 1913, cost you more than any meal you have eaten in twenty-three years.

According to statistics of the United States department of labor, the cost of fifteen staple articles on that day was higher than it has been with but one exception, in twenty-three years. That one exception was on November 15, 1912.

Retail prices on June 15th were 59.2 per cent higher than they were during the ten-year period from 1890 to 1899, 3.3 per cent above the price on June 15, 1912, and 14.4 per cent above the price on June 15, 1911.

Sugar is the only staple that has declined in price since 1890. Bacon is 128.5 per cent higher than it was in the ten years from 1890 to 1899.

Advance in a Year.

The following is the text of the report: "Comparing retail prices on June 15, 1913, with prices on the same date in 1911, eleven of the fifteen articles for which quotations are given advanced and four declined in price. Bacon advanced 16.2 per cent, smoked ham advanced 14.1 per cent, pork chops advanced 13.4 per cent, hens advanced 11.8 per cent, eggs advanced 11.7 per cent, round steak advanced 10.1 per cent, sirloin steak advanced 9.8 per cent, lard advanced 7.2 per cent, rib roast advanced 6.8 per cent, butter advanced 5.8 per cent, and milk advanced 4.1 per cent. Potatoes declined 31.9 per cent, sugar declined 15.2 per cent, wheat flour declined 7.7 per cent and cornmeal declined 3.8 per cent."

SEN. JOHN F. WADE DIES SUDDENLY AT DES MOINES HOME

Deceased Was Chairman of the State Board of Control and Had Long Been Prominent in Democratic Political Circles.

DEATH CAME AFTER ILLNESS OF FEW HOURS.

Was at Office Yesterday Complaining of Lumbago But Did Not Appear to Be Suffering From Serious Illness.

Funeral services for the late Senator Wade will be held in the Catholic church at Dougherty, Ia., Thursday morning. The remains were taken to Dougherty this afternoon. They were in charge of Judge M. J. Wade, brother of the deceased, who by chance arrived in Des Moines early last evening to attend supreme court. On Thursday morning a special train will be run from Mason City to Dougherty so that connections may be made from Des Moines and surrounding towns.

John F. Wade, chairman of the state board of control and former state senator from Butler county, died at his home, 1514 Harrison avenue, at 4 o'clock this morning at the age of 54 years.

LONDON, Sept. 16.—A workman this morning found on a sidewalk practically the entire pearl necklace, valued at \$20,000, which was stolen on July 15th while in transit by mail from Paris to London. The man was going to work in Highgate, a northern district of London, when he noticed the pearls lying in a heap. On picking them up he found there were fifty-eight. He took them to the nearest police station, where they were at once recognized as part of the famous necklace from which only one pearl is now missing.

On September 21 five men—three Englishmen and two Austrians—were arrested when trying to dispose of some of the pearls in London. They are believed by the police to belong to a notorious international gang of thieves.

A reward of \$50,000, which was offered for the return of the jewels, will probably go to the workman.

The necklace, said to be the most valuable in the world, was in transit between two dealers when stolen. Rumor indicated that it was destined for Mrs. W. K. Vanderbilt.

Bacon advanced 124.5 per cent, pork chops advanced 111 per cent, round steak advanced 102.5 per cent, smoked ham advanced 84 per cent, hens advanced 76.8 per cent, sirloin steak advanced 75.2 per cent, rib roast advanced 75 per cent, lard advanced 66.5 per cent, cornmeal advanced 57.3 per cent, potatoes advanced 44.4 per cent, butter advanced 41.3 per cent, eggs advanced 40.8 per cent, milk advanced 38.4 per cent and flour advanced 29.6 per cent. Sugar declined 8 per cent.

Retail Prices High.

"When the price of each of the fifteen articles of food is weighted according to average consumption in workingmen's families, retail prices were at a higher level on June 15, 1913, than at any other time during the last twenty-three and one-half years, excepting on November 15, 1912, when the level was slightly above that of June, 1913. Retail prices of food on June 15, 1913, were 59.2 per cent above the average price for the ten-year period 1890 to 1899, 3.3 per cent above the price on June 15, 1912, and 14.4 per cent above the price on June 15, 1911.

SENATOR JOHN F. WADE.

Death was due to a stroke of apoplexy. He was taken ill at 10 o'clock last night. Senator Wade was at his office in the state house all day yesterday. He has used a cane for two or three days, due to an attack of lumbago. When he arrived home last evening from the office members of the family said that he complained of a pain in his head, but aside from that there was no intimation of a serious illness.

Senator Wade is survived by a widow and seven children. Clement Wade is a practicing attorney at Iowa City. The other children all live in Des Moines. They are Grace, Nell, Martin, Hugh, Kathryn and Beatrice Wade. He was a brother of Judge Martin J. Wade of Iowa City.

Only a temporary residence has been maintained by the Wades on Harrison avenue. Senator Wade has always maintained his legal residence at Aredale, Iowa. He has been a member of the board of control of state institutions for four years and had two years yet to serve. He was made chairman at the resignation of Judge Gifford S. Robinson a short time ago.

Prominent as Democrat.

Senator Wade was a democrat in politics. He served as a member of the board of supervisors in Butler county for many years. He was elected senator from the Thirty-ninth senatorial district and served in the Thirty-first, Thirty-second, and a special session of the Thirty-second general assemblies. He was the only democrat elected from that district for many years.

He was appointed a member of the board of control by Governor Carroll October 1, 1909, to fill a vacancy caused by the resignation of John T. Hamilton.

John F. Wade was born in Burlington Vt., April 7, 1859. He removed with his parents to Iowa at an early age and in 1871 with his parents settled upon a farm in Butler county. On March 3, 1886, he was married to Mary Dougherty, daughter of Daniel Dougherty, a pioneer settler of Cerro Gordo county. Nine children were born, seven of them surviving. He was engaged in lumber, coal and farm machinery business for several years as a member of the firm of Wade, Leydig & Company in Dougherty, Iowa.

SENATOR WADE DIES SUDDENLY AT HOME HERE

Senator John F. Wade, of Aredale, chairman of the board of control of state institutions, died unexpectedly at his home, 1514 Harrison avenue, at 4 o'clock this morning. A stroke of paralysis at 9 o'clock last night caused death.

Illness prevented Senator Wade from attending to his duties at the state house Saturday, but he was on hand yesterday. He complained of lumbago and had suffered considerably from it in the last few weeks.

Forest S. Treat, secretary to the board, took Senator Wade home afterward in a motor car. The secretary advised Senator Wade to remain at home until his condition improved. "I'll call for you in the morning," Mr. Treat said when he left.

Brother Was With Him.

The secretary did call early this morning only to learn that Mr. Wade was dead.

W. J. Dixon and A. M. McColl, board members, knew that their chairman was not in the best of health, but his sudden death was a surprise to them.

The death of Senator Wade was a shock to his family and those with whom he was associated. Mrs. Wade returned yesterday afternoon from a visit with her relatives at Dougherty. She was dangerously ill for several months last summer and winter, but it is thought she is strong enough to withstand the strain.

Judge Martin J. Wade of Iowa City, a brother, arrived in the city last night. He came to attend to business before the supreme court. He was called to his brother's home shortly after 10 o'clock.

A sister, Mrs. P. J. Carr, lives at Dougherty, where the body was taken this afternoon, and where funeral services will be held Thursday morning.

Senator Wade is the third of a family of five children to die in a little more than a year. Mrs. T. J. Fitzpatrick of Dubuque, a sister, died suddenly on a train in Washington on July 3, 1912. William Wade of Dougherty, a brother, died last April.

Seven Children Survive.

Seven children survive Senator Wade. They are:—C. F., who last year was graduated from the state university law school and now is connected with the firm of Wade, Dutcher & Davis of Iowa City; Grace and Nelle, students at Highland Park college, and Hugh, Martin, Katherine and John.

Members of the board and some of the office force will go to Dougherty for the funeral services Tuesday morning.

Senator Wade was one of the prominent democrats of the state. He was appointed a member of the board of control Oct. 1, 1909. He succeeded John T.



Two extra "deputies" are to be added to the force of Sheriff John Griffin on Oct. 1, according to an announcement he made this morning. He has arranged to secure the services of two valuable bloodhounds owned by F. M. Shores of Waterloo. The animals will be used by the sheriff primarily to stop the operations of horse thieves in this vicinity, although they will be pressed into service in searching for other criminals, if necessary.

Senator Wade was one of the prominent democrats of the state. He was appointed a member of the board of control Oct. 1, 1909. He succeeded John T. Hamilton, who resigned.

Before he became a member of the board of control Senator Wade represented the Butler-Bremer district in the state senate. He served in that capacity for six years. He was a member of the Butler county board of supervisors for several years. He held township offices before that.

At the age of 11 years Senator Wade came to Iowa with his parents in 1870. They settled on a farm in Butler county.

He engaged in farming, stock raising and the lumber business. At the time of his death he owned a large farm and looked after the management of it.

Senator Wade and his family moved to Des Moines from Aredale last spring. He found it inconvenient to work here and have his family at another place.

Complete Change in Board.

Within less than five months the entire membership of the board of control will have changed. On May 1 W. J. Dixon of Sac City succeeded Dr. Murdoch Bannister of Ottumwa, who resigned. On July 1 Senator Anthoy M. McCall of Woodward succeeded Judge G. S. Robinson of Sioux City.

It will be the duty of the governor to name a successor to Senator Wade. He must be a democrat as the board is a nonpolitical body. In all probability a successor will be selected at once as the work of the board is heavy.

FUNERAL SERVICES FOR SENATOR WADE

Body Taken to Dougherty After Brief Obsequies in Des Moines.

DEATH IS UNEXPECTED

Ill for Some Time, but Per- formed Regular Work Monday.

Brief funeral services for the late Senator John F. Wade, chairman of the state board of control, who died suddenly yesterday morning, were held at the home, 4514 Harrison avenue, early in the afternoon. The body then was shipped to Dougherty, Ia., where the regular services will be held Thursday morning. W. J. Dixon and Senator A. M. McCall, members of the board, and Forrest Treat, secretary, will go to Dougherty this afternoon to be present at the funeral.

The death of Senator Wade was unexpected. However, he had been ill for some time. During the last week he had suffered much from lumbago. He did his regular work on Monday, but had

been forced to remain at home on Saturday.

Taken Home Monday.

The chairman was taken home by Mr. Treat Monday evening. Mr. Treat said he did not think Mr. Wade ought to ride in a street car.

Mrs. Wade had been visiting with relatives, but returned Monday evening. Judge Martin J. Wade of Iowa City, a brother, chanced to be here to appear before the supreme court.

Seven children survive Mr. Wade. Clement Wade is a practicing attorney at Iowa City and is employed by his uncle's firm. The others live at home and are Grace, Nelle, Kathrine, Beatrice, Martin and Hugh.

Mrs. J. P. Carr of Dougherty is a sister. A brother, William Wade, died in April and a sister, Mrs. T. J. Fitzpatrick, died suddenly on a train in Washington in July a year ago.

Early Appointment Expected.

Mr. Wade was appointed to the board of control Oct. 1, 1909. He succeeded John T. Hamilton, who resigned. He was chairman of the board this year for the first time.

For six years Mr. Wade served the Butler-Bremer district in the senate. He was a member of the Butler county board of supervisors for a number of years.

It will be the duty of Governor Clarke to appoint a successor to Senator Wade. He must be a democrat and from neither the Seventh nor Eleventh congressional districts and but one member may live in a congressional district.

Mr. Dixon and Senator McCall expect the governor to make the appointment at once. Much important work is before them and they want a full board to take care of it.

The governor was not in Des Moines yesterday. He attended a picnic at Lamoni.

HON. JOHN F. WADE SUMMONED BY DEATH

STROKE OF APOPLEXY ENDS A BUSY LIFE.

Had Been Ill Several Days But Was
Able To Go To Office.

A telephone call from Des Moines Tuesday forenoon conveyed the startling news of the sudden death of Hon. John F. Wade in that city. It was so unexpected that many refused to believe it at first, but it proved only too true to his large circle of friends and acquaintances.

Though Mr. Wade had not been in perfect health for years owing to asthma and lung affections the thought of paralysis was fartherest from the minds of those near to him.

The Des Moines papers state that Senator John F. Wade, chairman of the Board of Control of state institutions, died unexpectedly at his home on Harrison avenue at four o'clock Tuesday morning, a stroke of paralysis at nine o'clock Monday night causing his death. The account states there were two strokes, Mr. Wade lapsing into unconsciousness following the second attack from which he never rallied.

Illness prevented Senator Wade from attending to his duties at the state house on Saturday, but he was on hand Monday, characteristic of his energy. He complained of lumbago from which he had suffered considerably in the last few weeks.

Mr. Treat, secretary of the board, took Mr. Wade home in a motor car, and advised him to remain at home until his condition improved. W. J. Dixon and A. M. McColl, board members, knew that their chairman was not in the best of health, but his sudden death was a surprise to them.

The death of Senator Wade was a shock to his family and those with whom he was associated. Luckily Mrs. Wade had just returned from a visit at Dougherty and was with her husband during his last hours. She was dangerously ill for several months last year but it is thought she is strong enough to withstand the strain. Their oldest son, Clem, was called from Iowa City and arrived only a few minutes before his father passed away. The other six children, Martin J. Jr., Hugh, Grace, Nellie, Catherine and Beatrice, were at the bedside of their father, Judge M. J. Wade, brother, happened to be in the city attending court and was summoned before death. Mrs. P. J.

ANOTHER CROSSING ACCIDENT NEAR PARKERSBURG.

A Saturdays special from Parkersburg says: This community was greatly shocked yesterday afternoon when word was received at 4:30 that Miss Clarice Savage and George Pendleton had been killed by a North-western train. The accident occurred at the same crossing where Lew Gerhardt met his death about six weeks ago.

Miss Savage was teaching the Sinclair school, and it was her custom to come home on the five o'clock train, but as Mr. Pendleton had been working on the road near her school house, she had for a day or two been riding to and from her school with him.

The train was an extra and they were probably not on the watch. The crossing is somewhat obscure at this place and is considered a dangerous one. A young man by the name of Wells, who was riding in the back of the wagon, saved himself by jumping and escaped with only a sprained ankle. Death must have been instantaneous for the two.

Miss Savage had made Parkersburg her home nearly all her life. She was for several years a clerk in the post office and her obliging and pleasant ways made all the patrons of the office her friends. She was a girl of exemplary character, and had the respect and friendship of all who knew her. Her immediate surviving relatives are her mother, Mrs. Estell Savage, and one sister, Mrs. Maurie Kemmerer of Pryor, Okla.

Mr. Pendleton had made his home here only for a few years past, but those who knew him speak of him as a man worthy of respect and a good citizen. He is survived by his wife and a small child.

The remains were brought to Fox undertaking parlors, where the inquest was held.

The team of mules driven by Pendleton were killed.

The freight train struck the wagon near the front wheels. The mules were carried a distance of two hundred feet. The bodies of both Miss Savage and Mr. Pendleton were maimed and mangled. Pendleton was thrown fifty feet. Miss Savage's body was so badly mangled that it was almost impossible to identify her after the accident. Her remains were found on the cattle guard at the side of the crossing. Her watch and the buttons from her coat were picked up some distance away.

A brakeman, who witnessed the accident, says the train was running at moderate speed, and that the engineer sounded the crossing whistle. It appeared to the brakeman that Miss Savage and Mr. Pendleton did not notice the warning, being engaged in conversation.

John F. Wade was born in Burlington, Vermont, April 7, 1859. Removed with his parents to Iowa at an early age and in 1871, with his parents settled upon a farm in Butler county. Married March 3d., 1886 to Mary Dougherty, daughter of Hon. Daniel Dougherty, a pioneer settler of Cerro Gordo County. Nine children were born, seven now living.

Mr. Wade engaged in farming extensively and was one of the leading farmers and stock raisers of Bennezzette township for years. Was always recognized by his neighbors as a good business man and from his early years was a leader in all movements in his community. Mr. Wade was a democrat in politics and regardless of the fact that Butler county was strongly republican he was elected member of the board of supervisors which position he held for six years and where he gained state prominence. Was elected Senator from the 39th senatorial district composed of Butler and Bremer counties. Served in Thirtieth, Thirty-first, Thirty-second and special session Thirty-second General Assemblies. He was appointed member of the Board of Control by Gov. Carroll. Oct. 1st, 1909, to fill vacancy caused by the resignation of John T. Hamilton. Mr. Wade retained his residence in Butler county but had moved his family temporarily to Des Moines that he might more conveniently perform his duties.

The remains were taken to Dougherty where on tomorrow, Thursday morning the funeral will take place and interment made by the side of the loved ones gone before.

It is a painful duty of the Recorder today to chronicle the passing of this good man who was ever a sincere friend. A man through his thrift and energy had made a name for himself and family that will occupy a prominent place in the history of Iowa. Conscientious and energetic he died at his post of duty like a brave soldier. Not only Butler county but the great state of Iowa mourns his passing at the noon-day of life. To his most estimable family do we join this community in extending deepest sympathy.

**PROMINENT IOWAN
DIES SUDDENLY**

**John F. Wade, Chairman of The
State Board of Control Suc-
cumbs to an Attack of Apoplexy
At Des Moines Yesterday**

Des Moines, Ia., Sept. 16.—John
F. Wade, chairman of the Board of
Control of State Institutions, and brother
of Martin J. Wade, Democratic
national committeeman for Iowa, died
here early this morning from apoplexy.
Mr. Wade was born at Burlington,
Vermont, April 7, 1859, and removed
with his parents to Iowa at an early
age. In 1871 the family settled upon
a farm in Butler county. He was mar-
ried to Mary Dougherty, daughter of
Honorable Daniel Dougherty, March
3, 1886, and nine children have been
born to them, seven of whom are liv-
ing.

Mr. Wade was engaged in farm-
ing until assuming duties as a mem-
ber of the board of control; also en-
gaged extensively in buying and feed-
ing, and shipping cattle and hogs.
He was also engaged in the lumber,
coal and farm machinery business for
several years as a member of the firm
of Wade, Leydig & Company in
Dougherty, Ia., but continued to
reside upon his farm and give it his
personal attention. He has always
been a democrat in politics and has
taken a great interest in furthering
the doctrines of democracy. He held
township offices; was elected a mem-
ber of the board of supervisors of
Butler county in 1896, was re-elected
and continued to serve for six years.
Elected senator from the thirty-
ninth senatorial district, composed
of Butler and Bramer counties. Served
in the thirtieth, thirty-first,
thirty-second and special session of
the thirty-second general assemblies.
He was the only democrat elected from
that district for many years.

Deceased was appointed a member
of the board of control by Governor
Carroll October 1, 1909, to fill the va-
cancy caused by the resignation of
Hon. John T. Hamilton. He retained
his residence in Butler county, but
had removed his family temporarily
to Des Moines that he might more
conveniently perform his duties upon
the board.

The body will be taken to Doughter-
ty where interment will be made.

A QUIET WORKER.

With the passing of Senator John F. Wade, there leaves us one of those quiet, conscientious workers of whom the state of Iowa is so proud. Senator Wade never did anything to have his name appear in red ink; no act of his was ever a sensation. It was uncommon to see his picture in the newspapers. But he was one of those dependable workers—a man who went at his work, first laying it out, and then completing it; if the work took but a few hours to complete, well and good, if it took all day and all night, a week, a month, or a year, well and good, it was always done. And when he had done with it, it was finished.

There was no more conscientious worker in the state of Iowa, a state known for that kind of workers. His chair was never vacant when there was work to do, whether he was running a mercantile business in the small town, whether he was transacting business in a legislative capacity, whether he was doing state service on the board of control—and when the crops or the harvest, or the stock on his farm, needed attention, he was there to see that it was done right, or do it himself.

John F. Wade had honors galore among his neighbors; he had honors among the people of the state. The job never suffered. He was at it, day and night. Careful, honest, in- dustrious, every task he took up re- ceived his undivided attention until it was completed. Not as some men would complete it, but according to the best efforts and the wide knowl- edge of Mr. Wade. Not only was his a careful business mind, but it con- tained a strong sentimental side—that is, a streak of human nature found in only the best manhood. His was a deserving sympathy. Being practical, he had no use for sham, or for hypoc- risy; he was able with his keen knowl- edge of affairs and his careful eye to separate the chaff from the wheat, the good from the bad, and once hav- ing reached conclusion, he was adamant.

The board of control was just the place for Mr. Wade. He had just the training, business and executive, that serves well on such a job. No item was too small for him to give his per- sonal attention; and nothing too large for his mind.

The state of Iowa feels a loss in the passing of Senator Wade, a man who loved his neighbors as they loved him and who worked to accomplish.



John E. Downing is a native of Ireland, born June 22, 1837. When quite young his father died. In 1849 he came to America with his mother. They landed at Boston, and went to Fall River, where he was employed in the Globe Print Works until 1856, when he went to Michigan, and engaged in the copper mines. He was married there, in 1859, to Catherine Moroney. In 1861 they came to Iowa, and lived in Middlefield, Buchanan county, until 1867, when he bought land in the township of Bennezzette, Butler county, on section 26. He soon improved the land, and built his present home. He is the present secretary of the Board of Education, which office he has held since 1877. He has ten children—Patrick J., Josie, Mary A., Ellen A., Michael, John, Theresa, Bridget, William Henry, and Cecelia A.

Adam Kyle was born at Hessian, now a part of Germany, October 1, 1820. His father died when he was but two years old. When nine years of age he came to America, with his mother. They settled in Pennsylvania. In 1842 he settled in Jo Daviess county, Illinois: one of the early settlers. He there bought mining property, and engaged in mining until 1849, when he started for California, crossing the plains with three teams, in company with eight others; taking their camping utensils with them and camping out on the way. They were one hundred and forty days making the trip. They located at Hantown, now called Placerville, and engaged in mining until 1854. He then went to San Francisco, taking a steamer for home. He crossed the Isthmus, went up the Mississippi river to Rock Island, and there hired a buggy to take him to Jo

Daviess county. He soon after started for Wisconsin, where he settled in Grant county, buying a farm one and one-half miles from Lancaster, where he lived until 1870, when he sold it and came to Butler county, Iowa, buying his present farm, on section 16, township of Bennezzette, where he now lives. He married, February 22, 1856, Theresa Foak. They have ten children—Maggie and Elizabeth, the oldest, are twins; John, Herman, Veronica, Catherine, Adam, Francis, Joseph, and Theresa. Mr. Kyle's mother is still living with him, in her eighty-seventh year.

Gawn S. Killen, native of Ireland, born in County Down, April 4, 1832. His father was a mason by trade, and he learned that trade when quite young. In 1848 he left his native land for America, landed at New York; went to Batavia, and there worked [at his trade, also worked at farming. In 1868 he came to Iowa, and was employed as mason on the Insane Asylum at Independence, three years. He then came to Bennezzette, Butler county, and bought a farm on section 1, which he has improved, and built his present home. He married in October, 1858, Miss Jane Livingston. They have three children—John, Robert and James.

Michael Wade was born in Kilkenny, Ireland, in 1831. In 1851 he left his native land for America; landing at New York he went to Kingston, where he engaged in a stone quarry for one year, getting out flag stones; he then went to Charleston, South Carolina, where he stayed seven months; from there he went to Oxford, Massachusetts, working in a woolen mill six months; then returned to Charleston, South Carolina, where he was

engaged with the United States Coast Survey, remaining with them eleven years. He then went to Winooski Falls, Vermont, where he was employed in a woolen mill. In 1863 he came to Iowa, and engaged in railroading in Dubuque county until 1868, when he removed to Charles City, remaining in the same business. In 1871 he came to Bennezzette, and bought land on section 7, there building his present home. He married in 1858 Miss Mary Breen. They have eight children—John F., Martin E., Catherine, Mary E., William, Margaret and Agnes.

Joseph H. Brownell was born in Erie county, Pennsylvania, February 26, 1834. In 1856 he moved to Winnebago county, Illinois. In 1857 he moved to Iowa, buying land in Black Hawk county. In 1863 he removed to California, where he engaged in freighting and farming for two years, when he returned to farming in Illinois. In 1872 he came to Iowa, buying a farm in Bennezzette on section 24, where he built his present home. He married December 2, 1858, Miss Mary Collier, a native of Illinois. They have four children—Florence L., J. Clarence, George W. and Ernestine E.

Franklin Pierce Kent was born in Essex county, New Jersey, September 10, 1852. In 1860 his parents moved to Floyd county, Iowa. In 1863 they moved to Charles City, where he attended school. In 1873 he came to Bennezzette, Butler county, settling on his present home on section 8. He married in 1878, Miss Addie Frisbie; they have three children—Vera E., James F. and Annie D.

John Tindal was born in Sandusky county, Ohio, February 3, 1847. His father, who was a farmer, was one of the

first settlers of Tama county, Iowa, moving there in 1852. Here John received his education. In 1876 he came to Bennezzette township, Butler county, buying his present farm, on section 16. He was married in 1870, to Miss Margaret Crouse. They have three children—Aggie, John H., and Edwin.

L. L. Mayberry is a native of New Jersey; born in Warren county, May 23, 1834. In 1840 his parents moved to Oakland county, Michigan. In 1847 they moved to Ogle county, Illinois, among the earliest settlers of that county. L. L.'s younger days were spent on the farm. He was married in 1865, to Miss Mary, daughter of Robert Light, Esq., of Ogle county, Illinois. They have four children—William W., Robert R., Margaret E., and James L. March 17, 1877, Mr. Mayberry came to Bennezzette township, Iowa, and bought his present farm, on section 31.

Albert Meyer was born in Germany, in August, 1843, where his occupation was farming. In 1866 he emigrated to America. Landing at New York, he started immediately for St. Paul, Minnesota, where he was employed in a packing-house eight years. He then engaged in draying four years. In 1878 he came to Bennezzette township, Butler county, Iowa, and bought his present farm, on section 21. He was married in 1864, to Miss Caroline Kath. They have two children—Bertha A., and Helena H.

Jacob, son of Elder Philip Moss, was born in Indiana, February 2, 1845. In the fall of 1855 his parents moved to Coldwater, Iowa, where he attended school; later devoted his time to agricultural pursuits. In 1876 he bought a farm in Bennezzette

In 1869, Mr. Allen was chosen by the people of the county of Polk to a seat in this body. In the Thirteenth General Assembly he was chairman of the committee on the Suppression of Intemperance, and in the Fourteenth of that on Banks. His work here is largely reflected in the stately edifice in which this body sits.

In the year 1873, Mr. Allen removed to Chicago, where he undertook to save from ruin the Cook County National Bank. The effort proved too much for him, the great crash of that year coming on soon after he went to the great city. Then the man's princely fortune disappeared, and the successful and popular capitalist saw his vast wealth vanish.

Mr. Allen soon afterwards removed to California, where the man of benevolence when possessed of abundant means spent the last years of a life which in its prime was a highly useful one.

Mr. Allen was, on the 31st day of January, 1854, united in marriage with Miss Thusa West. The fifteenth anniversary of that event, observed as it was in the palatial home he had just erected, was a memorable event of the time. Mrs. Allen and their younger daughter long years ago preceded husband and father to the life beyond. Three children remain: Mrs. Swords of New York city, and Messrs. Frank and Harry of California.

In memory of this man so potently helpful in his day of opulence and so useful a man and a legislator, be it

Senator Hagemann from a special committee submitted the following report and moved its adoption:

MR. PRESIDENT—Your committee appointed to prepare resolutions commemorating the life, character and public services of John F. Wade beg leave to submit the following report:

JOHN F. WADE.

John F. Wade was born at Burlington, Vermont, April 7, 1859. He moved with his parents to Iowa in the year of 1873, and settled with his parents upon a farm in Bennezette township, Butler county, Iowa. Being the oldest son of a family of seven, he was obliged to forego to a large extent even the meager educational advantages from the country school. He was married April 3, 1886, to Mary Dougherty, daughter of the Hon. Daniel Dougherty, a pioneer settler of Cerro Gordo county. Nine children were born, seven of whom are now living. He engaged in farming upon a farm within a mile of his father's homestead and was especially interested and engaged in the feeding and shipping of cattle and hogs. He was also, for several years, a partner in the firm

of Wade, Ledyig & Co., at Dougherty, Iowa, which firm was engaged in retailing lumber, coal, farm machinery, etc., but always until about two years before his death, maintained his residence upon the old farm.

He has always been a democrat in politics. In a county that is republican by a large majority he held several township offices. In 1896 he was elected a member of the board of supervisors of that county and served as such for two terms. Upon the expiration of his second term, he was elected state senator to represent the Thirty-ninth senatorial district composed of Butler and Bremer counties. He served in the Thirtieth, Thirty-first, Thirty-second and the special session of the Thirty-second General Assemblies.

October 1, 1909, Mr. Wade was appointed member of the board of control by Governor Carrdill to fill a vacancy caused by the resignation of the Hon. John T. Hamilton of Cedar Rapids. At the expiration of that term, he was reappointed, and at the time of his death was chairman of the board. He died September 16, 1913, and was buried in the Catholic cemetery at Dougherty, Iowa, only a few miles from the farm upon which he spent practically his whole life.

Mr. Wade, as a man, was honest and industrious; as a friend, he was loyal, helpful, and sincere; as an official, he was diligent, painstaking, and capable; and as a Christian gentleman, he had the confidence and esteem of all who knew him. In his own immediate circle of friends and neighbors, he was not only most beloved, but most trusted, most honored. For years he was a county or state official. The close of his public career found him clean and honest as he was at the beginning. He held the confidence of the electorate as few men can gain and hold it. Measured by any of the standards of honorable, useful citizenship, he was a man. Be it

Resolved, That in the death of John F. Wade the state has lost a worthy citizen. That it recognizes the high character of his services to the state, and that the Senate takes this occasion to acknowledge its recognition and express its high regard and appreciation of his character and public services, and to extend to his family its sincere sympathy in their bereavement. Be it further

Resolved, That a copy of these resolutions, engrossed and duly authenticated by the President and Secretary of the Senate, be presented to the family of the deceased.


