**Was Once Fairfield Lawyer.**

Henry H. Brighton died in this city Sunday night, at the home of a sister, Mrs. John H. Frush. He returned here from the west September 23d, suffering from a disease of the heart and in a critical condition, and it seemed impossible for him to rally. Mr. Brighton was a son of the late H. M. Brighton. He was born at Tiffin, O., and was fifty-nine years old. The family came to Jefferson county in 1865 and the son grew to manhood here. For several years he was a student at De Pauw university, Greencastle, Ind., and graduated with honors from that institution. He was superintendent of schools at Kentland, Ind., for a considerable period, took up the study of law and later became a student in the law department of the State university at Iowa City. After admission to the bar he returned to this city and about 1882 began the practice of his profession with M. A. McCoid and A. W. Jaques under the firm name of McCoid, Brighton & Jaques. He was elected representative in the Twenty-sixth general assembly of Iowa in 1896 and was re-elected in 1898. In the Twenty-eighth and Twenty-ninth general assemblies he was senator from the Jefferson-Van Buren district. After his retirement from the legislature he was given an appointment under the interior department of the United States government

**Buried at Her Old Home.**

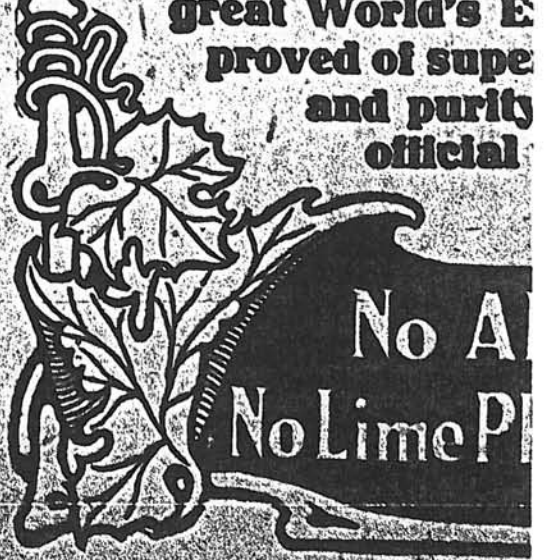
