Heart Attack Fatal to George M. Titus

George M. Titus, 30, president and treasurer of the Titus Loan and Investment Co., and one of Muscatine's best known citizens, died at 3:30 p.m. Wednesday at his home, 310 West Second street, as a result of a heart ailment.

Mr. Titus became suddenly ill at the company offices, 211 Iowa avenue, about 9:30 a.m. Wednesday, and at his home, where he was taken by ambulance, he failed to rally from the heart attack.

A former state senator, Mr. Titus during his long active career in business had always been an active supporter of progress in Muscatine, Iowa, and the mid-west. He was one of the strongest advocates in the Upper Mississippi area of the nine-foot channel which today is handling great quantities of grain, coal, oil and other freight between St. Louis and the Twin Cities.

Native of New York

Born in Cayuga county, New York, May 18, 1856, Mr. Titus was the son of Allen and Mary Jane Rhodes Titus. He lived in Cayuga county until 11 years old when he moved with his parents in 1868 to Shiawassee county, Mich., where he entered the high school of Carrara. Moving to Iowa, he continued his education at the Baptist college at Wilton and in the meantime began teaching school at the age of 13. He followed this profession for seven years in Michigan.

His legal career was launched in 1879 when he began the study of law in the office of A. M. Van Camp in Wilton and further continued his preparation for the bar in Muscatine as a law student in the office of Allen Broomhall until his admission to the bar in 1880.

He began the practice of law in Mr. Broomhall's office and in December, 1882, became associated with DeWitt C. Richman, who resigned as circuit judge prior to entering into the partnership. The legal firm was maintained until February, 1886, when Mr. Titus was joined by D. V. Jackson in forming the firm of Titus and Jackson, an arrangement that continued until Mr. Jackson's election as district judge.

Served as Senator

Mr. Titus was elected state senator from Muscatine and Louisa counties and served in the 27th and 28th general assemblies from 1895 to 1900. He was author of the Titus amendment to the constitution which changed annual elections to biennial elections and was instrumental in securing the passage of a measure prohibiting the manufacture of buttons and tubes in the state penitentiaries. While a member of the senate, he was selected by the state library association to present the library commission bill which was passed by the 28th general assembly. At the time of his death he was president of the board of the P. M. Musser Public Library in Muscatine, a position he had held since the inception of the library board in 1901.

Aside from his contributions to the progress while a member of the senate, Mr. Titus was a moving factor in numerous developments in Muscatine, Iowa and the Upper Mississippi Valley.

He was organizer in 1896 of the company which constructed the North and South railroad through Muscatine and served as first secretary of the company for several years. He also was the organizer and first secretary in 1901 of the company which constructed the Muscatine Mississippi bridge. Mr. Titus was a leading promoter in the construction of the

Lilienthal in the chairman's job he has held since last Jan. 1. Four fellow commissioners and General Manager Carroll Wilson also were confirmed without the formality of roll calls.

Lilienthal's aides said commission operations had been "seriously" handicapped by uncertainty over the legal status of the commission's membership.

Agency's Work Delayed

They added that as the senate argument dropped on over charges that Lilienthal was "soft" in his attitude toward communism the work of the agency suffered progressively.

When the commission took over the military's bomb developing and manufacturing agency on Jan. 1 the estimated value of atomic properties owned by the government was \$1,400,000,000.

While one phase of commission effort deals with harnessing atoms to power production for industry, another continues the research from which today's program originated—the military use of atomic energy.

This falls into two general categories:

(a) Further improvement of the already devastating power of the atomic bomb, together with possible uses of radioactive poison materials created as a by-product of industrial atomic pile plants, and (b) Use of atomic power to propel ships, airplanes and vehicles.

Those confirmed by the senate besides Lilienthal and Wilson are Commissioners Robert F. Bacher, 41-year-old physicist, W. W. Waymire, 55, former editor of the Des Moines Register and Tribune, Sumner T. Pike, 51, former member of the federal securities commission, and L. L. Strauss, 50, a retired rear admiral.

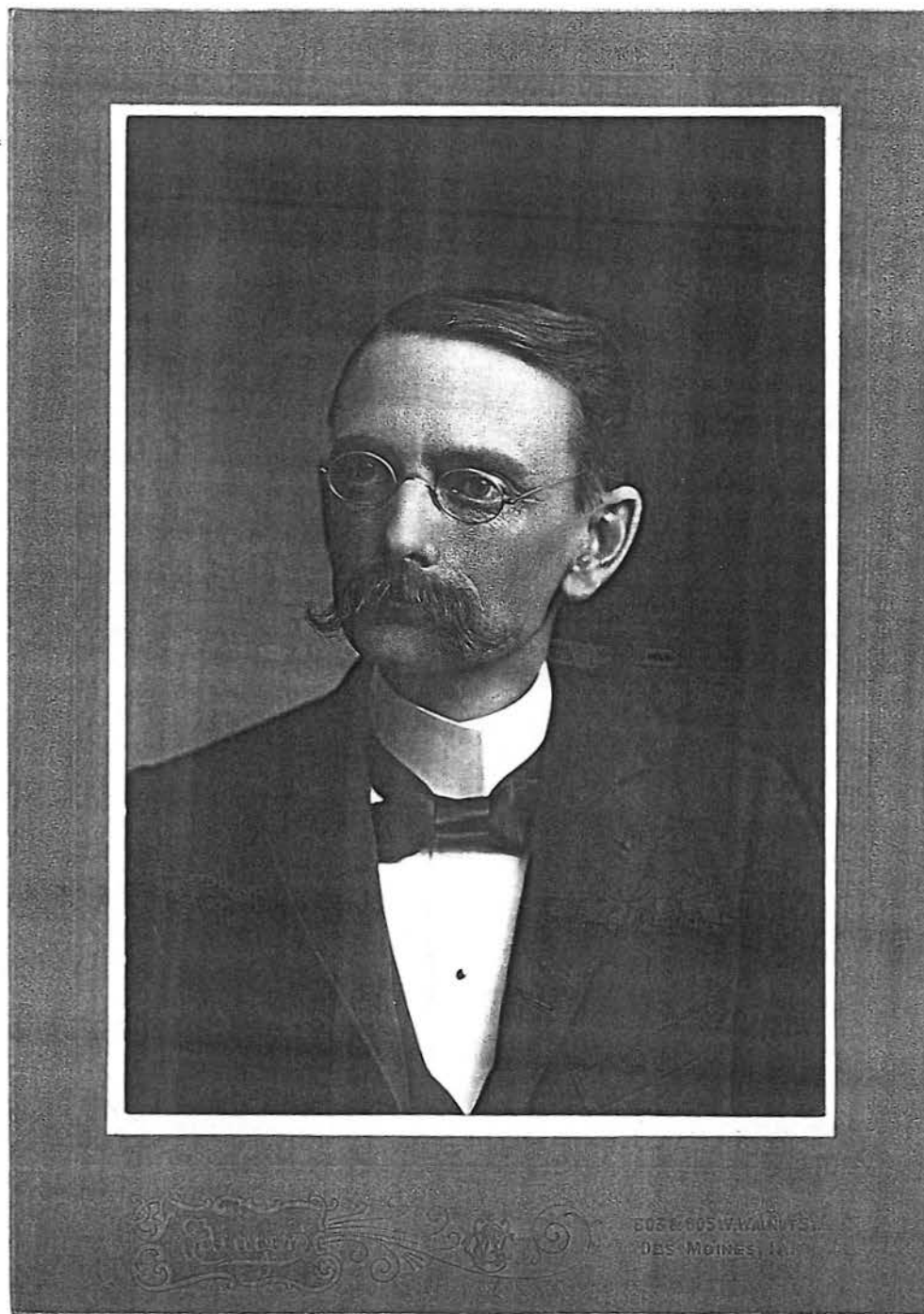
Former State Senator Titus Dies at Muscatine

He was president-treasurer of the Titus Loan and Investment company.





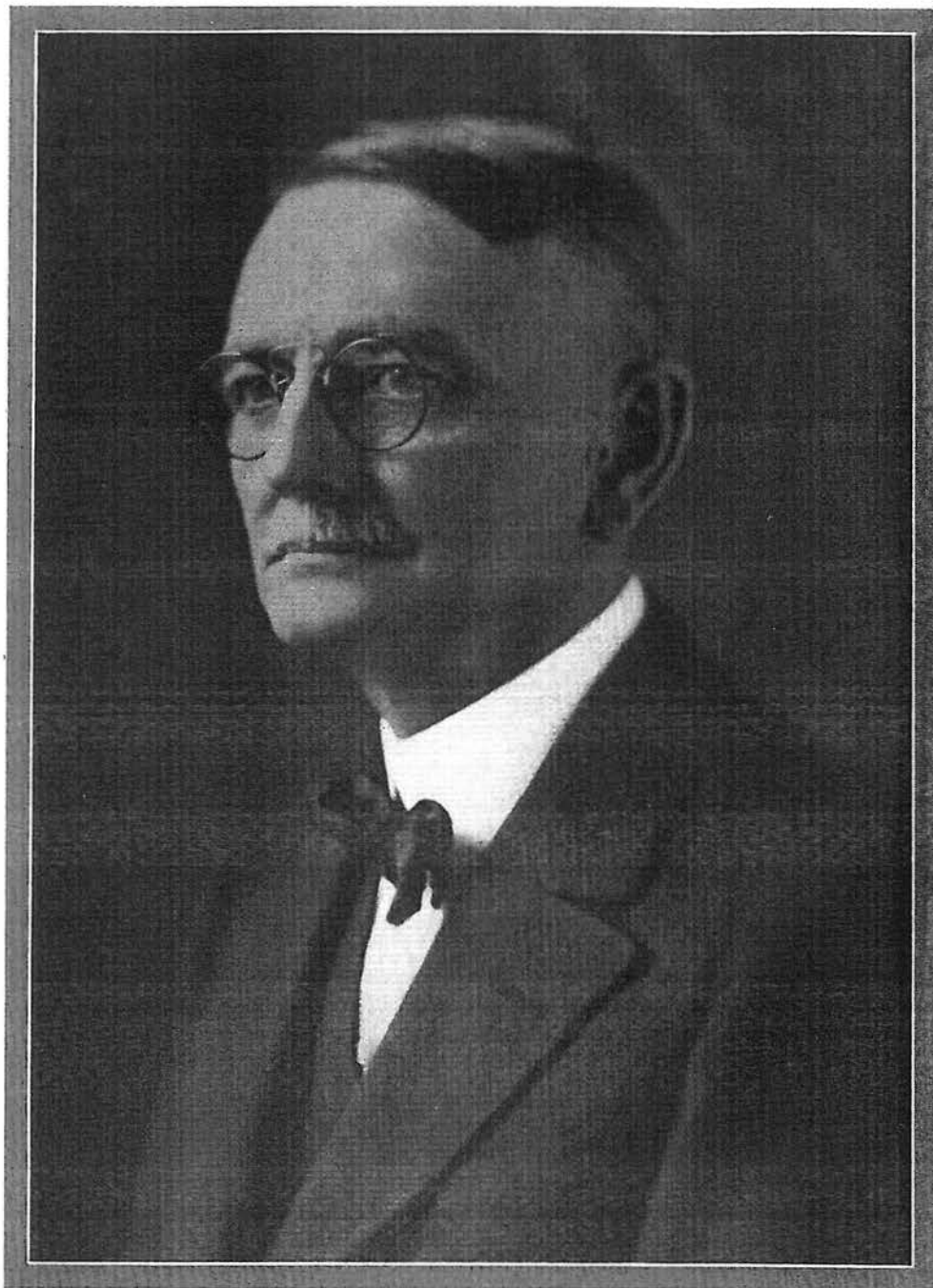

Mr. Remley is past secretary of the Anamosa Fair Association, past director, and past chairman of the concession committee. He is past secretary of the Commercial Club, and a past director of the Country Club. He is one of the originators, and was the first president, of the Rotary Club. He is a member of the Iowa Society, Sons of the American Revolution.

Fraternally, Mr. Remley is a life member of Lodge No. 252 of the Benevolent and Protective Order of Elks, Lodge No. 46 of the Ancient Free and Accepted Masons, the Chapter of the Royal Arch Masons, and the Commandery No. 36, of the Knights Templar. Mr. Remley is a member of the Baptist Church, which congregation he served as a trustee and a member of the finance committee. Since 1925, he has been executive secretary and treasurer of the Hinchman Fund of the Iowa Baptist Convention.

In connection with his political activities, Mr. Remley is Republican committeeman for his Ward and has been for many years. He has been influential in party councils in the state of Iowa, and was an alternate delegate from his state to the Republican national convention of 1928, on which occasion he had the privilege of casting his vote for the nomination of Herbert Hoover, the party's successful standard-bearer and a native of Iowa.

Mr. Remley has been affiliated with Sigma Nu and Phi Delta Phi fraternities. He continues in the practice of law, maintaining his offices at 106½ East Main Street, Anamosa. Mr. Remley's particular hobby is attendance at Republican conventions. He not only attends county and state conventions but has attended five national conventions. Another hobby is the operation of his farms, which has proved a profitable avocation. In his legal practice he is in partnership with his son, and the name Remley will probably continue to be an influential one in legal circles of Anamosa and this section of Iowa.

On October 18, 1911, James E. Remley married Lucy Tucker, who was also a native of Anamosa, and who graduated from Anamosa High School in 1902, as salutatorian. She is a daughter of Lewis E. and Cecelia (Wheeler) Tucker, who were reared, educated and married in Anamosa, where Mr. Tucker was long engaged in the jewelry business. James E. and Lucy (Tucker) Remley became the parents of four children: 1. Mary Cecelia, born in 1913, was educated at Anamosa High School and the University of Iowa, receiving the degree of Bachelor of Arts in 1934. She married Arnold Wunder of Dysart, Iowa, in 1941, and they have one child, John, born in 1945. 2. In 1941, the year of the outbreak of World War II, James T. Remley entered the service of the United States Army as a private, was in the Army for

five years, and was commissioned a first lieutenant. During the greater part of his period of service, he was a purchasing agent stationed at Richmond, Virginia. He is married to Wilma Bolsinger of Colesburg, who is a graduate of Coe College. They are the parents of two children: James Joseph, born in 1944, and Wilma Ellen, born in 1948. 3. Wheeler, born in 1920, who passed away in 1924. 4. Lucille Ellen, born in 1924, received her education at Anamosa High School and at the University of Iowa, where she received the degree of Bachelor of Arts in 1946 and in 1948 the degree of Master of Arts. In 1946, she married Lawrence Williams of Olin, who is also a graduate of the Medical School of the State University of Iowa, and is now resident surgeon of City Hospital in Cleveland, Ohio. They have one son, Lawrence Roy, born in December, 1948.

GEORGE RAYMOND TITUS, investment broker and president of the Titus Loan and Investment Company of Muscatine, was born in Muscatine, November 21, 1884, the son of the late George Marion Titus and Ella (Broomhall) Titus.

His father, George Marion Titus, was born in Cayuga County, New York, May 19, 1855, the son of Allen D. and Mary Jane (Rhoades) Titus. He attended the Corunna, Michigan, High School and the Baptist College of Wilton Junction, where he graduated in 1874. From 1876 to 1877, he was a law student in the office of A. N. Van Camp at Wilton Junction, and from 1877 to 1881, in the office of Allan Broomhall in Muscatine. From 1881 to 1904, he practiced law in Muscatine. In 1904, Mr. Titus went into the real estate and investment business, opening up an office and organizing the company of which he became president. He had already become active in public affairs. In 1891 he organized the company which constructed the Muscatine Mississippi Bridge, and he was its first secretary. In 1890 he had organized the company which constructed the north and south railroad through Muscatine and he was its first secretary also, serving for several years. He was State Senator for Louisa and Muscatine counties in the 27th and 28th Iowa General Assemblies in 1898 to 1900, and was the author of the Titus amendment to the Iowa Constitution, changing the annual elections to biennial elections. Mr. Titus also promoted the construction of Hotel Muscatine and was president of the Hotel Muscatine corporation for five years. He circulated the first petition to start paving in Muscatine and was a leader in securing the construction of the City Hall and County Jail and Court House. For six years he was director of the Upper Mississippi Valley Association, working to secure a nine-foot channel to re-instate river transportation.

He was also a member of the Muscatine park board for fourteen years. Mr. Titus was the first president of the Iowa Farm Mortgage Bankers Association, and served as vice president of the National Farm Mortgage Bankers Association. He was a director of the Muscatine Chamber of Commerce, a long-time Rotarian, a member of the Iowa State Bar Association, the Iowa State Tax Association, and the Thirty-three Club. From 1887 until his death, he served as an elder in the Presbyterian Church. Fraternally, Mr. Titus was very active in the Masonic order and for a number of years served as president of the Muscatine Masonic Temple Association. He was affiliated with Iowa Lodge No. 2, Ancient Free and Accepted Masons; Royal Arch Masons; Royal and Select Masters;

both York and Scottish Rites; and Kaaba Temple, Ancient Arabic Order of Nobles of the Mystic Shrine, and on eight occasions he was a delegate to the Imperial Council from Kaaba Temple.

George Marion Titus, on June 1, 1881, at Muscatine, married (first) Ella Broomhall, now deceased. To this union were born three children: 1. George Raymond, of further mention. 2. Harriett E. 3. Gertrude, now deceased, who married Clifford C. Hakes. He married (second), on October 10, 1908, Nanna Jefferson Hutchinson of Muscatine, now deceased. George Marion Titus died April 9, 1947.

George Raymond Titus attended Muscatine High School and Morgan Park Academy in Chicago, and then became a law student at the State University of Iowa, where he studied in 1907-08. In 1908 he joined his father's real estate and investment business, which is one of the oldest of its kind in Iowa, and was made vice president of the company. He is now president of the Titus Loan and Investment Company, vice president of the Muscatine Improvement Company, a director of the Hotel Muscatine Company, and president of the Greenwood Cemetery Association. Mr. Titus is a past trustee of the Young Women's Christian Association, having served while its building was being constructed; a past president of the Muscatine Club, the Lions Club, and the Muscatine Advertising Club; and a member of the Chamber of Commerce, the Young Men's Christian Association, and the Geneva Golf and Country Club. Fraternally, he is affiliated with the Benevolent and Protective Order of Elks, Iowa Lodge No. 2, Ancient Free and Accepted Masons, Royal Arch Masons, Royal and Select Masters, York Rite, and Kaaba Temple, Ancient Arabic Order of Nobles of the Mystic Shrine; and the Loyal Order of Moose. Mr. Titus's hobby is landscape gardening and the growing of trees.

On November 5, 1914, in New York City, George Raymond Titus married Miriam Bliven.

TITUS LOAN AND INVESTMENT COMPANY—Established in December, 1877, the Titus Loan and Investment Company, or its predecessors, have been actively and continuously engaged in business in Muscatine for more than seventy years. It is one of the oldest business firms in Muscatine and one of the oldest, if not the oldest firm engaged in the farm loan business in the state of Iowa. It is one of the very few firms, in Iowa, engaged in the farm loan business that has been able to prosper.

Along with the farm loan business, the firm has been actively engaged in the real estate and insurance business. It has always been an enthusiastic supporter of Muscatine and had faith in it and its future. As evidence of this faith, the company has built or remodeled well over four hundred homes which have been sold to individual home owners.

In the insurance field the Titus Loan and Investment Company has the distinction of being the oldest representative of many of the leading insurance companies, having represented some of them for over sixty years.

In 1940, felicitations were proffered by the press to George Marion Titus, whose career is outlined above. Attention was drawn to the fact that, as founder of the Titus Loan and Investment Company, the business was being continued under his guidance along long established lines, and that Mr. Titus was not only one of the oldest business men in the city, but one of its most prominent citizens.

ELMER FREUD—Since early boyhood Elmer Freud has known the need and value of work. In his school days a newsboy, he was a traveling salesman at sixteen. Today he is one of Cedar Rapids' successful business men, being president of the Hawkeye Rubber Manufacturing Co., and secretary and treasurer of the Handler Motor Company. Dodge and Plymouth dealers. He is as well known for his enthusiasm for flying—he operates his own plane—as for his activities in the community and in Masonic circles.

Mr. Freud was born in Chicago, Illinois, on July 15, 1904, the son of Bernard and Jennie (Fried) Freud. His father, who was born in Prague, Czechoslovakia, is a retired contractor and builder. His wife was born in Kludna, Czechoslovakia. They reside in Chicago.

Elmer Freud was educated in the public schools of his native Chicago. It was during the latter part of his education that he sold newspapers on Chicago's streets. For two years he worked for a retail jewelry store in the Windy City. Then, from the age of sixteen until he was thirty-four, Mr. Freud was a traveling salesman.

In the fall of 1939 Mr. Freud became associated with the Handler Motor Company, which had been founded in 1934 by Ben S. Handler (q.v.), its present president, and which retails Dodge and Plymouth cars and Dodge trucks and wholesales Chrysler products and parts. Mr. Freud later became secretary and treasurer and manager of this firm, and in this capacity has helped build the business and has made a reputation in the automotive industry. He is also one of the organizers of the Hawkeye Rubber Manufacturing Company of Cedar Rapids, and since its founding on September 29, 1949, has served as president. The company is engaged in the manufacturing of industrial rubber products, with plant operations, and is located at 915 Shaver Road, N. E.

Mr. Freud is a member of Ideal Lodge, Ancient Free and Accepted Masons, the Iowa Consistory, Ancient Accepted Scottish Rite, and El Kahir Temple, Ancient Arabic Order of Nobles of the Mystic Shrine, Cedar Rapids. He has been a Thirty-second degree Mason for many years. Hunting and fishing are his favorite sports and, as has been already indicated, flying is his hobby.

On September 6, 1936, Mr. Freud married Ethel Handler, daughter of Solomon and Pearl (Green) Handler and sister of Ben S. Handler. She was born in Oskaloosa. Both her parents were natives of Russia, where her father was educated and where he served in the Russian Army for four years. He emigrated to America in 1892 and after four years in Newark, New Jersey, settled in Oskaloosa, where after other activities, he was in the automobile business for many years. He died in that city on October 6, 1936, survived by his widow, who continues to make Oskaloosa her home. Joseph Handler, Solomon's father, was a well-known Rabbi who, born in Russia, lived in Oskaloosa for many years but later went to Jerusalem, where he died. Mrs. Freud was graduated from high school at Oskaloosa and spent several years at Ohio State University at Columbus. She and her husband worship in Judah Temple, Cedar Rapids. They are the parents of one daughter, Susan Freud, who was born on May 8, 1938. Mr. and Mrs. Freud and their daughter reside at 2330 Grand Avenue, South East, Cedar Rapids. 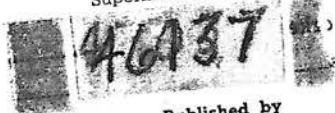

GEORGE M. TITUS

MR. PRESIDENT: Your committee, appointed to prepare a suitable memorial commemorating the life, character and public service of the late Honorable George M. Titus of Muscatine, Iowa, begs leave to submit the following report:

George M. Titus, lawyer and legislator, died at Muscatine, Iowa, April 9, 1947; born in Cayuga county, New York, May 19, 1856; moved with his parents to Michigan when eleven years old and attended school there, the family later moving to Iowa where he attended the Baptist college at Wilton; in the meantime started teaching school at the age of fifteen, and continued for seven years; undertook the study of law in 1876 in the office of A. N. Van Camp at Wilton; later studied in the office of Allen Broomhall and was admitted to the bar in 1880; associated in law partnership with DeWitt C. Richman until 1886 and then joined with D. V. Jackson in forming the firm of Titus & Jackson which continued until Mr. Jackson's election as district judge; served as state senator from Muscatine county in the Twenty-seventh and Twenty-eighth General Assemblies; author of the Titus amendment to the Iowa constitution which changed from annual to biennial elections; also author of the legislation establishing the state library commission; active in state and local civic affairs and at time of his death was president of the P. M. Musser library, a position he had held since 1901; president of the Titus Loan & Investment company and a past president of the Iowa Pioneer Lawmakers' association; married June 1, 1881, in Muscatine to Ella Broomhall, who died May 5, 1907; again married October 10, 1909, to Hannah Jefferson Hutchinson, who also preceded him in death, those surviving being one son, G. Raymond Titus, of Muscatine, and a daughter, Miss Harriett Titus, of Red Oak, Iowa.

Therefore, Be It Resolved by the Senate of the Fifty-third General Assembly: That in the passing of Senator George M. Titus the state mourns the loss of a valuable and honored citizen; a man who devoted many years of his life to public service.

Be It Further Resolved: That a copy of this memorial resolution be printed in the Journal of the Senate and that the Secretary be directed to send enrolled copies to the members of the family of the deceased.
