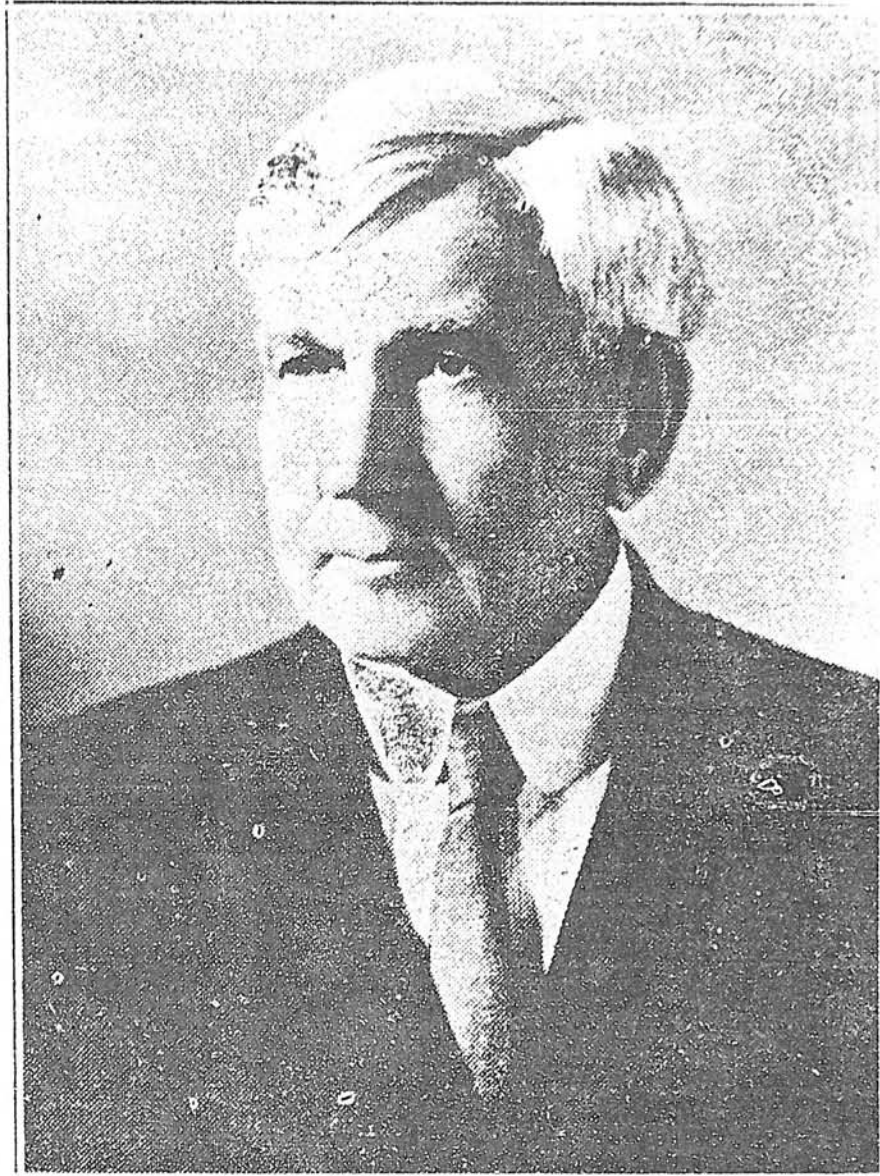

DISTINGUISHED CITIZEN PASSES AWAY TUESDAY

Body to Lie in State at Lutheran Church; Prominent Colleagues Expected.

Worth county's most distinguished citizen, one of Iowa's best known statesmen, a national figure for over 30 years, Gilbert N. Haugen, congressman from the 4th Iowa district for seventeen consecutive terms, died Tuesday evening at 8:30 o'clock at his home on Second avenue north, Northwood. He was 74 years, 2 months and 27 days of age.

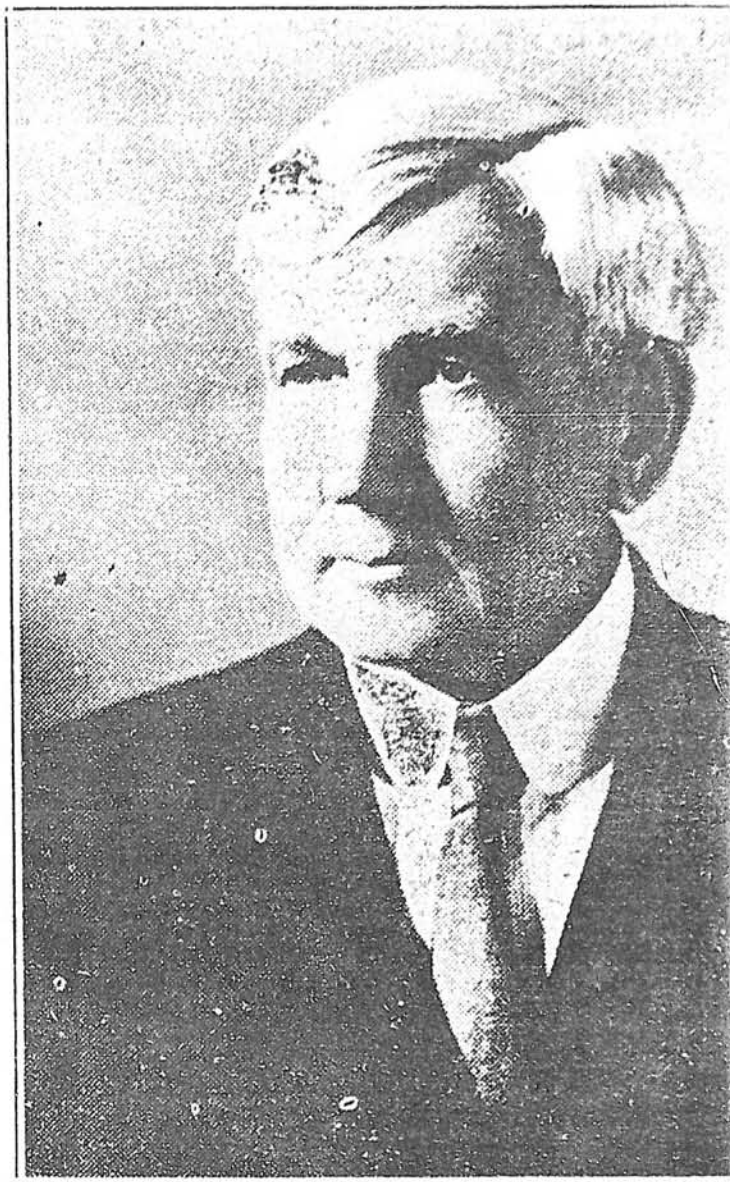
Mr. Haugen had been seriously ill at his home for several weeks before his death, his condition gradually growing worse until he sank into a condition of semi-coma which terminated suddenly Tuesday evening. His daughter, Mrs. J. O. E. Johnson, and Mrs. A. O. Johnson, sister of his deceased wife, have been constantly in attendance during the recent weeks of his illness. His son, Lauritz, of New York City, arrived here about three weeks ago.

Funeral Friday Afternoon.

Funeral services will be held tomorrow (Friday) afternoon at 2:30 o'clock at the Northwood Lutheran church with the Rev. J. W. Yivisaker, pastor of that congregation, in charge of the rites. The body will lie in state at the church from 12 o'clock noon until the hour of the funeral at 2:30 and friends who wish to pay their last tribute of respect to their honored fellow citizen may visit the church during this period.

Gilbert N. Haugen was born April 21, 1859, in Plymouth township, Rock county, Wisconsin, near the town of Orfordville. His parents were Nels and Carrie Haugen, both of whom were natives of Norway where his father followed the occupation of farming until he left his native land for America in 1844.

Mr. Haugen spent his early years on his father's farm and at the age of 14 years he went to Janesville, Wisconsin, in order to supplement his early education by study in the schools of that city. He later continued his studies in Decorah, Iowa, after which he was employed for a time on a farm in Winneshiek county.

Comes to Worth in 1877.

In 1877 he came to Worth county and purchased a farm of 160 acres in Kensett township. With characteristic energy he began its development and personally operated it for several years. He afterwards turned his attention to the implement and furniture business in Kensett and also became a dealer in livestock, in which business he was engaged at the time of his election to the office of county treasurer of Worth county in 1888.

He moved to Northwood to enter upon the duties of his new office and had maintained his home here since that date. He served as county treasurer for six years and in 1894 was elected to the Iowa state legislature as representative from the district which included Worth county.

He was one of the organizers of the former Northwood Banking Co. which later was reorganized into the First National Bank of Northwood, and of the Kensett Bank which later became the First State Bank of Kensett. He was president of both the Northwood and Kensett banking institutions for a number of years prior to his death. He also held interests in other banking and business concerns, both in Iowa and elsewhere.

Made Doctor of Laws.

Mr. Haugen was a member of the Norwegian Lutheran church from childhood. He was a member of the Northern Light Masonic lodge and

Possessing a retentive memory, the late Gilbert N. Haugen was known in Washington as one of the best informed members of either of the legislative bodies. He was often sought out by other members when needed information was difficult to locate and he was usually able to direct them to the desired sources.

For years it was said that "if you want anything done in Washington, Mr. Haugen is the man to see." His contacts were numerous and his opinion and judgment were respected by his opponents as well as his colleagues.

and Winneshiek with 32 votes, his total of 46 votes representing the balance of power between Thomas Updegraff, incumbent representative at that time, and James E. Blythe, of Mason City.

As neither major candidate would concede to the other, Mr. Haugen finally received the Updegraff support and a part of the Blythe support, making the result on the 366th ballot, Haugen 160, Blythe 59, after which the convention voted to make Mr. Haugen's nomination unanimous.

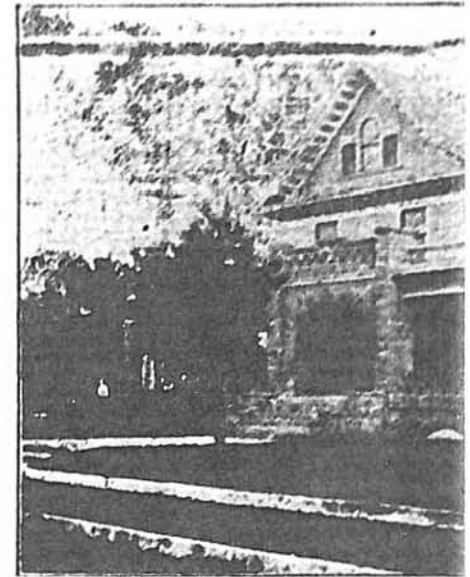
With a record of 45 years of public service, first as treasurer of his home county for three terms, then as state representative for two terms, and following that with 17 terms in the halls of the national house of representatives, it can truthfully be said of the late Hon. Gilbert N. Haugen that he spent his life in public service.

Mr. Haugen took his place among the "insurgents" or "progressives" on a number of occasions when he felt their cause was right, and in one of these instances took part in a revolt against the "boss rule" of Joe Cannon, republican speaker of the house at the time. This is characteristic of his courage when principles in which he believed were at stake.

Perhaps the McNary-Haugen act, of which he was co-author with Senator McNary, has been most frequently spoken of in recent times among the bills which he introduced and personally supported. This act was passed by the house and senate but failed to receive the signature of the president. As the law was not put into operation it may not be possible to state just what the results of its provisions would have been, but it seemed to those seeking relief for the farmers of the country a worth-while plan.

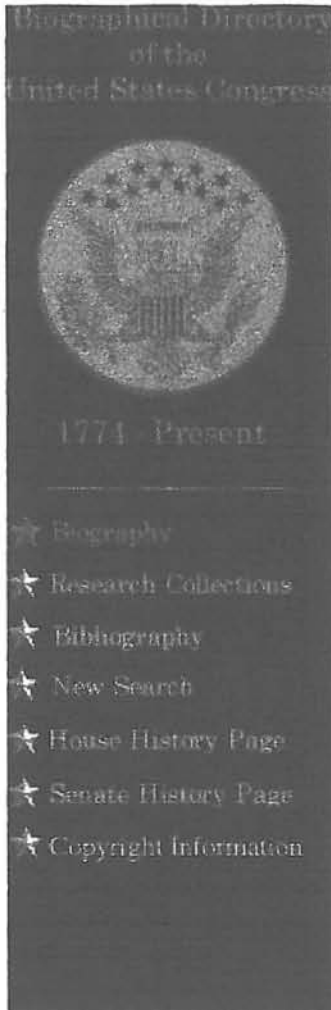
Northwood and Shell Rock Lutheran.

HAUGEN, Gilbert Nelson, 1859-1933

HAUGEN, Gilbert Nelson, a Representative from Iowa; born near Orfordville, Rock County, Wis., April 21, 1859; attended the rural schools; moved to Decorah, Winneshiek County, Iowa, in 1873 and engaged in agricultural pursuits; attended Breckenridge College, Decorah, Iowa, and Academic and Commercial College, Janesville, Wis.; engaged in various enterprises, principally real estate and banking; moved to Northwood, Iowa, in 1886 and engaged in banking; treasurer of Worth County, Iowa, 1887-1893; in 1890 organized the Northwood Banking Co. and became its president; member of the State house of representatives 1894-1898; elected as a Republican to the Fifty-sixth and to the sixteen succeeding Congresses (March 4, 1899-March 3, 1933); chairman, Committee on Expenditures in the Department of the Interior (Sixtieth Congress), Committee on Agriculture (Sixty-sixth through Seventy-first Congresses); co-sponsor of the McNary-Haugen farm bill in 1927; unsuccessful candidate for reelection in 1932 to the Seventy-third Congress; died at Northwood, Iowa, July 18, 1933; interment in Sunset Rest Cemetery, Northwood, Iowa.
