HON. W. A. DAVIE, EX-REPRESENTATIVE DIED WEDNESDAY

Was a Member of the 22d, 23d,
31st and 32d General
Assemblies

Hon. W. A. Davie, prominent in Crawford and Harrison counties, died Wednesday of last week. Mr. Davie was one of this county's prominent citizens and made this county his home for many years. His integrity, ability and honesty was such that he was called upon to accept many positions of trust at the hands of the people of this community.

He was an able orator and being a leading Democrat he was called upon many times to take the stump in behalf of his party.

His funeral was held Sunday at Dunlap and interment was made in the Dunlap cemetery.

The history of his life, as follows, is taken from the history of Crawford county, published in 1911:

One of the well known citizens of Crawford county is W. A. Davie, farmer, business man and member of the state legislature. He has passed the greater part of his life in this county and few men are better informed as to the resources and possibilities of this part of the state or have a larger acquaintance among its people. He was born near Pontiac, in Livingston county, Illinois, October 13, 1865, a son of John Turner and Hannah (Hoskins) Davie.

He came to Crawford county in 1861 with his parents and received his early education in the district schools of Boyer township and continued at home until he grew to maturity. In 1876 he began farming on his own account, in which he has been highly successful, making a specialty of stock raising. He is the owner of two hundred and eighty acres of land in Crawford and Shelby counties, which under his management are yielding substantial yearly returns. For two years past he has been the manager of the Farmers Co-Operative Lumber company of Dunlap. He was one of the organizers of this company in 1900 and was its first president and

The company started with a capital of twenty-five hundred dollars and is now capitalized at nearly \$25,000, being one of the highly prosperous concerns of the county. Mr. Davie was also one of the organizers of the Kiron Insurance company, formerly a Swedish concern, which has since been taken over by the Farmers Mutual Fire & Tornado Insurance association of Kiron, Crawford county, Iowa, and he has served as director of the same for five years.

On October 29, 1876, Mr. Davie was united in marriage to Miss Mary Elizabeth Fullerton, a native of Ohio, and five children have blessed this union: Edith, who is the wife of John Hunt, of Harrison county; Maude, now Mrs. Omer Musgrove, of Harrison county; Ray, who is engaged in farming, Harry, who assists on the home farm, and Maybelle, now the wife of Fred Cook of Union township. The mother of these children was called April 29, 1904, and Mr. Davie was subsequently married to Mrs. Florence (Painter) Griffith, a lady of many excellent qualifications of mind and heart.

In political affairs Mr. Davie supported the Democratic party and has taken an active part in its campaigns. He served in the twenty-second, twenty-third, thirty-first and thirty-second Iowa state general assemblies, and also was elected to fill a vacancy in the twenty-ninth general assembly, discharging his duties most effectively. In 1885 he was elected a member of the county board of supervisors and has also served in all the township offices, being now a member of the board of trustees. Fraternally he is connected with Lodge No. 244, A. F. & A. M., Chapter No. 89, R. A. M., and Lodge No. 178, I. O. O. F., and Golden-Crown lodge of the Rebekahs. Of a genial and kindly temperament, he has many friends and acquaintances and is entirely worthy of the sincere regard in which he is held by all who know him.

LAFAYETTE BIGGS DIED SUDDENLY TUESDAY MORNING

Died Following an Illness of a Week. Heart Trouble Was the Cause

People of this community were shocked and grieved Tuesday morning to learn that Mr. Lafayette Biggs was dead. While he had been confined to his home for a week, his sudden demise was a surprise and came as a shock to his family and friends. He had felt quite badly Monday, and the doctor called Monday evening, but Tuesday morning he told his daughter, Bernice, that he felt much better. Mrs. Biggs raised him up to give him a drink about 8:15 o'clock and he fell back dead.

Mr. Biggs was a long time resident of this county and was a man of industry and trustworthiness. For the last few years he has been employed as an agent for the Des Moines Register and also was a salesman for the L. T. Petersen Sheet Metal company. When the Farmers Union store was organized he was one of the principal promoters and the success of this institution was due largely to his untiring efforts. He became a member of the Methodist church when 20 years of age and has been steadfast in his worship in that organization.

Mr. Lafayette Biggs was the eldest son of Mr. and Mrs. W. A. Biggs, and was born in Cook county, Illinois April 27, 1872. He was 56 years, 11 months and 26 days of age at the time of his death. When a boy of ten years of age he came, with his parents, to Crawford county, where the family located on a farm in Milford township. He attended the rural schools and subsequently attended college at Shenandoah, following which he engaged in teaching school in this county.
