National Bank Case Failed
Before Bank Topped**

One Company Paid

**Cash on Deposit in Washta
Bank Repaid by Company
That Holds Claim**

The recent enactment of legislation, under the provisions of which the state will issue \$3,000,000 in warrants, or so much thereof as may be necessary, to pay claims of counties and other political divisions of the state, including school districts, against the sinking fund, will enable Cherokee county to collect its one and only claim against that fund. The Farmers State Bank at Larrabee held a balance of county funds at the time of the suspension. This sum will be paid by state warrants.

The bonding company repaid the money the county had on deposit in the Farmers State Bank of Washta, about \$10,000, the county assigning its claim to the bonding company which receives such dividends as are paid to other depositors.

The county has received 60 per cent of its funds on deposit in the Citizens Savings bank of Quimby, at the time that bank suspended, and will probably receive from 15 to 20 per cent more.

The \$12,000, more or less, that was on deposit in the First National bank of Marcus when that institution failed, is lost. The county will probably never recover any considerable sum. The bonding company failed some thirty days before the bank suspended.

Pending arrangements for bonding in another company, Treasurer Adsit asked the First National bank of Marcus to send an individual bond. Such a bond was received and accepted on the day that Treasurer Adsit had made out a check, covering the balance on deposit in the Marcus bank, with the intention of withdrawing the funds. When the bank failed the signers of the bond for county money were pulled down with the bank.

The attorney general of Iowa, when the matter was referred to him, held that Treasurer Adsit had taken reasonable precautions to protect the deposit and proceedings against him and his bondsmen to recover were not instituted. This is the record of Cherokee county's financial connections with bank failures.

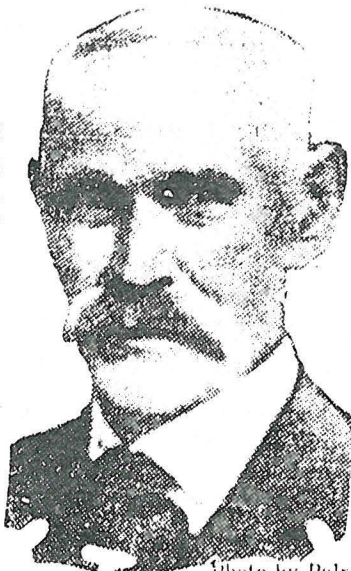

John Potter Was Pioneer of County

**Born in Vermont He Came in
An Early Day to Cast
His Lot in Iowa**

Prominent Character

**Practical and Successful He
Was an Exemplar of Good
Will Toward Man**

John F. Potter, a pioneer of Cherokee county, and who had won prominent place in the acquaintance and friendship of the community, died, Friday night, about 10:30, at the age of over 93 years. For the past several years his health had been indicative of age, but only within the past few months had he been unable to cheerily greet his friends about town.

John F. Potter was born in Bridgewater, Windsor county, Vermont, Feb. 27, 1834, and was a son of John Potter, who served in the war of 1812. John Potter had been born in Rhode Island, a son of Ichabod Potter, of English and Scotch ancestry. The mother of John F. Potter was Polly Wheeler of Connecticut, who was a daughter of Asa Wheeler, of Scotch ancestry, and who had served in the patriot army in the war of the revolution.

When John F. Potter was nine years of age his parents removed to Rutland county, Vermont, where his mother died at the age of seventy-five years. His father died at the age of eighty-seven years.

Nine children were born to John and Polly Parker. Adeline became the wife of Josiah Morgan of Pitcher township, and was a member of the church. She died in the rebuilding of Cherokee county.

George Hicks of Traer has been employed as coach for Cherokee high school, to succeed Coach Boyd, who resigned following his reelection. Coach Boyd has not made known his plans for the immediate future. Under his administration Cherokee has contributed rather liberally to the list of star performers in colleges and universities and Coach Boyd's years here have been a time of pleasure and profitable endeavor by the youths who have been under his training.

In securing Coach Hicks the school board and Superintendent McCombs have perfected a piece of good business in connection with the athletic feature of high school education. Hicks is a graduate of Iowa State Teachers college and is not an experiment. Four years ago he went to Traer in the capacity of a coach bent on discovering a new world. In Traer, talent had been abundant; but training had been low. Years ago that town developed a hose team that swept the state at tournaments, at a time when all cities had volunteer departments and when Traer was pitted against all racers between the two rivers. Talent was there, but Hicks found only an opportunity to begin at the bottom.

How well he built is proved by the fact that in the Tama county track meet his team placed in all fourteen events, winning eight firsts and several seconds and thirds. Macy Campbell Paralytic Sufferer

Dr. Macy Campbell, professor of rural education at Iowa State Teachers college, was found stricken with paralysis Friday in his hotel room at Macon, Ga., where he was attending the Georgia educational association's convention.

Dr. Campbell was taken to a private hospital, where physicians said he had suffered a cerebral hemorrhage. His condition was pronounced serious, paralysis produced by the hemorrhage having affected his left side.

Campbell is widely known and in educational circles is a national figure. He has addressed Cherokee county audiences on numerous occasions and was the principal speaker at the last annual meeting of the Cherokee County Farm Bureau.

The Little Sioux river was this morning at flood stage, probably two feet higher than on Saturday evening. The rise has been steadily maintained. A fair sized stream is flowing under the bridge immediately south of the river bridge on South Second street. The west end and south side of Riverdale park is flooded.

A small stream was this morning flowing across East Main street, east of the river bridge. Several acres of the Rhoads garden are under water. The stage of the river has interfered with the work of the East Hill relocation, and work already done has been considerably damaged.

In 1868 he inspected the advantages offered by western Iowa, and selecting Cherokee county as the location affording greatest promise, purchased 160 acres of land, afterward increasing his holdings to 400 acres in Silver township, all of which he put under a good state of cultivation.

Mr. Potter testified to his prosperity and contentment by erecting a fine residence which was set in the midst of attractive grounds, a feature of which was a grove of thirty-two acres.

On November 27, 1862, Mr. Potter was married to Miss Mary A. Bailey, daughter of E. B. and Lydia A. (Wells) Bailey, residents of the town of Cherokee. Mrs. Potter was born in Connecticut, so that the family, in all its connections was of New England stock and of colonial derivation.

In political affiliation John F. Potter was a democrat and did not seek to hold any office but was chosen to represent Cherokee county in the twenty-third general assembly. He derived abundant pleasure from his status as a private citizen of a nation, state and county in the greatness and bounties of which he rejoiced. As years advanced until he was listed among the patriarchs he retained his love of pleasant contact with fellow man, his laugh was always ready as his pessimism was always absent. He came gracefully to the end of long life, and when his day was closed the sunset was beautiful, a phenomenon of mentality, of energy and of spirit in which his fellow citizens could rejoice.

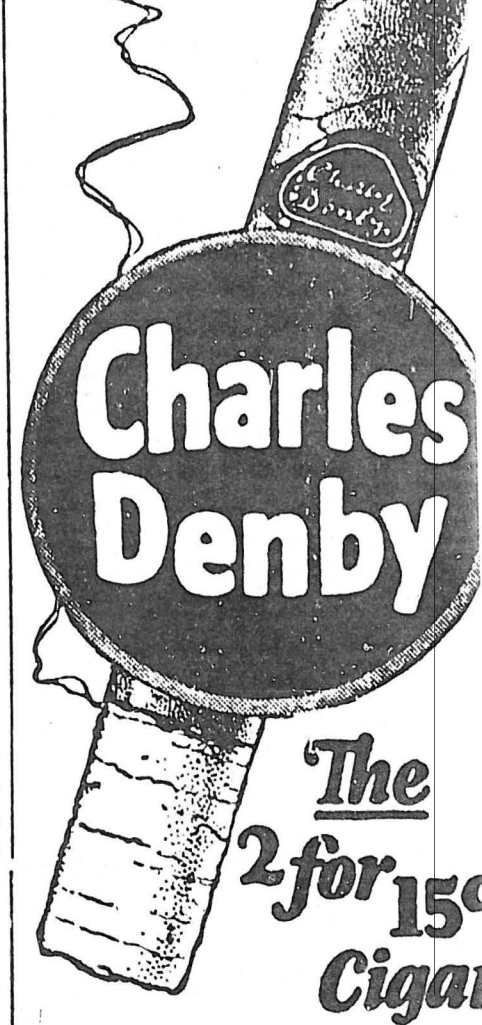
Although shunning publicity, Mr. Potter was a very generous man and contributed liberally to many movements and enterprises in which his name never appeared. His largest benefaction was the gift to local Masonic bodies for the purchase of a site for a Masonic temple, and it was this gift that made possible the buying of the lots at corner of North Second and Willow streets, which are to form the site for a very pretentious building at some later date. Mr. Potter also was a very generous contributor to the fund for the erection and equipment of Sioux Valley Hospital, insisting, however, with his usual modesty, that his contribution should be given no publicity. Many other benefactions were made on the same conditions, the extent of his giving being known to very few of those intimately associated with his affairs.

Funeral Largely Attended.
The funeral service held at Oak Hill cemetery Sunday afternoon was one of the largest attended services of the kind ever held in the city, more than one hundred Masons participating, many coming from other towns and counties. The funeral address was given by Representative C. C. R. Bush and was most impressively delivered.

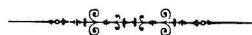

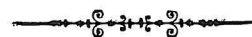

Mr. Potter's mother was Polly Wheeler, a native of Connecticut, and a daughter of Asa Wheeler, of Scotch origin, who served in the War of the Revolution. John F. was a lad of nine years when his parents moved to Rutland County, Vermont. His mother died at the age of seventy-five years, and his father lived to the advanced age of eighty-seven years. There were nine children in the family: Austin, Harriet, Sybil, Jefferson, Adeline, George, Mariette, John F. and Eber. Adeline is the wife of Josiah Morgan, of Pitcher Township. John F. Potter came to Clayton County, Iowa, in 1856, and remained there thirteen years, improving a farm. In 1868 he looked over a large part of Western Iowa, and thinking that Cherokee County possessed more natural advantages than any other in that part of the State he decided to try what the earth and his own industry would yield him. His first purchase was 160 acres of wild land, and the success that has attended his efforts is shown by his title to 400 acres of Cherokee County's choice land, which is in an excellent state of

cultivation. Mr. Potter's residence is a fine building of an attractive plan, situated in the midst of a beautiful lawn containing evergreen and other ornamental trees. One of the best groves in the county is to be found on the Potter farm; it contains thirty-two acres. A large and conveniently arranged barn, and other buildings for stock and grain add to the completeness of the place, and show the thrift and prosperity of the owner. Mr. Potter was married November 27, 1862, to Miss Mary A. Bailey, a daughter of E. B. and Lydia A. (Wells) Bailey, residents of the town of Cherokee, mention of whom is made on another page of this work. Mrs. Potter was born in Middlesex County, Connecticut, and was reared and educated there. Mr. Potter's political opinions are expressed by the Democratic party; voting for Buchanan in 1856, he has ever since been a staunch supporter of Democratic principles. Although holding the confidence and respect of the community in which he lives he has never held public office, his preference being to live a private life. Mr. Potter's long residence in the county, his honorable and upright life, and his appreciation of merit in others have won for him a host of friends. At the home of Mr. and Mrs. Potter hospitality is ever dispensed in a cordial and generous way.

HON. JOHN FREDERICK POTTER

MR. SPEAKER: Your committee appointed to prepare suitable resolutions commemorating the life and service of the Honorable John Frederick Potter, late of Cherokee county, beg leave to submit the following memorial:

John Frederick Potter was born February 27, 1834, in Bridgewater, Windsor county, Vermont, a son of John Potter, who served in the War of 1812, and Polly Wheeler, both of Scotch ancestry. When nine years old he moved with his parents to Rutland county, Vermont, where he lived until he came to Clayton county, Iowa, in 1856.

Mr. Potter followed Rufus Richardson to Iowa and assisted him in developing his farm, which was located southwest of McGregor, and in 1860 he purchased land nearby and in 1862, November 27, married Mary A. Bailey, who had come with her parents from Connecticut in 1859 and lived on a neighboring farm.

In 1868, Mr. Potter looked over a large part of northwestern Iowa, and decided to locate in Cherokee county. Consequently in the spring of 1869 he sold his Clayton county land and with his wife, his father-in-law and several neighboring men he came by covered wagon and ox team to Silver township, Cherokee county, where he purchased Iowa college land and established a home that was known far and wide for its generous hospitality.

Although they had no children of their own, they were the friends of youth everywhere and were Uncle John and Aunt Mary to an ever-widening group, and many were the picnics and gala times enjoyed in the Potter grove and orchard, all planted with their own hands.

Mr. Potter's political opinions were expressed by the Democratic party, voting for Buchanan in 1856. He served as Representative from Cherokee county in the Twenty-third General Assembly.

In 1900 Mr. and Mrs. Potter retired from the farm and moved to Cherokee where he continued to enjoy life and visiting with his many friends until his death, which occurred April 15, 1927, at the advanced age of 93. Funeral services were conducted by the Masons, of which fraternity he was an ardent member.

Therefore, Be It Resolved, That the House of Representatives of the state of Iowa take this occasion to express its appreciation of the character and services of this valuable citizen, and

HON. LEVI FRANKLIN POTTER

MR. SPEAKER: Your committee which was appointed to prepare resolutions commemorating the life, character and services of the late L. F. Potter of Shelby county, beg leave to submit the following:

Levi Franklin Potter was born at Wawatosa, Wisconsin, March 27, 1855, and died at his home in Harlan, Iowa, April 8, 1928.

Mr. Potter was educated in the schools and colleges of his native state and in 1876 made a trip to Pottawattamie county of this state where he received his first impressions of the possibilities of western Iowa.

He located at Oakland, Iowa, and represented Pottawattamie county in the Twenty-sixth and Twenty-seventh General Assemblies of the state legislature and in the special session in 1897, which met to completely codify the laws of the state; and was also chairman of the ways and means committee. Mr. Potter's activities since he came to his adopted state have been many and varied.

If any particular line of endeavor should be used to classify his activities, it would be that of banking, and many people owe their start in life to his wise counsel, his financial aid and his foresight in affairs of finances.

He was elected to the presidency of the State Bankers Association in 1903, and served creditably to himself and the association.

He was a member of the Congregational church, and it can be truly said that the church is richer, not only in a material sense, but from that of brotherly love. He was also a member of the Ancient Free and Accepted Masons, and passed in that organization into the Knight Templar and Shrine degrees.

There are left to mourn his loss his wife, Mrs. Stella Grace Potter, and his son.

Due to his business acumen his holdings in land ran into the hundreds of acres.

His work is done. It is recorded today in the history, in the statutes, and in the affections of the people of the state in which he lived and died, and which he loved so well. He was one of the last of the old oaks, sturdy, steadfast and true to all in which he believed and held convictions.

He has finished his course and he has kept the faith as he conceived that faith.

The last chapter of his life has been written, and the book is closed. It can be truthfully said of him, "Well done."
