Bids of Other Companies.

The other bids included those of the American-LaFrance Company, the Seagraves Company and the Johnson Company, makers of the Laverne pumper; on 750-gallon pumpers, and the White and Mack companies, on pumpers of 600-gallons capacity.

The bid submitted on the White was \$9,829, and on the Mack, \$10,156.20, but the capacity was too small and the bids were not on equipment advertised for.

The price of the LaFrance and Seagraves pumpers was the same as that for the Stutz—\$12,500—but the Seagraves with pneumatic tires was \$300 additional. The Stutz and LaFrance are equipped with pneumatic tires.

Offered Convention Job.

The Seagraves company offered to seal the city its convention "job," built for exhibition at the convention of fire chiefs at Atlanta, to be held next week. This job was described as one of the most perfect the company had turned out, but the council desired not so much appearance as assurance of utility and durability. The Seagraves pumper could have been delivered within ten days. With the pneumatic tires, however, it would have cost an additional \$300.

Fire Chief C. C. Pligman will leave Saturday for Atlanta, Ga., to attend the annual meeting of the fire chiefs of the United States and Canada, to be held next week.

JOHN G. BROWN, OLD RESIDENT, IS DEAD

FORMER REPRESENTATIVE IN GENERAL ASSEMBLY DIES OF OLD AGE.

HONORED BY OFFICES IN STATE AND IOWA G. A. R.

In Early Days Mr. Brown Was Well Known as Large Land Owner of Logan Township—Was Director of Marshalltown State Bank For Years—Funeral Tuesday Afternoon

J. G. Brown, an old resident of the county and city, who was prominent as a farmer in earlier days and twice represented the county in the state general assembly, died at 11:15 Saturday night at his apartment, 112 North Third street. Death was caused by heart disease and complications of old age. Mr. Brown was in his 82d year. He and Mrs. Brown came here from their winter home in Daytona, Fla., the last week of May and May 29 Mr. Brown suffered a severe heart seizure.

He rallied from the first attack and became able to be up and about at times, but recurring seizures followed the first, bringing on other complications. He had been bed-fast for six weeks.

Honored by State Offices.

Mr. Brown was actively interested in politics in his younger days and was elected by the republican party to a seat in the house of Twentieth and Twenty-first general assemblies. He was active in supporting the movement to establish the soldiers' home here.

The Twenty-second general assembly elected him a trustee of the Soldiers' Orphans Home, Davenport, and twice re-elected him. He also was treasurer of that board.

A veteran of the civil war and altho the G. A. R., he was elected junior vice commander of the Iowa de-

her marriage, at Center White C. N. Y., until Dec. 15, 1905, when family came to Iowa.

For seven years the family was on the Lynnbrook farm, six west of the city, then for two Mr. and Mrs. Hewitt lived on a farm, three and one-half miles of the city, where the former Sept. 21, 1914.

Since Mr. Hewitt's death, Hewitt has lived at 206 West F street. When her condition became more serious she was removed to daughter's home.

Surviving Mrs. Hewitt are daughter, Mrs. Herrick, of near mottle, and three sons, Edgar S. Hewitt, Savanna, Ill.; Albert Miron Hewitt, Hollywood, Calif., and Robert Hewitt, city.

SMITH CASE CONTINUED.

Charged With Having Possession of Car With Defaced Numbers.

The case of Warren Smith, arrested on a charge of larceny of an automobile, Friday was continued in municipal court to Oct. 11, on motion of his attorney, after the charge had been changed to that of having in his possession an automobile with the engine numbers defaced.

The car was thought to be one stolen from Fred Gard, but Gard found it was not his property.

Was Native of Illinois.

John Gaddis Brown was born at Farmington, Ill., Feb. 17, 1839. He was reared on a farm and his common school education was supplemented by a course in Illinois College, Jacksonville.

When the civil war broke out he enlisted in 1861 and served three years as a musician in the Fifty-fifth Illinois infantry, re-enlisting as a veteran and serving until Aug. 23, 1865. He was at Shiloh and the engagements of the campaign that led to the fall of Atlanta and with Sherman on the march to the sea.

Came Here in 1871.

He came to the county in 1871 and purchased land in Logan township four miles southwest of Vanclote, where he was very successful in farming. Eventually he came to own more than 1,400 acres that now comprise part or all of the present Waltemeyer, Preston, Wehrman and Cummings farms of that neighborhood. He became especially prominent in agriculture as a hog breeder and feeder and contributor to agricultural publications.

He retired from active farming in the '80s but continued to superintend his farming interests until 1895 when he rented his land. When he quit farming he moved to this city, but for twenty-five years he lived in a winter home at Daytona, Fla., altho he always maintained his legal residence here.

Owner of Much Property.

At the time of his death the only real estate he owned here were four residence properties at Third and Sunnif streets, all the farm land in the county having been sold.

Port of Jaffa, Syria, April 10, 1904,
while she and Mr. Brown were re-
turning from a trip to Palestine. His
second wife, who survives him, was
Miss Frances H. Rodgers, of this
city. Their marriage took place here,
Aug. 31, 1905. No children were born
to either marriage.

Mr. Brown was the last surviving
member of his family. He and the
first Mrs. Brown took to rear a boy,
Charles Dyer, whom they never
adopted, but who used the name of
Charles R. Brown. He died at Colo-
rado Springs, Col., in 1915.

Mr. Brown was a member of the
Congregational church, Cosmopolit-
tan lodge, No. 38, Knights of Pythias
and Frank M. Thomas Post, No. 94,
G. A. R., city, and Daytona Yacht
Club, Daytona.

The funeral will be held at the
Congregational church at 2:30 Tues-
