# HON. P. M. SUTTON DEAD

## Ex-Senator of Marshall County Dies After an Illness of Sixteen Years.

### At One Time Was One of the Ablest Criminal Lawyers of the State--His Career.

### Remains to Be Cremated, Complying With His Request--Funeral Thursday.

Hon. P. M. Sutton, after a lingering illness covering a period of sixteen years, died this forenoon at 11:30 o'clock at his home, corner of Grant and Center streets.

Mr. Sutton's death was hardly expected, altho he has been gradually falling in health for several weeks. He has been a confirmed invalid since the fall of 1886, or after his retirement from the state senate. A week ago he took to his bed and since that the end has been gradually growing nearer until death brought an end to intense sufferings.

Preston M. Sutton was born in Kalamazoo, Mich., Feb. 22, 1845, and removed to McHenry county, Illinois, in

died out in strict accordance with the wishes of Mr. Sutton, made in writing on Thursday, Jan. 27, 1887, shortly after he took sick and at a time when it was thought he could not long survive. No flowers will be used at all, neither will there be indications of mourning in any way. No hearse will be used, but the casket, the cost of which is given in the instructions written by the deceased, will be borne from the residence to St. Paul's church, by members of Frank M. Thomas Post, No. 95, G. A. R., to which the deceased belonged. Funeral services will be conducted by D. John K. Black Thursday afternoon at 2:30 o'clock, and from the church the casket will be borne to the Northwestern passenger station, where the remains will leave Thursday night for Chicago, in charge of Mrs. Sutton and son, and the remains cremated at the Graceland crematory. Returning to the city the G. A. R. post will meet the funeral party and bear the ashes to Riverside, where they will be interred. At the request of Mrs. Sutton Mrs. R. E. Sears will sing at the funeral "A Home on Beyond," a song written by Mr. Sutton several years ago. It was a his request that this song be sung at his funeral.

He taught school in southern Illinois one year after which he entered the Northern Illinois Normal School, at Normal, Ill., and after studying there one year came to Iowa, locating in Marshall county, near Albion. At Albion he was employed to take charge of the mathematical department of the Iowa Lutheran College, which long since passed out of existence, in which position he remained one year, when, with a number of the students, he enlisted in Company A, of the Sixth Iowa Volunteer Cavalry. He served two years.

After the war he came to Marshalltown and was chosen principal of the schools of this city, remaining in that capacity for two and one-half years. He then entered politics and was nominated by the republican party for the office of clerk of the courts. His election followed the nomination and he served one term, four years. While in the clerk's office Mr. Sutton read law, deciding on that profession as best to his liking. On Jan. 1, 1873, he was admitted to the bar, and formed a partnership with Judge H. C. Henderson and H. L. Merriman, which continued for seven months, or until he withdrew, at the consent of the senior member of the firm, to establish an independent office. Shortly after this he was elected city solicitor, which office he held two years, and also he was elected to the school board, of which body he was made president. He was largely instrumental in employing Professor C. P. Rogers, who had charge of the Marshalltown schools for twenty years or more until his death by suicide a few years ago. It was during Mr. Sutton's term as a member of the board that the present efficient school system of the city was inaugurated.

On Oct. 6, 1866, he was united in marriage to Miss Harriett Leverton, of Hardin county, near Steamboat Rock.

After his career in county and city politics he aspired to state honors, and in 1884 was elected to the senate from Marshall county, serving in the Twentieth and Twenty-first general assemblies, in 1884 and 1886. In 1885 he entered the race for the attorney generalship before the republican state convention, but was defeated by a combination of other forces, similar to that used in the last state election in the attempt to defeat A. B. Cummins, the republican candidate for governor. At about this time Mr. Sutton distinguished himself not a little in the Soldiers' Home fight in 1886, he having been one of the most ardent supporters of Marshalltown in securing the state institution for this city in the face of the strongest of opposition.

Mr. Sutton was also widely known throuth Iowa as a criminal lawyer of great merit, and his defense of criminals was the foundation of a considerable fortune which he accumulated. He won a number of important cases that brought him into public notice, cases that had been refused by some of the most able members of the Iowa bar as impossible and hopeless. Among these might be mentioned the "Orr case," the "Carlisle case" and the celebrated defense of Mrs. Ellen S. Tupper, the once famous "Bee Queen" and notorious forger.

Mr. Sutton's life has been an eventful one in many ways. Whatever he has done he has done with all his might. Whatever he undertook, no matter how impossible it seemed at the start, he entered into it with great zeal, resulting in many achievements that were brilliant.

Mr. Sutton is survived by his wife and one son, Mr. Frank Sutton, of this city, also a half brother, George Bekler, of Des Moines. The funeral arrangements will be car-

Mrs. Sutton and son, Mr. Frank M. Sutton, left at 7:30 o'clock Thursday evening for Chicago with the remains, which were cremated in that city today. The ashes will be brought to the city Saturday morning, and interred in Riverside.

Mr. George Ecklor, of Des Moines, a half brother of the deceased, was in attendance at the funeral from out of the city.

**SENATOR SUTTON'S DEATH.**

**Passing of a Citizen Distinguished in Law, Letters and Politics.**

After sixteen years of suffering and almost helplessness, Hon. Preston M. Sutton passed away shortly before noon, Tuesday of this week, at his home, corner of Center and Grant streets. Although an invalid for so many years and his health having failed rapidly the past few weeks it was not thought by his relatives and the friends who attended him that the end was so near. They realized, however, that it was but a question of time.

Mr. Sutton was born on Washington's birthday—Feb. 32—1845, at Kalamazoo, Mich. From infancy until in his sixteenth year he resided with his parents in McHenry county, Ill. For a year he taught school in southern Illinois and studied another year in the Illinois Normal school. Then he came to Iowa, first locating at Albion, where he had charge of the mathematical department of the Iowa Lutheran college, which older residents will recall. After holding this position one year he enlisted in Co. A., Sixth Iowa volunteers and served two years in the civil war.

At the close of the war he came to Marshalltown and was principal of the city schools for two and a half years, being largely instrumental in raising them to the standard of excellence they have since maintained. He subsequently served four years as clerk of the courts in this county, studied law meanwhile and was admitted to the bar the first of January, 1873, entering into partnership with Judge H. C. Henderson and H. L. Merriman. He withdrew from the firm in a few months, however, and practiced individually. His election as city solicitor followed, which position he held two years, and he was elected a member of the city school board, afterward becoming its president. In 1884 he was elected to the 20th and 21st assemblies, and

For many years prior to his retirement as state senator, in 1886, Mr. Sutton was a conspicuous figure in Marshall county affairs. He possessed a rare breadth and depth of intellect, tireless energy and extraordinary method. He was a potent force among the Marshall county bar, his ability and achievements being most noteworthy as a personal injury lawyer. By his incisive method and attention to detail that to other often seemed inconsequential he won many cases that his less venturesome legal brethren refused to touch. This brought him into prominence as a successful attorney and he enjoyed an extensive practice for years, in fact until his physical infirmities incapacitated him from further active pursuit of his chosen profession, He had spent the winter months in the south, for a number of years sojourning principally with an old friend on the battle scarred heights

**STODDERT, THOMAS**, firm of Stoddert Bros., lumber dealers; born in Liverpool, Eng., March 1, 1852; after receiving his education, he became Cashier and head bookkeeper in a large steamship office in London. He came to America in 1875, and came to Marshalltown the same year, and associated with his brother in the lumber business.

**STONE, C. W.**, banker; born in Canada March 17, 1842, and came with his parents to this State to Iowa City and from there they started in the stage, but after coming ten miles, he and his father being in a hurry they came the rest of the way on foot, and arrived here half a day in advance of the stage; in 1855, they engaged in farming, and carried on an extensive dairy business; over 100 cows; the reputation of Stone's cheese was known far and wide. Mr. Stone attended school at Marietta during the county seat trouble, and came to Marshalltown in 1860. He was in the army; enlisted in 13th I. V. I., Co. H; was with Gen. Sherman from Chattanooga to Atlanta, and went with him to the sea, and then to Washington; he was promoted and commissioned First Lieutenant in the regular army in front of Atlanta. After the war, he returned here and associated with H. E. J. Boardman, J. L. Williams and John Turner; has been engaged in banking for the past five years. He married Miss Allie E. Williams, from Erie Co., Penn., Feb. 26, 1864; they have three children—May, Hallie and Herbie.

**STONE, ESBON W.**, of the firm of McCombs & Stone, livery, sale and boarding stable; born in Canada July 23, 1838, and came to Iowa when 17 years of age; arrived in Marshall Co., in May, 1855, with his parents; they engaged in farming and in dairy business extensively; they were early settlers, and there was but little improvement here when they came; he came to this city in 1874, and engaged in his present business. He has held town and school offices. He married Miss Delia A. Randall from Ohio, in January, 1864; they have two children—Willie and Nellie, and lost one son in infancy. Sullivan, Mat., employe C. R. R.

**SUTTON, PRESTON M.**, attorney at law; the subject of this sketch was born in Kalamazoo, Mich., Feb. 22, 1845, and removed to McHenry Co., Ill., in infancy, and lived there until 1860; taught school in Southern Illinois one year and entered Normal University at Normal, and after being there one year, came to Iowa and Marshall Co.; while in Albion he was employed to take charge of the mathematical department of Iowa Lutheran College; was there one year and enlisted with a number of the students in the 6th Iowa V. C., Co. A; served two years. After the war, was chosen Principal of the schools in Marshalltown, and remained in that position for two and a half years; was nominated and elected Clerk of the Courts of this county; held that office two years, reading law in the mean time, and was admitted to the bar Jan. 1, 1873, when he formed a partnership with Messrs. Henderson & Merriman and continued for seven months, then withdrew with the consent of the senior member of the firm and opened an independent office. Was elected Solicitor of the city; held the office for two years; was also elected President of the School Board, and was instrumental in employing Prof. Rogers and in inaugurating the present school system. His present position at the bar is in a considerable degree owing to his having won a number of cases that have attracted large attention, and which were rejected by some of the ablest lawyers of the State as impossible and hopeless, among which may be mentioned the "Orr case," the "Carlisle case" and the celebrated defense of Mrs. Ellen S. Tupper the once famous "Bee Queen" and notorious forger. Mr. Sutton's life has been an eventful one; whatever he has done has been done with his might; his achievements have been brilliant, victorious, and his mistakes have been equally marked and serious. But he is always known to be liberal and generous in his support of all measures intended for the public good and in aid and defense of those most needing help and assistance; he has and always will have hosts of warm and enthusiastic friends; and even those who would be expected to say

most against him have for him only words of kindness and charity.

**TATE, D. H.**, farm laborer.

**TAYLOR, R. HOWE**, Mayor of Marshalltown; born in Newport, Rhode Island, Oct. 1, 1825, and removed at an early age to the State of New York; received his education and studied medicine; came West in 1853, and came to Marshalltown in 1854, and engaged in the practice of his profession; he was one of the early settlers, only few here now that came before 1853. He was elected County Judge in 1861; has held the offices of County Treasurer and Recorder; also held office of Supervisor and was chosen Chairman of the Board; was elected State Senator in 1871, for four years, and was Presidential Elector in 1876; he was elected Mayor of Marshalltown in 1877, and re-elected in 1878. Married Miss Rachel Dunn, from La Porte, Ind., in April, 1860; they have two children—Ettie and Madge; they have lost one daughter.

Taylor, S. J., harness maker.

**THAYER, THOMAS**, buying and shipping stock; born in Hampshire Co., Mass., Aug. 1, 1806; came to Aurora, Kane Co., Ill., in 1844; engaged in milling, farming and stock business; used to drive stock to Chicago; he came to Marshall Co., Iowa, Sept. 13, 1855; came with an ox team, coming by Dixon and Rock Island, then to Iowa City; were four weeks on the way; came to this county, and was here when there was only fourteen voters in this town, and eighty-two or eighty-three in this county. He married Clarissa Williams, from Goshen, Hampshire Co., Mass., in June, 1838. They went back to Aurora, Ill., in 1863; his wife died Aug. 28, 1872; he came here again in 1876, and engaged in buying and shipping stock, and does a large business; he paid out for stock during the months of March, April and May of this year over \$58,000; he has five children—Wealthy Ellen, Thomas J., Edward L. and Clarissa; lost three children.

**THOMAS, FRANK M., COL.**, deceased; was born in Illinois in 1842; and came with his parents to Iowa when

2 years of age; they were at Spirit Lake at the time of the massacre. When the war broke out, he enlisted in the 8th I. V. C., and was in active service until he was severely wounded, having his leg shot off and was taken prisoner near Atlanta, Georgia; he languished in their prisons for a year and a half, suffering everything but death. After the war, he was appointed to a clerkship in the Treasury Department, where he remained two or three years, meantime graduating at the Columbia Law College. Returning to Marshalltown, he married Miss Lydia Holloway, from Ohio, Dec. 26, 1867. He was elected Recorder of Deeds, and was afterward chosen Clerk of the District Court, which office he held at the time of his death, which occurred in the city of Washington, March 6, 1873; in the language of the *Washington Chronicle*, he was a brave, self-sacrificing soldier, a true, generous and abiding friend, and an upright, honest man, and his loss will be deeply deplored wherever known. He left a wife, and one daughter, who now lives with her adopted father, Mr. Lot Holmes.

Gen. William Worth Belknap, the distinguished Iowa soldier and secretary of war. His education was begun in the Keokuk high school and completed at the Phillips Exeter Academy, N. H., and at Andover. Soon after his school days he entered the employment of the Baltimore and Ohio R. Co., becoming chief clerk to the general manager. He afterwards opened a law office in Chicago. While engaged in the practice of his profession he was elected to congress, where he served two terms. Last spring he received from President McKinley the appointment of major and paymaster in the regular army, and was sent to the Philippines, where he fell a victim to disease incident to that climate. Major Belknap was well known throughout this State. He was a genial, excellent gentleman, whose early death will be deplored, especially by the old soldiers who served in the civil war in the commands led by his father. He was the last member of the family of the late Gen. Belknap and leaves no children.

PRESTON M. SUTTON was born in Kalamazoo, Mich., Feb. 22, 1845; he died at Marshalltown, Iowa, Nov. 19, 1901. He was educated at the Northern Illinois Normal school, at Normal, Ill. He came to Iowa in 1860, locating near Albion, where he was for a time employed to take charge of the mathematical department of the Iowa Lutheran college. At the outbreak of the civil war he enlisted in Co. A, Sixth Iowa Cavalry, in which he served two years. After the war he settled in Marshalltown where he was for a time principal of the public schools. He was chosen clerk of the courts, which position he held four years. During this time he read law and was admitted to the bar, becoming a partner with Judge H. C. Henderson and A. L. Merriam. He served a term in the State senate, including the sessions of 1884 and '86—20th and 21st general assemblies. He took an active part in securing temperance legislation and in establishing the Soldiers' Home at Marshalltown. As a criminal lawyer he became widely known throughout the State. He was a man of marked ability, positive and unyielding in his convictions, and before he fell a victim to ill-health was active and influential.

WILLIAM A. DINWIDDIE was born at La Porte, Ind., Aug. 26, 1839; he died at Palmyra, Wis., Nov. 4, 1901. He received his education in the public schools, and afterwards taught school for about two years, when he entered Jefferson Medical College, Philadelphia, from which he took his degree of M. D., in 1860. He did not, however, practice medicine, as he had early decided upon a military career. He was appointed cadet at West Point, and had passed the necessary examinations, but before the time came to enter that school, the civil war broke out, and he volunteered as a private soldier, joining the 22d Iowa Infantry. He was at once made hospital steward, and soon became assistant surgeon. He served with the regiment until it was mustered out in 1865. After the close of hostilities, he served several months in the provost marshal's department. He entered the regular army in 1866 as second lieutenant and was promoted to first lieutenant in 1874. He was retired from active service from injuries received in the line of duty, in 1866, having spent eighteen years in the U. S. army. After that time he was connected with several educational institutions as instructor in military tactics.

MRS. MARY A. BICKERDYKE was born in Knox county, Ohio, near the town of Mt. Vernon, July 19, 1817, and died Nov. 8, 1901, at the home of her son in Bunker Hill, Kansas. "Mother Bickerdyke," as she was called, was known and loved throughout the country for her heroic work as a nurse during the civil war. She came of revolutionary ancestors, her grandfather having served under Washington. At the age of 25 she married and removed with her husband to Galesburg, Ill., where he died before




