IN MEMORIAM.

Christian J. Wyland was born in Elkhart county, Indiana, June 22, '36. In 1851 he moved to Bowman's grove east of this city, and his residence in the county dates from that time. April 11, 1864 he was married to Miss Amanda Dunnington, a native of Kentucky. In 1867 he operated a saw mill at Bowman's grove, and 1871 was elected treasurer of the county. He was re-elected to the place two years later. During this time there was no bank nearer than Council Bluffs, and frequently he carried \$15,000 to \$20,000 between that city and Harlan in the transaction of business. He was elected to the legislature in 1883 and again in 1885.

In 1872 the real estate firm of C. J. & D. M. Wyland was established which later grew to a banking business.

Deceased was among the leading spirits who organized the company which was instrumental in having the Rock Island build the branch from Avoca to Harlan, and the rapid growth of our city has continued since with little interruption.

He leaves a wife and five living children to mourn his death. The oldest child (Arthur) died many years ago.

Funeral services were held at the residence Friday afternoon at two, conducted by Parian Lodge A. F. & M., with an introductory service conducted by Rev. L. P. McDonald of St. Paul's Episcopal church, Council Bluffs. The remains were interred in the family lot in the city cemetery.

BIOGRAPHICAL SKETCHES.

HON. C. J. WYLAND.—We all have a part to perform in the drama of life. The race is made, the outcome determined, our destinies decided, just in proportion to our opportunities, endurance and ability. These are the marks that distinguish the successful man from the man that fails and falls. Let us take a glance backward to the year 1851, and picture a train of emigrant wagons slowly coursing their way through swollen streams and undefined pathways, destined for Shelby County, Iowa, the land of promise. In this way our subject, together with his brother William and his estimable wife, his three younger brothers and his youngest sister, made their journey from Elkhart County, Indiana, the father having previously visited Iowa, entering large tracts of land, a portion we mention as being the southeast quarter of section 36, township 80, range 38, near Bowman's Grove. Having leased this land, C. J. Wyland settled here. In this wild, new country he sought to provide a home for the younger members of his father's family, until they should be old enough to care for themselves. That this plan was well carried out, those younger children, all living but one, can

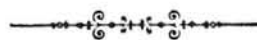
truly testify. The family chain was broken by the death of Jasper N., who died at Duval's Bluff, Arkansas, in 1864, while a soldier in the Union army. At the date of Mr. Wyland's coming to Shelby County, the nearest railroad point was Marengo, Iowa County, to which point he made several trips for supplies. That was the most western point on the Chicago, Rock Island & Pacific line. On these long, tedious trips he camped out, as there were very few hotels; and had there been many, money was too scarce to be thus expended. Notwithstanding these trips were often in bad weather, and over trails where there are now well-improved highways, and over swollen streams long since spanned by iron bridges, yet the remembrance of them still has a pleasing charm, mingled with toil and beautiful romance. While those early days were hard ones, they were not without their joys, for there has ever been something attractive about a new country, and Mr. Wyland is of that type of manhood which seldom broods over toil or even misfortunes, but always sees the bright side on the darkest day. On April 11, 1864, he was united in marriage to Miss Amanda H. Dunnington, a native of Kentucky. Soon after his marriage

he built a house on land adjoining that of his brother William, and removed to it. The lumber used in the construction of this house was hauled by him from Boonesborough, Boone County, a distance of 100 miles, some of it costing \$100 per 1,000 feet. It would almost go without the saying that he smoked few cigars at that time, however well he seems to enjoy one now. He did chew, however, and it is related of him that as a means of economy he used to chew the weed until most of the virtue had been extracted, and then laid it away in some secret place to dry, after which he would smoke it in a cob pipe, unless some one of the other boys had appropriated it to his own use. In speaking of these early days, Mr. Wyland says, in his jolly, good-natured way, "Well, we used to have good times even though we did have it a little tough. Everything in the way of provisions seemed common stock in the neighborhood, and by general consent was divided among all. When flour was out at one neighbor's, another volunteered a supply; in other words, when one neighbor went to mill the whole settlement was sure of flour. But occasionally all would get out at the same time, and then they would change their diet to middlings, which was middling good until pure flour could be obtained." Among the curious customs of pioneer milling was that of the customer cutting and carrying with him a small load of wood to grind his own wheat; and not infrequently he was cheated out of his turn by some other fellow slipping a quarter of a dollar into the hand of the honest (?) miller, which would result in the first man having to haul a second jag of wood before he could get his grinding done. In 1867 Mr. Wyland moved to the saw-mill at Bowman's Grove, and operated it for a year; then he moved back to his farm. In 1871 he was nominated for county treasurer

on the Democratic ticket, for this has always been his party, and was elected. He then moved to Harlan and took possession of the office January, 1872. He was a faithful officer, accounting for every farthing entrusted to his care. He was re-elected in 1873, again making the county an efficient officer. During his first term of office there was no bank nearer than Council Bluffs. As the county provided no way to keep the money safe from the hands of thieves and robbers, except the official bond required of the treasurer, it often became a vexed question how to keep the funds safe from marauders. It was the duty of the treasurer to have the various funds for roads, schools, etc., on hand the first of April, when a greater portion of the taxes were collected. So it not infrequently happened that he was compelled to bring from \$15,000 to \$20,000 from Council Bluffs; then much of this large amount had to be kept in readiness for the different townships for two or three months, during which time the money was stored away in a secret place, not exactly a vault, but a place Mr. Wyland will not mention now, for fear of making some of the early settlers feel badly because they did not know it at the time. In the spring of 1872 Mr. Wyland, in company with his brother, D. M. Wyland, who came back from Council Bluffs, where he had been engaged in a banking house for some time, formed a partnership in the land-office business, as C. J. & D. M. Wyland. They bought the business of Adams & Sharp, who were then located in the building now occupied by Miss Dunnington as a millinery store. D. M. had the management of the office, while C. J. looked after outside matters. They soon outgrew their quarters, and moved a building, 14x16 feet, to the lot upon which their present fine bank building stands. From real-estate business they gradually advanced to loaning, and

finally to banking, when their extensive business again demanded more spacious rooms. In 1880 they erected their present building; the bank is a private concern, known as the Bank of Harlan. To mark the popularity of C. J. Wyland in the county where he has undergone so much privation and lived to see such marked improvement, it only need be said that his services as county treasurer for two terms, his election to the Iowa Legislature in 1883, and his re-election in 1885, have proven him a man of ability and untarnished reputation. No man has been more active than Mr. Wyland in encouraging advancement in public improvements. It was he, together with other leading spirits, who organized the company which finally induced the Harlan branch of the Rock Island Railroad Company to build a line into the county. Every commercial interest has felt his force as an organizer. Mr. Wyland was born on the old Wyland homestead, known as Wyland Mills, in Elkhart County, Indiana, June 22, 1836, where he grew to manhood, having the usual school advantages and experiences of most country lads. In those days the school-house was built of logs, with the flat side of a slab for a seat, while the teacher occasionally touched the pupil up with a strap simply to remind him of the routine of a country school. From the age of ten to sixteen he worked on his father's farm, and for the next five years was a hand, first on the farm, then at the mill, wherever his services were of most value. From 1855 to 1860 he was engaged in superintending a mill of his father's. The following year he came to Shelby County, as before noted, where he has been an important factor in the settlement and development of his adopted land. Whatever his success may have been, his admirable wife is not without her share of credit, for her part was bravely borne in

times when privations were common and the foundation was being laid for better days. She was the daughter of Alexander and Lovisa (Sellers) Dunnington. To Mr. and Mrs. Wyland were born six children—Arthur Perry (deceased), Stella, Jay, Jessie, Grace and Roy. Mr. Wyland is a member of Mt. Zion Commandery, No. 49, K. T.; Olivet Chapter, No. 107, R. A. M., and Parian Lodge, No. 321, A. F. & A. M. He is a quiet, unassuming gentleman, possessing the secret of winning friends and keeping them. In politics he is firm and immovable. In business circles he takes rank with the most substantial men in the State. And so closes the remarkable and unsullied career of one of Shelby County's leading men.



JUDGE JONAS W. CHATBURN, proprietor of the Harlan Mills, has been prominently identified with the interests of western Iowa since 1850. He is a native of England, born in Lancashire, March 11, 1821, and a son of Thomas and Margaret (Ingham) Chatburn, natives of the same place. At the age of fourteen years he was apprenticed to a machinist, and served an apprenticeship of three years, after which he served an apprenticeship of seven years in calico printing. Judge Chatburn was united in marriage, December 25, 1843, to Miss Mary Burton, a native of Lancashire, England, and a daughter of George and Jane (Foster) Burton. In the spring of 1845 they emigrated to America, sailing May 12, in the vessel *Genesee* of Bath, and arrived in New York, July 2, 1845. They went to Frankfort, Pennsylvania, five miles from Philadelphia, where our subject engaged in the printing business at the Tackawanna print works, where he remained one year. He then

this county. After leaving school, he worked on a farm for about seven years, after which he worked in a retail meat market for seven years, and then went into the retail meat business for himself. He erected a suitable building on the west side of the square, at the time one of the best equipped business buildings in the state. He continued in the meat business until 1907, when he disposed of it in order to devote all of his time to his farming interests. He has a fine farm of over two hundred acres east of Harlan, as well as real estate interests in Nebraska. Since 1909 he has been engaged in the real estate business in connection with his farming.

Mr. Patterson was married in 1894 to Luella Downs, the daughter of Dunham Downs. To this union three children were born, Herman, George and Edna. His first wife died and Mr. Patterson then married Mrs. Ida (Paup) Pierce, the daughter of Daniel Paup, and to this union three children have been born, Eleanor, Margaret and C. Robert. The children of both marriages are still living at home.

• Mr. Patterson is a Republican in politics and has been one of his party's leaders in local affairs. The family are members of the First Baptist church and deeply interested in its welfare. He is a member of the board of trustees of his church and has also served as clerk for a number of years.

THOMAS JEFFERSON WYLAND.

Agriculture has been the true source of man's dominion on earth ever since the primal existence of labor, and has been the pivotal industry that has controlled for the most part all the fields of action to which his intelligence and energy have been devoted. In a civilized community no calling is so certain of yielding a satisfactory compensation as that which is culled from the kindly soil. Although the husbandman at times is sorely taxed in coaxing from Mother Earth all he desires, yet Mother Earth is kind to us and seldom treats with disappointment her child whose diligence and frugality she deems it but just should be rewarded. The early pioneers of Shelby county, Iowa, suffered disappointments which her sons of today will never know. Thomas Jefferson Wyland has lived for more than a half century in this county and has seen it emerge from a wide and trackless prairie to its present prosperous condition of highly cultivated fields and flourishing towns and cities.

•• Thomas J. Wyland, the son of Jonathan and Elizabeth (Vanarsdale)

Wyland, was born on February 1, 1849, in Elkhart county, Indiana. Jonathan Wyland was a native of Ohio, his birth having occurred there January 1, 1797, and when a young man came to Indiana and located five miles from Goshen, where he built and operated the first saw mill in that part of the state. He came to Indiana about 1825 and for many years was one of the most prominent men of the northern part of Indiana. In addition to his saw mill he built and personally supervised a woolen and flour mill and built up a large business. In 1855 Jonathan Wyland and his son, William, came to Shelby county on a prospecting trip and entered a tract of government land.

William and his brother, Isaac, came to Shelby county in the spring of 1856 and settled north and south, respectively, of Bowman's Grove. William settled on what he called "Windy Knoll." In 1857 Washington Wyland, Jonathan's son by his first marriage, came to Shelby county to make his home. In this same year Jonathan and his sons erected a saw mill in the county, hauling the outfit from Iowa City, the nearest railway station. In 1861 Jonathan Wyland sold out in Indiana, came to Iowa and spent the following winter with his children in Shelby county. He then went to Kansas, entered government land and some of his children moved there in 1863. Jonathan Wyland was one of the first farmers to bring Shorthorn cattle to Shelby county, securing some registered cattle of this breed from a Kentucky herd in 1861. He brought the first Chester White hogs into this county. In 1864 Jonathan Wyland returned to Indiana and died while in that state, May 29, 1864.

Jonathan Wyland was twice married, his first marriage occurring on December 8, 1823, to Catherine Plumb, and to this union one son, Washington, was born, December 22, 1826. His second wife was Elizabeth Vanarsdale (born April 20, 1809), to whom he was married December 20, 1827, and to the second union twelve children were born: Catherine, Rachel, William, Isaac C., Mary, Christian J., Lovina, Barbara, Jasper N., David M., Thomas Jefferson and Elizabeth. (1) Catherine first married William J. Latta, and after his death, in 1847, she was married to James E. Winegar, on November 10, 1850. To her first marriage one son, Wesley J., was born, while to her second marriage four children were born, Ira J., Ella, Mary J. and Catherine. (2) Rachel died in infancy. (3) William, born September 14, 1830, married Helen M. Thompson, and died December 31, 1911. (4) Isaac P., born August 26, 1832, married Julia A. Mittenbarger, on March 9, 1855, and was the father of seven children, William W., Jeannetta E., Omer P., Jonathan, Seth L., Mary H. and Osa O. (5) May, born April 4, 1834.

married John C. Harris, February 20, 1850, and was the mother of eight children, Alice E., James H., David J., Emma C., Ira J., Calvin J., Clara E. and Helen S. (6) Christian J., born June 22, 1836, married Amanda H. Dunnington, April 11, 1864, and had six children, Arthur P., Stella, Jay, Jessie, Grace and Roy. (7) Lovina, born February 20, 1838, married E. Jarvis, August 14, 1859, and she had eight children, James L., Jonathan M., Anna, Laura, Francis, Arthur P., Helen M. and William T. (8) Barbara, born March 31, 1840, married Christian Goodyear, July 20, 1856, and she had four children, Andrew, Catherine, Mary and Lillian E. (9) Jasper N., born March 12, 1844, enlisted in Company M, Ninth Iowa Cavalry, October, 1863, and died July 9, 1864, at Balls Bluffs, Arkansas. (10) David M., born August 21, 1846, married Rose B. Keasey, September 8, 1867, and died in 1912. (11) Thomas Jefferson was the eleventh child, and the one with whom this narrative subsequently deals. (12) Elizabeth, the youngest child of Jonathan Wyland and wife, was born May 30, 1853, and married Austin D. Hill, December 17, 1871. She has one daughter, Bonnie, and an adopted daughter, Dora L.

Thomas J. Wyland was twelve years of age when his parents finally settled in Shelby county, Iowa, and attended school until he was eighteen years of age after going west. He also spent one year at Tabor, Iowa, in school. He has lived a simple and unostentatious life for a half century in this county, raising all the crops peculiar to this section of the state, and at the same time paying due attention to the raising of live stock for the markets. He has been especially interested in raising of thoroughbred horses and has found a ready market for all such stock as he had to sell. He has a fine farm of two hundred acres, which is well improved and has a beautiful home, where he is spending his declining years.

Mr. Wyland was married April 11, 1870, to Clara Osborn, the daughter of John F. Osborn, of Mills county, Iowa, and to this union have been born five children: Hugh O., Elizabeth A., Ralph W., Mary J. and Fred E. Hugh O. was born December 16, 1873, married Grace Florence, and has four children, Florence, Ruth, Lloyd and Dorothy; Elizabeth A. was born September 16, 1875; Ralph W., born January 10, 1880, married Estella G. Babcock, February 26, 1902, and to this union have been born two children, Evelyn C. and Hal B.; Mary J. was born December 19, 1883, and Fred B., the youngest child, was born January 9, 1891. He has never aspired to office and has voted the Democratic ticket all his life. He was township clerk in the early history of the county. Mrs. Wyland, who was a member of the Congregational church, died August 2, 1902.

Mr. Wyland has been a close observer of modern methods of agriculture and has met with encouraging success in his chosen life work. He has not attained to his position of present prosperity without long years of toil and good management. He has been a man who never permitted any stone to remain unturned whereby he might advance himself, and yet at the same time he has so lived that he has kept the confidence and esteem of his fellow citizens.

HEZEKIAH N. BAUGHMAN.

One of the Hoosiers in Shelby county, Iowa, is Hezekiah N. Baughman, whose parents were among the first settlers of this county. For sixty years, Mr. Baughman has been a resident of this county, except the three years he served his country during the Civil War. Through the munificence of our government, thousands of soldiers were given homestead claims in Iowa and other western states after the close of the war, and several hundred of these worthy men came to Shelby county.

Hezekiah Baughman, the son of David and Elizabeth (Neal) Baughman, was born in Noble county, Indiana, January 12, 1840. His father, a farmer and a native of Pennsylvania, came to Shelby county, Iowa, with his family in 1854. The Baughman family was one of the first to locate in the county, and David Baughman was one of the most prominent citizens in its early history. He served as judge of the county shortly after its organization, and during his life-time was one of the most influential citizens of this part of the state.

Hezekiah Baughman was educated in the schools of Noble county, Indiana. Mr. Baughman enlisted at Lewis, Iowa, in 1862, as a member of the Twenty-third regiment, Iowa Volunteer Infantry, and was mustered in as a member of Company I. His regiment participated in many of the severest engagements of the south and was finally mustered out at Harrisburg, Texas, in 1865.

At the close of the war, Mr. Baughman returned to Iowa, secured forty acres of timber and prairie land in Grove township, built a small cabin and lived in it for several years. He married in 1866 and he and his young wife lived pioneer lives amid all of the hardships and privations incident to life in a new country. As Mr. Baughman prospered, he added to his acreage and now is the owner of one hundred and sixty acres of excellent land, thirty-five acres of which is in timber. He has spent about six thousand dollars in

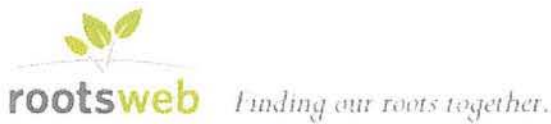

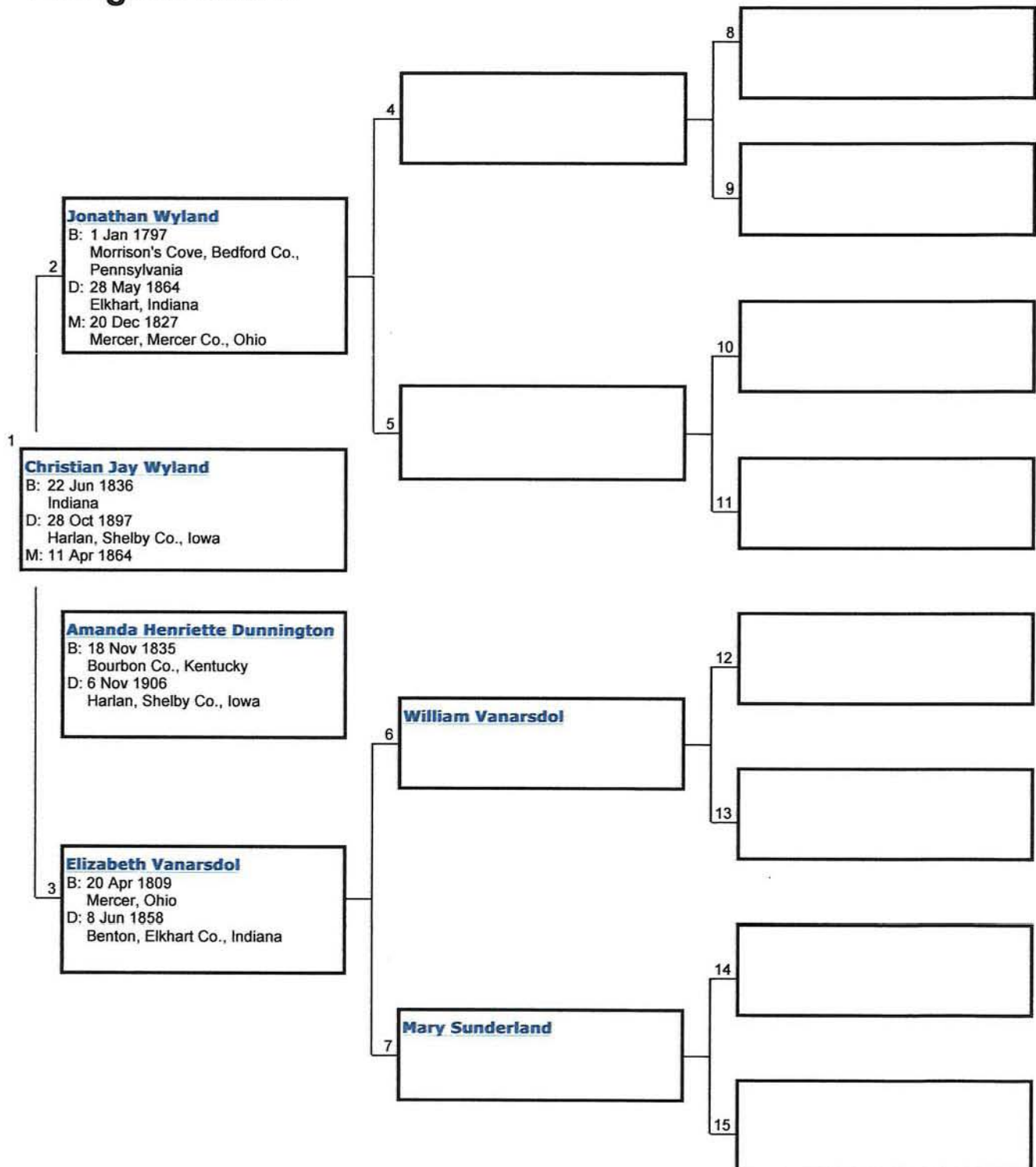
