COL. H. C. EGBERT DEAD.

SOLDIER AND CITIZEN PASSES AWAY AT SUBURBAN HOME

The End Came At 7 O'clock Last Night, Very Quietly and Peacefully—Davenport Loses One of Her Most Distinguished Citizens—Biographical Sketch of His Interesting Career.

At 7 o'clock last night the sorrowful news was borne to many anxious friends that Colonel Henry Egbert had breathed his last at his beautiful home east of the city. Quietly and peacefully so that the grief stricken watchers hardly knew when the end came, the warrior, citizen, philanthropist and friend passed away. The members of his family and a few very close friends were at his bedside when the spirit departed from this life to the life eternal.

For weeks Col. Egbert had been ill, but during the last few days there seemed to be a marked change for the better, and it was believed that immediate danger was past. Day before yesterday he improved and was able to be about the house. Then he took a turn for the worse, and about 5 o'clock Friday afternoon, became unconscious, remaining so until the end.

"Never to my knowledge has a word of ill been spoken about Col. Egbert," said a gentleman last evening upon learning of the colonel's death. "He was one of the finest men that ever lived in Davenport—a peer among men." And what this gentleman said so sincerely can be seconded by everybody who knew the colonel. Kindly and generous, always doing acts of kindness and alleviating the misfortunes of his fellow man, the extent of his good works will never be known, save by the keeper of all records: A farmer, soldier, a county official, a state official, a progressive business man, and an ideal citizen—all this the community loses in the death of Col. Egbert.

Biographical Sketch.

Col. Egbert was president of the Davenport National bank, to which important office he was elected a little

Biographical Sketch.

Col. Egbert was president of the Davenport National bank, to which important office he was elected a little over a year ago. He was senior member of the Egbert, Fidler & Chambers company. In the Central Methodist church and the Fejervary Home for Old Gentlemen he was a trustee, and he was very prominent in all other work for the good and uplifting of mankind. He was also a trustee of Cornell college at Mt. Vernon, Ia. In Masonic and Grand Army circles he was prominent, and twice had he served as president of the Second Iowa Cavalry association. He was one of the foremost organizers of the Federal Life Insurance company, and of the Davenport Building & Loan association.

A year ago Col. and Mrs. Egbert celebrated their golden wedding anniversary quietly. Mrs. Egbert survives with one daughter, Mrs. J. D. Duncan.

Col. Egbert was born in Newcastle, Delaware, Dec. 22, 1826, his parents being Christian and Elizabeth Egbert. His father was a native of Amsterdam, Holland, and came alone to America at the age of 14, for years following the sea, and finally becoming the captain of ships. The colonel was one of his six children. Until 15 years of age he attended school. Then, though a mere boy, he engaged in the grocery trade at Philadelphia, Pa., and continued at that avocation for six years. In 1847 he went to Hocking River, seven miles from Logan, Ohio, and operated a saw-mill.

It was there he married, May 12, 1850, Miss Elizabeth G. Sudlow, daughter of Richard and Hannah Sudlow, and a native of New York.

Mr. and Mrs. Egbert lived near Logan until 1856, when they came to Scott county. Mr. Egbert bought a farm in Cleona township, and lived upon it until August 14, 1861, when the call of his country caused him to lay down the plowshares for the time and take up the sword.

again by wounds and illness to return
to his home.

But he did not leave the service of
his country. In 1864 he again went
into the field as lieutenant-colonel of
the Forty-fourth Iowa infantry, and
March 1 was appointed provost-marsh-
al of the Second District of Iowa. In
this capacity he closed up the provost-
marshal business of the entire state
and on Jan. 1, 1866, received his final
discharge from the service of his coun-
try.

County and State Officer.

The war over, the man who had gone
out as a sergeant and returned the
commander of a regiment, laid aside
the sword that for five years had
swung by his side, and once more
took up the quiet avocation of the
farmer. In the fall of 1869, he was
elected treasurer of Scott county and
held that responsible office for four
years. About that time he engaged in
the printing, binding and blankbook
business, as the senior member of the
firm of Egbert, Fidler & Chambers. In
the fall of 1879 he was elected on the
Republican ticket as Scott county's
representative to the Iowa legislature.
He was a member of Davenport lodge,
No. 37, A. F. & A. M., and of A. O. U.
W. lodge No. 17. In politics he was a
strong supporter of the Republican
party. He was a trustee and strong
supporter of the First Methodist, and
