FORMER SIDNEY MAN DEAD

T. R. Stockton, Who Was Judge of This District Back in the 60's When it Was the 13th, Dies in Chicago.

Judge T. R. Stockton, a former citizen of Sidney, died very suddenly at the home of his daughter in Chicago, Nov. 26, 1904. The remains were brought to Clarinda for burial, the funeral services being held from the home of Mrs. Eva Kimball, a cousin of Mrs. Stockton, last Tuesday afternoon, conducted by Rev. J. N. Maclean. The service was attended by a very large number of friends. The pall bearers consisted of the elders of the Presbyterian church, and six ladies who were members of his Sunday school class, when he resided there, acted as flower bearers.

The late Thomas R. Stockton was born near Quincy, Ill., Aug. 16, 1834. He was the second child of Rev. Jas. M. Stockton, a pioneer minister of Iowa. In 1852 the father settled on a homestead of 320 acres in Taylor county, Ia., near the eastern boundary of Page county, and while living there Thomas followed farming and school teaching until 1859, when he began reading law. In October, 1860, he moved to Clarinda and entered the law office of J. J. Barwick. He was admitted to the bar in May, 1861. In the fall of that year he taught school in Montgomery county. In January, 1862, he opened a law office in Clarinda, and in that year and until November, 1863, did editorial work on The Clarinda Herald. In October, 1863, he was elected probate judge of Page county, in which office he served two years. May 1, 1866 he removed to Sidney, Fremont county, where he was elected judge of the Thirteenth judicial district of Iowa, which embraced

the counties of Fremont, Mills, Pottawattamie, Shelby, Audubon, Crawford, Carroll and Greene. From 1866 to 1877 he was the law partner of Major A. R. Anderson. In the summer of 1873 he removed from Sidney to Council Bluffs. His term of four years as judge expired Jan. 1, 1877, and on the expiration of his term in that office he opened a law office in Council Bluffs. In May of that year he was called to Deadwood, S. D., by the excitement over the Black Hills region, but being unsuccessful there he returned to Sidney in November, 1877, and again engaged in the practice of law at this place. In 1879 he was elected a member of the Iowa house of representatives from Fremont county. In May, 1883, he removed to Shenandoah, where he formed a law partnership with C. S. Keenan, which continued until 1886, when he was elected county attorney of Page county, and to which position he was reelected in 1888.

Mr. Stockton was married Aug. 20, 1863, to Miss Elizabeth Pierce, a native of Pennsylvania.

Mr. Stockton is survived by his widow and their three children, Mrs. Lillian J. Stockton, of Chicago, Mrs. Nellie Ebert, of McCook, Neb., and Fred R. Stockton, of the City of Mexico. The family left Clarinda in 1890, moving to Longmont, Colo., where Mr. Stockton lived until recently when he went to live with his daughter in Chicago, at whose home he died.



of the district court, which office he filled to the entire satisfaction of the county. He is a democrat in politics, and has been identified with the political history of that party since his residence in the county. In 1871 he engaged in his present business; adding to his income as a practicing attorney, he having been admitted to the bar in 1868. Mr. Shockley was married at Council Bluffs, February 14, 1866, to Miss Rebecca M. Mattock, of Wayne county, Indiana; they have two children living: Edward, and Jessie.

SCYOC, JOHN V., joint proprietor Cromwell House, P. O. Sidney; born January 9, 1816, in Perry county, Pa., where he attained the estate of manhood, and resided many years. His early life was passed as a farmer, and his educational advantages limited to the common schools of that day. He followed the occupation of a tanner for five years, and then, the four years following, engaged in railroading. In the spring of 1865 he moved to Cedar county, Iowa, following farming for one year, when, in 1866, he removed to Jefferson county, engaging in farming until the fall of 1871. He then moved to Fremont county, settling permanently at Sidney. In 1873 he rented the hotel property, known as the Cromwell House, which he conducted until 1875. In that year he purchased the property, in copartnership with Frederick Crabbs, and these gentlemen still conduct the house. Mr. Scyoc was married June 1, 1843, to Miss Julia Winters, a native of Maryland, born August 12, 1819. They have four children living: Isaac, Margaret, Julia and Jennie, all married, and three deceased. Mr. Scyoc is a member of the Masonic fraternity; and both he and his wife are members of the M. E. church.

STOCKTON, T. R., attorney at law, P. O. Sidney; born near Quincy, Adams county, Illinois, August 16, 1834. His parents were the Rev. J. M. Stockton and S. E. Kirkpatrick—his mother's maiden name. He resided in the counties of Adams, Hancock, and Henderson, Illinois, until 1852. In April, 1853, his father's family settled in the western part of Taylor county, Iowa. The boyhood and early manhood of Mr. Stockton were passed upon a farm, the uneventful life of which had little to offer him in the way of mental improvement. His education was limited to that of the common school, but was sufficiently complete to beget a desire for knowledge, which was met by a wide range of general reading. At various times, from 1855 to 1860, Mr. Stockton was engaged in teaching in the counties of Page, Taylor, and Montgomery. He began to read law in 1859, while still engaged in teaching, to follow which he borrowed books from friends. He was admitted to the bar in 1861, commencing to practice in Clarinda. From 1862 to 1863 he was editor of the *Page County Herald*, which had been moved from Sidney a year or two previ-

ously. He did not cease either his study or his practice while engaged in editing the *Herald*, but kept abreast of his brother attorneys. He was elected county judge of Page county in October, 1863, filling the position with entire satisfaction. Three years later, in 1866, he removed to Sidney, Fremont county. In 1872 was elected judge of the circuit court of the thirteenth circuit, at which time he removed to Council Bluffs, remaining there until the expiration of his term of office. The spring, summer and fall, of 1877, were spent in Deadwood, D. T., in the practice of law and dealing in mining property—the latter proving a losing venture. In November, 1877, he returned to the states, and moved to Sidney on the first of December, the same year. In 1879 Judge Stockton was elected to the state legislature. While at the Capital he entered with intelligent zeal into legislative affairs, occupying several positions of importance in that council of the state. He was successively chairman of the committee on constitutional amendments, a member of committee on judiciary, ways and means, schools, retrenchment, and reform. He served his constituency well, was thoroughly independent, and all his acts characterized by that complete want of bias that marks the competent legislator. Judge Stockton married Miss Lizzie Pierce, near College Springs, Page county, August 20, 1863, by whom he has three children: Lillie J., born in Clarinda, June 10, 1864, now at Tabor College; Nellie P., born in Sidney, July 25, 1866; and Fred R., born in Council Bluffs, December 10, 1873.

SWEARINGEN, GARRETT V., farmer, section 28, P. O. Sidney; born August 23, 1824, in Beaver county, Pennsylvania, where he remained until some sixteen years of age, when he removed to Washington county, same state. Until 1852 he followed the business of machinist and millwright in western Pennsylvania, eastern Ohio and Virginia. In 1852 he moved to New Cumberland, Hancock county, West Virginia, where he followed his trade until 1854. In that year he went to California and Oregon, engaging in his business some three years. Mr. Swearingen came to Iowa, locating in Mills county, in the spring of 1858, and in the same year came to Fremont county, in which he has since resided. In 1860 a misfortune befel him which necessitated the amputation of his foot. In 1861 he was appointed postmaster at Sidney, which he held for twelve years. In 1864 he also became revenue collector of this district. In 1865 he assumed charge of the business of the express companies then located in Sidney, remaining with them until 1870. He was married March 2, 1857, to Christiana M. Burke, of West Virginia. He has been a member of the I. O. O. F. for twenty-two years, a fact which of itself testifies to his worth.

SHIRLEY, W. R., P. O. Hamburg; born in Defiance county, Ohio,

judge for his noble traits of character, and especially for his qualifications as a jurist.

At the annual meeting of the Iowa Baptist state convention, held in Des Moines in 1870, Judge Mott was elected its president, and the same compliment was paid him at the next three annual meetings of that body. In 1873 the regents of the State University elected him to the professorship of pleadings and practice in the law department of that institution, a position which he filled for two years, and then, under the pressure of enthusiasm created by the Baptist denomination in favor of their higher schools of education, in connection with the centennial year of the nation, he accepted the presidency of the University of Des Moines. That position he held until the close of the centennial year, when, owing to the condition of his health, he resigned, and, returning to his old home, resumed law practice and banking. In 1867-68 he was cashier of the National Bank of Winnetonka, and that position he again holds.

During the connection of Judge Mott with the University of Des Moines, the college building was finished; rooms for the societies and library were provided; the library was started, and about twenty thousand dollars were added to the endowment.

Judge Mott early embraced the tenets of the whig party; cast his first vote for General Scott for the Presidency in 1852, and since the dissolution of that party has acted with the republicans. He is a candid, sincere and conscientious man, cherishing his political and religious sentiments with equal honesty of purpose.

The judge has a second wife. His first was Miss Emma E. Dean, of Grayton, Vermont; married in 1856. She died in August, 1868. His present wife was Miss Mary J. Best, a native of Morrow county, Ohio; married in July, 1861; they have three children.

An old neighbor of Judge Mott, and an associate of his at the bar, thus speaks of him as a man, and a lawyer and jurist:

He is pleasant in his manner, kind-hearted and charitable, ever ready with a kind word when a kind word will do good. He is an earnest christian worker, public-spirited, and an invaluable citizen. As captain and assistant adjutant-general in the army, he was prompt, courteous, efficient and gallant.

As a judge, he was pleasant in his treatment of the bar and litigants, ever jealous to see that fair play and justice were accorded to all. He was a close student, keeping up with the adjudications with higher courts, and so correct that few of his rulings were ever reversed by the supreme court of the state. He could have received a re-nomination for judge had he expressed a desire for it, but he declined.

HON. THOMAS R. STOCKTON,

SIDNEY.

THOMAS RICHARD STOCKTON, late circuit judge of the thirteenth judicial district, is a son of Rev. James M. Stockton, a Cumberland Presbyterian minister, and Susan E. Kirkpatrick; and was born in Adams county, Illinois, on the 16th of August, 1834. This branch of the Stocktons sprang from the old New Jersey family. Samuel Stockton, the grandfather of Thomas, was a soldier in 1812-1815, and lived in Tennessee. Samuel Kirkpatrick, his maternal grandsire, came from Georgia to Illinois, bringing his slaves with him and freeing them. He aided as a member of the constitutional convention of Illinois, to form the first constitution of that state. Rev. James M. Stockton left Tennessee because of his hatred of the system of human servitude.

Thomas spent the first nineteen years of his life in his native state, having only a common-school education. His father was a country minister, and always owned a farm, on which the son was reared. In

1853 the family removed to Taylor county, Iowa, where Thomas aided in opening a farm, working very hard and giving the little leisure time which he could command to the study of certain English branches. When about twenty years old he taught a winter school, and continued to teach at intervals for five or six years. He commenced reading law at Clarinda, Page county, while teaching in 1859, and was admitted to the bar at Frankfort, then the seat of justice of Montgomery county, on the 16th of May, 1861, and practiced in Clarinda for five years, occupying different positions during this period. He edited the Page county "Herald" for about fifteen months, commencing in September, 1862, while the proprietor, Major C. B. Shoemaker, was in the army; was deputy provost-marshal between one and two years after leaving the editorial chair, and was judge of Page county from January, 1864, to January, 1866. Mr. Stockton regards his brief experience as a journalist as one of the most important epochs in his

life, it furnishing him a good opportunity for mental improvement.

In May, 1866, Mr. Stockton moved to Sidney, and here practiced steadily until January, 1873, when he went on the bench, as already indicated, serving four years. During the greater part of this time, for convenience, he resided in Council Bluffs, returning to Fremont county on leaving the bench. He made a conscientious and impartial judge. The judge spent the summer and autumn of 1877 in the Black Hills,

practicing law and speculating in the mines. He is a close student, and has a good standing at the bar in his district.

In politics, he is a republican. In religion, a Presbyterian, and a man of excellent character. He is a Master Mason, and a fifth-degree member of the Odd-Fellows order.

Miss Lizzie Pierce, of Page county, Iowa, became the wife of Judge Stockton on the 20th of August, 1863, and they have three promising children.

JOHN TEESDALE,

MOUNT PLEASANT.

ONE of the oldest representatives of the press living in Iowa is John Teesdale, who, like Dennis A. Mahoney, of Dubuque, Wesley Bailey, of Decorah, and a few others in this state, spent thirty or forty years in a printing office. Mr. Teesdale is a native of York, England, is a son of Robert and Elizabeth (Overton) Teesdale, and was born on the 25th of November, 1816. His parents emigrated to this country when he was two years old and settled in Philadelphia, where his father was a merchant, who died when the son was about ten years old. Two or three years later John entered the office of "The Casket," Philadelphia, doing various kinds of work, but not much at the case. He partly learned the printer's trade in the same city, in the office of the "American Sentinel," finishing it at Beavertown, Pennsylvania, whither his mother, now married again, removed when he was about sixteen. Two years afterward he spent a short time at the Steubenville Academy, and then went to Wheeling, West Virginia, where he remained for several years, working at his trade part of the time, and also editing the Wheeling "Gazette" and a little later the Wheeling "Times." During this period he spent a short time at Cadiz, setting type and aiding an editor, and six months at Mount Vernon, as one of the editors and proprietors of the "Western Watchman," suddenly leaving the paper because his associate was too timid on the slavery question and they could not agree.

Mr. Teesdale was the editor of the "Ohio Whig Standard," of McConnellsville, seven or eight years, and went thence to Columbus in 1843; took charge of the "Ohio State Journal," and conducted it four or five years. He was private secretary of Governor Bartley a short time; in 1848 purchased the Akron

"Beacon," and was its conductor for eight years, selling out and removing to Iowa City, then the capital of the state, in the summer of 1856.

Mr. Teesdale became the proprietor of the Iowa City "Republican," which he published until elected state printer, in the winter of 1856-57, and his removal to Des Moines, which was made the capital in 1858. He was state printer four years. On reaching Des Moines he purchased "The Citizen," soon changed its name to "Iowa State Register," and sold it to Frank W. Palmer, the incoming state printer, in 1861.

At that time Mr. Teesdale was appointed postmaster by Mr. Lincoln, and he held the office until turned out by President Johnson.

In November, 1868, Mr. Teesdale removed to Mount Pleasant, which has since been his home, though he himself has had brief sojourns in other places. He spent seven months on a daily paper at Omaha, Nebraska, in 1870, and had charge of the "Daily Chronicle," Washington, District of Columbia, during the second campaign (1872) of General Grant for the Presidency.

Since locating in Mount Pleasant Mr. Teesdale was a short time on the "Mount Pleasant Journal," and a short time in trade with his son-in-law, George P. Okell. Latterly he has engaged in no business.

Mr. Teesdale was originally a whig, and was a delegate to the national convention which nominated General Taylor in 1848. From the birth of the republican party he has acted with it, and his pen has wielded a powerful influence in promulgating its principles. Probably no journalist now living in the state has done more to advance the cause of his party.

Mr. Teesdale has been a member of the Congre-
