PHINEAS CADWELL

Died at his home in Logan, Iowa, on the morning of February 26, 1904. Hon. Phineas Cadwell, aged 79 years, 10 months and 9 days.

Mr. Cadwell was known to nearly every one in this county, having settled here in the year 1854 and having lived here continuously except for a few years when he resided in Kansas. He was particularly well known during the earlier years of the county for he was identified with nearly every public enterprise and a familiar figure at all public functions.

He came of a line of Scotch ancestry who immigrated to America in 1620. They were prominent in the early history of the country, especially of New England, and took part in the wars of independence and of 1812. They were all noted for traits of sterling integrity, untiring energy and fraternal devotion. They were all long lived and each left numerous posterity.

Mr. Cadwell was born in Madison County, New York, on April 17, 1824. He was married to Harriet Newell Fiske in 1845. They first settled in Wisconsin, then coming to Iowa with teams in 1854. Seven children were born to them: Charles E., born in 1848, dying in 1861; Mary E., born in 1849,

While not gifted with wealth, Mr. Cadwell early acquired a competency. He was at one time the owner of the town of Eagle Grove as well as a large amount of real estate. To the younger generation he presented the aspect of a man remarkable in any assembly; to the older he presented the living embodiment of sociability and was the constant reminder of days which called out the true worth of men and linked the pleasures, the hardships and the friendships of those earlier days.

He was buried on February 28th in Silver Prairie cemetery. himself to work in the woolen mills in Lowell, Massachusetts. He next is heard of in Buchanan county, Iowa, running a farm and selling corn at twelve cents and wheat at thirty cents the bushel.

Captain Stocker was much attached to the Grand Army Post at Logan and was an enterprising citizen. Under President Benjamin Harrison he received the appointment of postmaster at Logan, which position he filled acceptably and well until the election of President Cleveland when he had to step down and out. In a few years his health declined and he died September 7, 1893.

HON. PHINEAS CADWELL.

So long as there remains a pioneer, or the son or grandson of a pioneer, in Harrison county, the above name will be recalled in recounting the men of influence and integrity in this part of the state. As a citizen and as a leading light in the Reorganized Church of the Latter-Day Saints, Phineas Cadwell will be remembered as long as the longest. The Cadwell family is still numerous in this section. It had its origin in Scotland, and was largely represented in the American Revolution.

Phineas Cadwell was born in 1824 in New York state, and in 1842 became a resident of the then wild section near Racine, Wisconsin. In 1854 he came to Harrison county, Iowa, and settled in section 36, Magnolia township, and at one time owned an even thousand acres of Harrison county land, but parted with most of it before it had come to be of great value, as compared with today's prices. All in all, he had possessed seventeen hundred acres in his own name, but as the years sped by he parted with many of his broad prairie tracts, giving each of his children good pieces. In 1874 Mr. Cadwell, in association with his brother-in-law, started banks at Logan and Woodbine. Neither of these proved a financial success, and his last years were not as successful as his earlier years had been.

Politically, Mr. Cadwell was a supporter of the Republican party and in 1871 was elected to a seat in the Iowa Legislature. In 1861 he was elected a director of the state agricultural society, and was a member of the society for twenty odd years. He also was president of the Harrison county agricultural society for about twenty years. In his religious faith Mr. Cadwell held to that of the Reorganized Church of the Latter-Day Saints (sometimes styled Mormons), and was firm in all the teachings of this sect, save in the matter of polygamy, which latter tenet the members of the

reorganized body earnestly denounce as wicked and sinful in the extreme. Mrs. Cadwell died in Logan, Iowa, September 1, 1891, and Mr. Cadwell passed from earthly scenes February 26, 1904, at the age of seventy-nine years.

JOHN C. McCABE.

Among the pioneers of Harrison county who are justly entitled to a place of prominence in the annals of this county is the late editor and proprietor of *The Logan Observer*, who for twenty-one years exerted a wide influence in the county and state, by reason of his fair, clear and open editorials, many of which were widely quoted throughout the state and nation.

John C. McCabe was born near the line of King county, New York, May 5, 1840, a son of Francis and Elizabeth (Connaughty) McCabe. The father was a native of County Cavan, Ireland, born in 1817. He married at the age of nineteen and sailed for America, landing at New York harbor, April 16, 1840, after a six weeks' voyage on the Atlantic. For six years the family resided near Albany, New York, then moved to Canton, Massachusetts, fifteen miles from Boston, where they remained until 1848, in which year they emigrated to a point near Oshkosh, Wisconsin, locating on a farm where the father died May, 1884. The wife and mother died February 11, 1863, aged fifty-five years.

John C. McCabe attended the common district schools in Wisconsin, until nineteen years of age, assisting his father to clear up a farm, the surface of which was covered with heavy timber and rubble. As a monument to this work the old stone fence still remains, the same having been built from the stones gathered about the premises. Mr. McCabe also attended the high school at Oshkosh after which he bade adieu to Wisconsin and on August 30, 1861, went to Scott county, Iowa, where for three months he clerked for an uncle. He then taught school until 1864, after which for eight months he traveled in different states and territories. He had decided to cross the plains, but upon arriving at Council Bluffs, concluded he would abandon the trip west and he retraced his steps to Harrison county, locating in Raglan township. That summer he worked for Charles Gilmore on the farm, and in the winter commenced teaching school, which vocation he followed until 1880. He taught at least five months each year of this time, his service covering four townships in Harrison county. In the spring of 1867 he purchased a farm in sections 12 and 13, Raglan township, the same con-
