DEATH OF MAJOR WARNER

PASSED AWAY AFTER A SECOND
STROKE OF PARALYSIS.

A Prominent Citizen of Waubeek and
Father of Postmaster Warner
of Central City.

Major Edgar Allen Warner, father of Postmaster C. B. Warner, of this place, ex-member of the legislature, died at his home in Waubeek at 2 a. m. Wednesday, January 28th, 1903, after a second stroke of paralysis, aged 73 years and about five months. The funeral occurred today at 2 p. m., from the Waubeek Baptist church, Rev. Chas. E. McColley officiating, the funeral being in charge of the G. A. R. Post of this city, of which he was a member.

The deceased leaves a wife and four children to mourn his departure. The children are Mrs. Stewart Kennedy, Waubeek; Mrs. Charles Lacock, Linn Grove; Chas. B. Warner, Central City; Miss Sadie B. Warner, McIntosh, Georgia. All these except Miss Sadie were at home when he passed away.

The funeral was very largely attended, a testimonial to the high esteem in which the gallant Major was held.

MAJOR E. A. WARNER JOINS MAJORITY

He was one of the Pioneers of This Section, a Brave Soldier and an Honored and Successful Business Man.

Major Edgar A. Warner, for nearly half a century a resident of Linn county, died at his home at Waubeek, Wednesday morning, from apoplexy. He was one of the early legislators of Iowa, having represented this county in the state assembly in 1868. The greater part of his life was devoted to the business of building contractor and a number of years ago erected a number of the fine buildings in Santa Anna, Cal., and also built the government pier at San Diego. In an early day he built several grist mills in this county and other counties in this part of the state. He was 73 years old and leaves a wife and four children: Mrs. Stuart Kennedy of Waubeek, Mrs. Chas. Laycock of Linn Grove, Miss Sadie Warner, a teacher in an industrial school in Georgia, and C. B. Warner, postmaster at Central City.

The career of the decedent is identical with that of many of the older residents of the Hawkeye state who started out alone in the world and carved out their fortunes by sheer determination and attained a position of which they had reason to be proud. He was born in Livingston county, N. Y., Oct. 5, 1829, and started out for himself when he was fourteen years old. He served a thorough apprenticeship at the millwright business and followed it more or less most of his life. With little experience he became also a skillful engineer and followed this occupation for several years on the public works of the state of New York. He remained in his native county until the spring of 1854, when his adventurous disposition led him to desire something beyond what the limits of his environment could afford. He accordingly turned his face westward and traveled through the streets of Indiana and Illinois, crossed the Father of Waters and came to a halt in the Hawkeye state. He was well pleased with the looks of the country and concluded to settle for a while at least.

AUSTRIAN TARIFF RADICAL

Vienna, Jan. 29—The tariff has been laid. The duties on many articles are increased, generally but specially high duties in the finest grades. Principal changes interested in the United States are the following: Cotton yarns raised 10 per cent. Leather 10 per cent. Shoes 10 per cent. Fancy leather trebled. Raw tobacco raised to \$24 per hundred about 267 pounds. Every article increased 50 to 100 per cent. Electrical dynamos increased 20 to 35 per cent. The duties on the apparatus are doubled on agricultural machinery 20 per cent, with steam plows and the like on which is not charged. he became a resident of that place,
as it were, by the necessity of the
situation. He was not displeased by
this, however, for he soon found
himself on the road to a competence.

When the civil war broke out Mr.
Warner lay aside his personal inter-
ests and the demands of business,
determined to go to the rescue of the
union. He organized Company H,
which became a member of the Four-
teenth Iowa infantry and he was com-
missioned captain of the company.
He served in this capacity till the
spring of 1862, and then was promot-
ed to the rank of major of the regi-
ment, a position he held till he was
mustered out in December, 1864. He

and settled in Maine township, Linn

after. Mr. Bennett was fatally in-
jured by the kick of a horse Sep-
tember 5, 1871, and the death of his
wife occurred in 1872.

It was in the fall of 1868 that Mr.
Warner was elected to the state
legislature, where he served one
term, being a portion of the time
chairman of the committee on mili-
tary affairs. He also served on the
committee on expenditures and was
a member of other important com-
mittees. He had also served as a
member of the county board of
supervisors and had held minor pub-
lic offices. He stood high in Ma-
sonic circles, being a member of the
Royal Arch chapter, and also of the
Marvin Mills post No. 212, G. A. R.
He was a splendid citizen, a brave

man. He was always a republican

though for a number of years he
had not taken an active interest in

UNIQUE LAW PROPOSED IN UTAH LEGISLATURE

Salt Lake City, Utah,
Jan. 29—Every habitual building in

Obituary of One High in the Esteem of His Fellow Men.

Edgar Allen Warner was born in Livingston county, N. Y., October 5, 1829. At the early age of 14 he started out into the battle of life, a battle that he fought bravely and well as was attested by his success and the esteem in which he was held in this community during his life here.

A thorough apprenticeship at the millwright business gave him an occupation and he also became a skilled engineer, following that line on the public works of his native state. In the spring of 1854 he joined the westward movement and landed in Jackson county, Iowa, where he followed his trade of millwright for one year. He then went to Wisconsin and finally back to his home county in New York. He returned to Jackson county, Iowa, where he remained until 1857, when he came to Linn county. He came to Waubeek to build a grist mill, and taking land in payment for his work, settled there and became prosperous.

Mr. Warner's sense of duty to his country took him gallantly into

public life, brave in battle, and high in the esteem and love of his fellow men, he will be remembered and revered by all who knew him.

HOCKED BY SAD DEATH

COMMUNITY MOURNS LOSS OF A LOVED ONE.

Sudden Passing Away of Mrs. Maud Heaton Giffen Saddens the Hearts of Relatives and Friends.

Mrs. Maude Heaton Giffin, wife of Ernest N. Giffin, died at the residence of her parents, Mr. and Mrs. A. Heaton in Central City at 15 Sunday morning, February 1908.

Her death was sudden and startling to the extreme. She was taken ill Friday night, and Dr. Woodruff was called at 6 o'clock in the morning and found her suffering from convulsions. The doctor stayed with her all day, and in the afternoon called Dr. Skinner and Dr. Fisher to his aid, and the three worked heroically to save her life, but their efforts were fruitless, and she was called away at midnight.

Her trouble was what is called uremic poisoning, coming from kidney trouble, and the larger percentage of all such cases are fatal.

The news of Mrs. Giffen's sudden death cast a gloom over the community. Born and raised in Central City, she was loved and respected by everybody. Of a generous and kindly disposition she made friends everywhere, and her taking

MAJOR E.A. WARNER DIES AT WAUBECK

A RESIDENT OF LINN COUNTY FOR ALMOST 50 YEARS.

Identified With All the Early Interests of the County and Erected Several Flour Mills Here and at Waubeck.

Major E. A. Warner died Wednesday morning at his home in Waubeck. Maj. Warner has been a resident of Linn county for almost 50 years and represented Linn county in the legislature in 1868.

He was a prominent contractor going at one time to California to erect some fine buildings at Santa Ana, and also built a government pier at San Diego.

He was identified with all the early interests of Linn county, and has erected several flour mills here and in Jones county.

Three years ago he was stricken with apoplexy, but the stroke being light he made a partial recovery, but has remained an invalid until Sunday morning last, when he had another stroke, and at 2 o'clock a. m. Monday morning another shock came and he survived until this morning.

He leaves a wife and four children. Postmaster C. B. Warner of Central City being his son. His daughter Miss Sadie Warner, is teaching in the industrial schools of Georgia, among the colored people, and his eldest daughter is Mrs. Stuart Kennedy of Waubeck, and his second daughter is Mrs. Chas. Lacock of Linn Grove.

Mr. Warner was a soldier for three years in the Fourteenth Iowa, holding a major's commission, and was at one time an adjutant on the staff of Gen. A. J. Smith.

One by one the old settlers' ranks are thinning and it will be only too soon that the pioneer old settler will be but a memory.

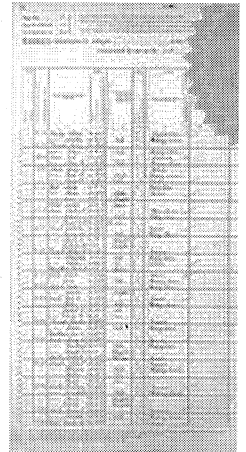

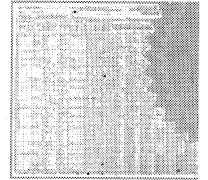

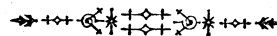

her last husband being Samuel Heaton, a brother of the other two. Samuel Heaton was born in St. Lawrence County, and came to Iowa with the remainder of the family. When he first came to this county he made a claim on section 34, township 87, range 6, which he sold after his marriage, when he settled on the place which his brother had entered previously. In a short time he also sold this and purchased a claim on section 35 of Jackson Township, which he improved and cultivated until 1875. Then he sold this also, removed to Kansas, and took up a homestead and timber claim in Phillips County. There he improved a good farm and spent the remainder of his life, his decease occurring Feb. 8, 1886. His widow survives him and still lives there. She was the mother of nine children. By the first marriage were two daughters, both of whom died young. By the second, two sons—the subject of our sketch, and his brother Joseph; the latter died in early youth. By the third marriage were five children, all of whom are living: James, William, Annie (the wife of J. D. Matteson), Benjamin Franklin and Nathan C. All these latter, except William, live in Phillips County, Kan.; William lives in Jackson Township.

Peter A. Heaton was reared on the farm and attended the district school. During the Rebellion he enlisted as a soldier, Oct. 11, 1862, becoming a member of Co. K, 6th Iowa Vol. Cav., and served until the close of the war. His duties led him to the frontier. He served bravely and faithfully, and received an honorable discharge at the close of the war. After returning from the army he purchased a farm in Maine Township on section 1, which he operated for three years, then sold out and came to Central City, and in 1873 opened a store, and was in trade three years, when he disposed of his stock and returned to his former occupation as a farmer. He first rented a tract of land, and then purchased the old homestead in Jackson Township, remaining upon it until 1882, when he sold the farm, came to Central City, and engaged in the butchering business until 1886, in the spring of which year he opened his present place of business, which he has carried on with success.

Peter A. Heaton and Miss May A. Sawyer were united in marriage Dec. 31, 1865. Mrs. Heaton is

a native of Massachusetts, born in Middlesex County, and the daughter of Abner A. and Sophia (Gillum) Sawyer. Their marriage has been blest by the birth of four children, all living: Susie, Curtis, Maude and Benjamin. Mr. and Mrs. Heaton are esteemed members of society and regular attendants of the Methodist Episcopal Church, being connected in regular membership with that society. Mr. Heaton is a fair and square business man, and a general favorite with the business portion of Central City. Politically he is a Republican.



HON. EDGAR A. WARNER. The career of this gentleman presents a vivid picture of what may be accomplished from a humble beginning. It is no drawback to any youth to be obliged to rely upon his own resources; nothing is better calculated to stimulate his self-respect and to build up within him a character of manliness and true courage. The history of Mr. Warner is identical with that of many of the older residents of the Hawkeye State who started out alone in the world, and carved out their fortunes by sheer determination, and attained a position of which they have just reason to be proud.

The parents of our subject were Ebenezer and Sarah (Hamilton) Warner. They were natives of Vermont and New York State respectively, and were the representatives of good old family names whose history was replete with good deeds and noble lives. They settled in Livingston County, N. Y., after their marriage, and engaged in agricultural pursuits. The life of Ebenezer Warner terminated in Livingston County, and he was laid to rest in its soil. The mother still survives, and resides on the homestead made sacred by early memories. They became the parents of five children, viz.: Lucinda, Edgar A., Harriet, Thomas J. and Octavia.

Edgar A. Warner was born in Livingston County, N. Y., Oct. 5, 1829, and started out for himself when he was fourteen years old. He served a thorough apprenticeship at the millwright business, and has followed it more or less up to the present time. He was quick-witted and observant, and there were

very few things passing around him that he did not notice. With very little experience he became a skillful civil engineer and followed this occupation for several years on the public works of the State of New York. He remained in his native county until the spring of 1854, and then his adventurous mind led him to desire something beyond what the limits of his native county could afford. He accordingly set his face westward, traveled through the States of Indiana and Illinois, crossed the Father of Waters, and came to a halt in the Hawkeye State. The face of the country pleased him, and he concluded to tarry awhile. His first business was to obtain employment, in which he succeeded, and he followed his trade of millwrighting for about one year in Jackson County. Then he went into Wisconsin, roamed over the Territories of Minnesota and what now is Dakota, to his satisfaction, and completed the circle of his travels by returning to his native county in New York State. There was no place like home, and he concluded to remain for a time amid old scenes and associations. He had accumulated some means, notwithstanding his wanderings, and while tarrying in Livingston County, erected two gristmills, after which he again went to Iowa, and remained there until the fall of 1857, in Jackson County, when he proceeded to Linn County. Previous to his location here in Waubeek, it was proposed to him to erect a gristmill, and after the work was completed he was obliged to accept land in payment for his labor, and consequently became a resident as it were, by force. He was not displeased at this, however, as he soon found himself on the road to a future competency.

When rumors of war began to be heard in the land, and the Rebellion had assumed alarming proportions, Edgar A. Warner, laying aside his personal interests and the demands of business, determined to go to the rescue of the Union. Leaders must be had, and he was selected as one well calculated to fill the post of an officer. He accordingly organized Company H, which was attached to the 14th Iowa Infantry, and Mr. Warner was commissioned as Captain of the company. He served in this capacity until the spring of 1863, and then was promoted Major of the same regi-

ment, which position he occupied until he was mustered out in December, 1864. He participated in all the engagements of his company and regiment, and at the battle of Shiloh was taken prisoner. This was on April 6, 1862, and he was held for seven months, and finally exchanged in October of the same year. His place of confinement was in Talladega, Ala., whence he was removed to Selma, Ala., then to Atlanta, Ga., from there to Madison, Ga., thence to Libby Prison, Richmond, where he was exchanged. After he was mustered out of the service, Mr. Warner returned to Waubeek, and engaged in contracting and building, which he has followed up to the present. During the years of 1879-81, he was in Nebraska, engaged in building mills, and became quite noted for his skill and excellent judgment in the construction of these manufacturing.

The marriage of Mr. Warner and Miss Laura A. Bennett was celebrated in November, 1862, at Waubeek, Iowa. Mrs. Warner is a daughter of William and Joanna (Wiggins) Bennett, natives of New Hampshire. They were married in Wakefield, and settled in Tamworth, that State, where they remained until 1857. In the spring of that year, feeling confident that he could better his condition in a more western locality, Mr. Bennett with his wife, emigrated to Linn County and located in Maine Township, where they remained until their decease. The father was fatally injured by the kick of a horse, and died Sept. 5, 1871; the mother died Dec. 8, 1872. They were the parents of five children—George W., Eliza, William H., Laura A. and Joseph.

Mrs. Laura A. Warner was born in New Hampshire, May 8, 1833. By her union with our subject she has become the mother of five children, and the record is as follows: Effie is the wife of Stewart Kennedy and resides in Ayrshire, Palo Alto Co., Iowa; Frank died March 28, 1871, at the age of fifteen months; the remaining children are, Charlie B., Maude L. and Sadie B.

Mr. Warner was elected to the Iowa Legislature in the fall of 1868, and served one term. He was, for a portion of the time, Chairman of the Military Committee, the Committee on Expenditures, and a member of other important committees during

the sessions of that year. He has been a member of the County Board of Supervisors for two terms, and has held other minor offices. He is a member of the Royal Arch Chapter, also a member of Marvin Mills Post No. 212, G. A. R.

During his army experience Mr. Warner was detailed on Gen. A. G. Smith's Staff as Provost-Marshal of the 16th Army Corps, and prior to that time he had served ten months on the Military Commission at Columbus, Ky. He was there detailed to muster the State troops of Tennessee into the United States service. Among these was included the 13th Tennessee Infantry, which, with the commanding officer, Col. Bradford, was massacred at Ft. Pillow.

The career of Hon. Edgar A. Warner has been an interesting one to follow. It has shown a man who proved capable to a surprising degree, in adapting himself to all the circumstances of a busy and varied life. As a citizen he has performed his part well, and as a soldier, most nobly. He has lost none of his youthful energy of character, and were he put to the test there is no doubt he would display the same bravery and earnestness of purpose that characterized him in his younger years. He has a fine homestead in Waubeek, besides other property. He is Republican in politics, endorsing the principles of that party with all the conscientiousness and energy which has characterized his conviction upon all other questions of the day. He has made his ineffaceable mark in this part of the Hawkeye State, and as a citizen, his place when made vacant, will be a difficult one to fill.



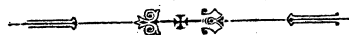

He received a fair education in the common schools, the latter part of it being completed in this State after the removal of his parents here. He is the son of M. S. and Mary A. (Gamberton) Remington, and was a young child of four years old when his parents came into Iowa. Most of his life has been spent upon a farm, the labors of which he has alter-

nated with teaching school, having taught in Linn County for thirteen winters successively.

Mr. Remington is the proprietor of seventy-four acres of good land. He was married in Linn Township Nov. 1, 1871, to Miss Cordelia, daughter of Leonard and Elizabeth (Cauke) Anderson. Mrs. R. was born in Knox County, Ohio, Nov. 13, 1854, and by her union with our subject has become the mother of one child—a son, Guy A., born May 2, 1881.

After the death of his father, the mother of Mr. Remington was married to Mr. C. W. Webster, a sketch of whom appears in another part of this work.

Politically Mr. Remington is identified with the Republican party. He is leading a quiet and unostentatious life as a good citizen, a kind neighbor and generous friend, and filling his position in life as the promoter, to the best of his ability, of every good work and purpose socially, morally, religiously and politically.



FRANK MITTVALSKY is one of the leading butchers of Cedar Rapids, dealing in all kinds of choice meats, and carrying on his business in a highly successful manner. He has been a resident of the city for fourteen years, and in the fall of 1870 established his present business, being located at No. 44 First street. He was obliged to suspend operations for a while on account of impaired health, and for three years was scarcely able to superintend it, but on recovering resumed his occupation with all the old energy and enterprise. He has established a good trade and accumulated considerable property. He occupies a handsome brick residence at No. 303 Second street, which he built himself, and also erected his present commodious market house.

Mr. Mittvalsky is a native of that Bohemian Province which has contributed so largely to the development of the Hawkeye State. He was born in October, 1843, and remained with his parents until he emigrated to the United States in 1870.
