



HOYT SHERMAN DIED YESTERDAY

A Severe Attack of Pheimonia
Proves Fatal To Noted

MEMBER FAMOUS FAMILY

No Arrangements Have as Yet

Been Made For the

Funeral.

Major Hoyt Sherman, of Fifteenth and Woodland avenue, died yesterday at 12:80 p. m., after a long illness. His recovery had been expected, after a severe attack of pneumonia several weeks ago, and from which he rallied rapidly. His age and the continued inclemency of the weather were deterrent influences in his convalence which he was unable to overcome.

Only his son. Arthur, was in the city at the time of Major Sherman's death. The other children were wired at once, and Mr. Charles Sherman, who is practicing law in Chicago, will arrive this morning, the others coming later. Until they arrive no arrangements will be made relative to the funeral.

For almost sixty years Major Hoyt Sherman was one of the most prominent business men of this city. As postmaster, as head of a large banking firm, as organizer of the first street car company in Des Moines, as representative of the public in many trusted official positions, as organizer of the first and best insurance companies, as head of the Des Moines branch of the solid state bank in every capacity he was one of the leading man of the community. His accumulation of property was very successful and his prominence in financial and business circles placed him among the coterie of men who not only saw Des Moines grow from the sub-foundation, but who helped, also, to build the foundation and the superstructure.

Major Sherman, was born November 1, 1827, at Lancaster, O., and was the youngest son of Charles R. Sherman, whose family attained distinction beyond that accorded to most families, in that all of his sons made very conspicuous successes. That of Maj. Sherman has been alluded to. Senator John Sherman and General W. T. Sherman left imperishable names. SHERMAN, HOYT—Among the early pioneer settlers who have watched the growth of this populous city, from a little hamlet of a few houses to its present population, and have seen it take its place as the metropolis of Iowa, is the name which heads this sketch. He is the son of Hon. Charles R. Sherman, Judge of the Supreme Court of Iowa, from 1825 until his death, which occurred in 1829, and brother of Hon. John Sherman, Secretary of the Treasury, Gen. W. T. Sherman of the U. S. army, and of the late Hon. Chas. B. Sherman, Judge of the U.S. Court, for the Northern district of Ohio, and was born in Lancaster, Ohio, November 1, 1827, and until eighteen years of age divided his time between attending school and learning the trade of printer with his brothers Charles and John in Mansfield, Ohio. He then followed a cherished plan to emigrate West, and early in the spring of 1848 he came to Iowa and settled in Des Moines. and in 1849 was admitted to the bar. His first business engagement was with Thomas McMullen, School Fund Commissioner. He became connected with Casady & Tidrick and served as deputy postmaster until 1849, when he was appointed postmaster by President Pierce, and held the office until 1853 when he resigned and recommended his successor, who was appointed. In 1849 he was elected clerk of the District Court. Mr. Sherman was one of the organizers of the State Bank of Iowa, and was cashier of the same until 1861 when he was appointed a paymaster in the U.S. army with the rank of major. After his return from the army he engaged for a short time in mercantile pursuits. He was one of the incorporators of the Equitable Life Insurance Company, and in 1868 took the general management of the same and still holds this position. As a citizen he has always shown a worthy public spiritedness, and has heartily sympathized with all local improvements and enterprise. In April of 1898, and in June of 1899, I corresponded with his widow, Maria Freeman Gray, with a view to obtaining data in reference to the nativity and early life of Judge Gray. She responded, by saying, that she would be very glad to furnish me with a short biographical sketch, which she had prepared, but that she had sent it to Des Moines for publication. I think this publication was never made; at least, after diligent search, I have been unable to find it. Mrs. Gray was a woman of rare accomplishments, and the author of a number of magazine articles. The letters referred to were written by Mrs. Gray, from San Francisco, where she had become a resident, and where she was then President of the Woman's Christian Temperance Union.

Hoyt Sherman, Lampson P. Sherman, Barlow Granger, Madison Young.

I became acquainted with Hoyt Sherman about fifty years ago. The last time I saw him was at a reception given at his house to the members of the Pioneer Law Makers' Association, in attendance at their meeting of 1898, before which I had delivered an address on invitation of its President, coming from Kansas City for that purpose. His house was most hospitably opened to the members of the Association, and many of the Legislature which was then in session. It was a notable occasion. I then thought he had yet many years before him, but in this his family and friends were disappointed, for he died at Des Moines in 1904. He was one of the early lawyers of Des Moines where he came from Ohio in 1848, and in 1849 was admitted to the bar and entered upon the practice there. For a time he was associated with Judge P. M. Casady and R. L. Tidrick in practice. He was a man of high character, indominitable and gifted, and had he persevered in the profession, would beyond question, in my judgment, have attained superiority. He could not, however, resist his impulse for business enterprises, in some of which during his life he became prominent. He belonged to a remarkable family. His father, Charles B. Sherman, was a Judge of the United States Court for the Northern District of Ohio. His brother, John Sherman, was the distinguished United States Senator from Ohio, Secretary of the United States Treasury, and came very near the nomination for President of the United States when General Garfield received the nomination. I recollect that it was said at the time that the great power and eloquence displayed by Garfield in presenting the name of John Sherman to the convention, was so potent in his own favor that it turned the attention from Sherman to himself and resulted in his own nomination. Another brother was the illustrious General William T. Sherman, whose triumphant career shed not only a lustre upon the profession of arms, but on his own name and that of his country. Another brother was Lampson P. Sherman, one of the early settlers of Des Moines.

Hoyt Sherman was born in Lancaster, Ohio, in 1827. Before studying law, he had learned the trade of a printer with his brothers, Charles and John, in Mansfield, Ohio. After coming to Des Moines, and in 1849, he was appointed Postmaster,

by President Pierce, and held that office until he resigned, and recommended his successor who was appointed in 1853. He was one of the organizers of the State Bank of Iowa, and was its Cashier until 1861, when he was appointed a Paymaster in the United States Army with the rank of Major. After his return from the army he engaged for a short time in mercantile pursuits. He was one of the Incorporators of the Equitable Life Insurance Company, and in 1868 became its general manager. In 1854 he established the banking firm of Hoyt Sherman & Co. He was the author of several instructive papers on banking, among which are, "Early Banking in Iowa," appearing in Volume Five of the Third Series of the Annals of Iowa, and another entitled, "The State Bank of Iowa," appearing in the same volume. He took an active part in preserving and perpetuating Iowa history and may be regarded as one of its notable and most valuable sons. Like his brothers, John and General Sherman, he was tall in person, quick in perception and movement.

Lampson P. Sherman, though less conspicuous than any of the brothers mentioned, was nevertheless a man of sterling qualities and real ability. In his father's family there were eleven sons and daughters, of which he was the seventh. In a History of Polk County, published in 1880, he is classed among the early lawyers of Des Moines, but I fail to find any evidence in support of his being in the profession. When I first became acquainted with him, he was occupying a position in the State Bank of Iowa at Des Moines, or that of Hoyt Sherman & Co., and which he continued to occupy until 1886, when he was appointed United States Revenue Collector for his district, and held that office until 1883. He was the third Mayor of Des Moines, in 1854; in 1855, its Recorder, and in 1858, its Treasurer. He was for many years prominent in its public affairs and always administered the trusts committed to him with perfect fidelity. He was born in Lancaster County, Ohio, in 1821; came to Des Moines when it was then known as the frontier settlement of Fort Des Moines, in 1849, where he continuously resided for nearly fiftytwo years, and until his death in 1900, at the age of seventy-nine. He had learned the trade of printing, and upon coming to Des Moines, he was induced to take up journalism, and commenced the publication of The Fort Des Moines Weekly Gazette. Dr. Johnson in his essay on Milton, says, if I recollect rightly, that "if he had been the first, he had been the greatest of epic poets." Homer had the precedence. So if Barlow Granger's Star had not been established a few months before, the Gazette would have been the first paper published in Des Moines. Gazette, however, was doomed to an ephemeral existence; the name was changed to the State Journal, but after a few months of adversity its material was sold to the office of The Star.

Barlow Granger was an interesting figure in Iowa history. He had witnessed most of its important periods. He lived until after he had entered upon his ninetieth year, and at the time of his death knew perhaps, more of Iowa men and events



He served in that position three terms with marked ability. In 1881 he was nominated by the Republican party for Governor and elected by a large majority. He was reflected in 1883. HOYT SHEEMAN, son of Charles B. Sherman, dudge of the Supreme Court of Ohio, was born in Lancaster County, November 1, 1827, and is the younger brother of John Sherman, the distinguished Ohio statesman, and of Geneval William T Sherman of Civil War fame. In 1849 he was admitted to the bar and began to practice law, and also engaged in real estate business. That institution owes much of its stability and high standing to the fine executive ability and unquestioned integrity of Major Sherman. In 1866, Major Sherman was a member of the House of the Eleventh General Assembly where he was chairman of the committee on railroads and a member of the committee of ways and means. In 1886 he was one of the founders of the Pioneer Lawmakers' Association and has always been one of its most influential members, serving as president and long a member of the executive committee. He has contributed valuable historical articles to the Annals of Iowa on "Early Banking in lowa," and on the "State Bank of Iowa." For many years he was the executive officer of the Associated Charities of Des Moines.

JOHN C. SHERWIN was born at Berlin. Eric County, Ohio, February 6, 1851. His early education was acquired in the public schools and later he attended Ripon and Beloit colleges in Wisconsin. After leaving college he entered the Madison Law School from which he graduated in 1875. He removed to Mason City, Iowa, in 1876, where he entered upon the practice of his profession. He was mayor of that city in 1884-5, and the latter year was elected District Attorney of the Twelfth Judicial District. In September, 1888, he was appointed by the Governor to fill a vacancy as judge of the District Court and was continuously reëlected, serving until 1900 when he became a judge of the Supreme Court, having been elected on the Republican ticket.

JAMES H. SHIELDS was born near Bowling Green, Missouri, May S. 1842, and soon after his parents removed to Dubuque, Iowa, where his early education was acquired. He was sent to Union College, New York, where he graduated in the class of 1562. Returning to Dubuque he studied law, was admitted to the bar and followed that profession for thirty-nine years. He was elected on the Democratic ticket District Attorney for the Ninth Judicial District in 1883, serving four years. In 1889 he was elected to the State Senate, serving in the Twenty-third and Twenty-fourth General Assemblies. He was a delegate at large and chairman of the Iowa delegation to the Democratic National Convention at Chicago in 1892. He has been for some time president of the Dubuque Business Men's League, an organization composed of jobbers, manufacturers, real estate owners and capitalists of Dubuque.

JOHN G. SHIELDS was born on the 22d of May, 1811, in Grayson County, Kentucky. He was one of the earliest settlers in the "Black Hawk Purchase," long before it was organized into Iowa Territory. In 1835 he went to the Dubuque lead mines and established a store which for more than twenty years furnished goods for the early settlers in the lumber regions of Wisconsin and Minnesota. 

MAJOR HOYT SHERMAN

Hoyt Sherman was born November 1, 1827, in Lancaster Co. Ohio, son of Charles R. Sherman, Judge of the Supreme Court of Ohio, the youngest boy of six boys and five girls. His father died when Hoyt was only three years old and he divided his time between schooling and the print shop. Sherman came to Des Moines in May of 1848 at the age of 21, to see the unsettled part of the country. "Des Moines was a pioneer community where, only a few years before, Indians had roamed and the prairie grass was waist-high." One brother, General William Tecumseh Sherman, was the Union Civil War General who led *Sherman's March* and also was in the first *Battle of Bull Run*. Another brother, the eldest, Charles, stayed in Ohio as a member of the Ohio Supreme Court. John, a brilliant financer, proposed legislation that returned the country to the gold standard after the Civil War and authored the Sherman Anti-Trust Law. He went on to serve as secretary of the Treasury under President Hayes and Secretary of state under President McKinley. James, who lived in Des Moines, established the town of Sevastopol (now a part of Des Moines) and Lampson, who was a prominent civic leader and newspaper publisher.

Hoyt associated himself with Thomas McCullen and started selling school lands granted by the state by an Act of Congress. He became Deputy Postmaster and built the second building used as a post office on the corner of Third Street and Court Avenue, and the third post office on Third Street in the rear of the Sherman Block.

In 1849, Sherman was admitted to the Bar, going into a partnership with Phineas Casady and Robert Tidrick, becoming a very prominent lawyer. The litigation at that time consisted of hog cases, rival timber claims and minor differences among neighbors.

By 1850, he was buying real estate, and became one of the biggest land owners and bankers in the state, owning 22,441 acres at one time. The practice of "entering land on time" was widespread and profits accumulated rapidly as the land market blossomed. Most were sold on credit to speculators and to settlers who were eager for land but lacked the alternative exchange medium accepted at land offices-hard cash. In such cases, the Realtor would protect the loan by entering the land in his own name, giving the other person a title bond expressing an obligation to deed the land at the end of a specified time on the payment of the loan

During the famous flood of 1851, Hoyt and three other friends boated to a hotel, tied their boat to the bannisters of the hotel stairway, climbed to the 2nd floor and ate their dinner. They were on their way to St. Louis to charter a steamboat to obtain provisions as they were getting very scarce. Sherman and three others attempted to get a flat-bottomed-skiff to Keokuk to get supplies. The water was high, overflowing the banks making it impossible to know where to guide the boat, but on the fourth day, they arrived at Keokuk, went to St. Louis and chartered a steamer, loading it with flour and other provisions. At Bonaparte, Meek's Dam proved to be impassable, and the cargo was stored and the steamer returned to St, Louis. Major Sherman then, engaged a two-horse wagon and driver to take them to Oskaloosa. It took them three days to travel through rough roads, swampy shoughs and swollen streams to get to Oskaloosa and two more on

a roomy two-horse hack, used for mail to get to Des Moines, without any supplies. "In traveling east from Iowa it was necessary to carry three different kinds of money." In 1852, Sherman was elected Clerk of District Court and by 1854, he had opened the Bank of Hoyt Sherman & Co., for the business of banking and exchange. It was largely instrumental in driving out worthless notes that had been circulating. The chief function of an early Iowa banker was "entering land on time." "Land," was the basis for all live business, and the land agent and real estate dealer evoluted naturally into a banker." Hoyt maintained that a forty percent interest rate was not excessive as "the customer could stand it."

There is some evidence, that Hoyt married first, to a bride who died very young. Major Sherman, age 27, returned to Ohio and on Christmas Day1855 and married Sara Moultan, born 14 June 1837 in Granger, Ohio at Mansfield, Ohio. "By then a mover and shaker in the growing community of Des Moines (population 2,000), sherman felt a responsibility to brave the winter eather and return to his affairs. The intrepid newlyweds traveled from Ohio to Iowa City by train, and made the rest of the rigorous 130-mile journey grom Iowa City to Des Moines by stagecoach." They had seven children, Frank Allen, Adeline, Charles M, Arthur, and Helen and two daughters that died in infancy. "Eldest son, Frank became a lawyer and lived in Des Moines, where he died in 1902; two years before his father's death. Charles, also a lawyer, moved to Washington, D.C. while Arthur, settled in California. Two daughters married and settled in the East. Helen became the author of several children's books. Adeline married Frank Wiborg, the wealthy owner of a Cincinnati ink manfacturing firm.

In 1856, he subscribed three thousand dollars to put the Capital on the West Side and two years later, the State Bank of Iowa was organized and Sherman was elected Cashier of the Des Moines Bank and he merged his bank into it.

In 1861, he was appointed by President Lincoln, paymaster in the Army, with the rank of Major and served in the Civil War. He held that position for three years and was known for his honesty, disbursing millions of dollars without loosing a penny. Major Sherman was a member of the house of the Eleventh General Assembly, where he was a chairman of the committee on ways and means.

By 1867, he helped to organize the Equitable Life Insurance Company, along with his friends, Isaac Cooper, B.F. Allen, F.M. Hubbell, and Jefferson Scott Polk. He was elected Actuary, then Secretary and later President. Sherman issued policies, collected premiums, kept books, handled correspondence and in short, ran the business. Its first home was in what was then the largest office building in the city, the Hoyt Sherman Block at Third Street and Court Ave. A bust of Sherman occupies a place of prominence in the lobby of the Equitable Building.

Sherman died January 25, 1904, after a three-week bout with pneumonia. His home was bought in 1907, when the Des Moines Board of Park Commissioners bought the mansion and five acres. Which, in turn, leased it to the Des Moines Woman's Club for ninety-nine years, at one-dollar a year, with the stipulation that they add a public art gallery. They added a large one-story wing to the west to serve as art gallery, a dining hall and later constructing a 1,500 seat theatre adjoining the house to the east, a center for the city's cultural events. The "Hoyt Sherman Home" has been maintained by the Des Moines Women's Club since 1907, housing the city's first art gallery with an outstanding collection. Many cultural events are held there and is open to the public for a small fee.

Blk 9, 0008 Sherman Vault, originally had a wooden door, but it was replaced with cement blocks after the mausoleum was broken into and Sarah's skull was stolen. "Someone pulled the coffin from its resting place in a Woodland Cemetery mausoleum in Des Moines recently, broke the glass lid and disturbed the contents." "Detective Greg Hansen said the intruders broke a stone plate covering the end of the chamber. The heavy metal coffin with the glass top was pulled out and dropped on the floor." "Two small stones mark the location of two infant daughters of Sarah and Hoyt Sherman, police said. It was found in an east side home and returned to the mausoleum and the opening was cemented shut.


Hoyt Sherman came to Des Moines in 1848, five years before the city was incorporated. He established the first city bank, city railroad, public school, college, waterworks and post office. He was one of the founders of Equitable Life Insurance Company of Iowa, the first insurance firm in the state. Construction of his Italianate-style home was completed in 1877. It served not only as his family residence until his death in 1904, but as a social gathering place for local and national notables including Hoyt's brother, General William Tecumseh Sherman. The city purchased the home from the Sherman heirs in 1907, when it became the home of the Des Moines Women's Club.

HOYT SHERMAN PLACE - CULTURAL LANDMARK

The original home is graced by handcarved wainscoting and marble fireplaces, impressive woodwork, parquet floors and rococo plastering. The handsome entryway reveals the architectural beauty of the Victorian age with its high arched doors constructed of five varieties of hardwood. The original etched glass windows accentuate the entry doors. The "umbrella room" for top




ART GALLERY 1907 ORIGINAL HOME 1877 THEATRE 1923




hats and capes, was a necessary part of a home in the Victorian era. The dining room is complete with its outstanding buffet which boasts spelter relief medallions mounted in the doors.

A magnificent walnut staircase leads to the second floor. A period bed/sitting room has been recreated in what was originally part of the servants' quarters. Two large reception/meeting rooms exhibit an interesting collection of American and foreign decorative and fine arts. A 1796 handcrafted sampler, tatted Inca collar, rare black basalt Wedgwood vases and Chippendale game table are highlights.

It is the purpose of the club, with the city council's consent, to enlarge the art gallery and auditorium rather than build another art gallery, and steps have been taken to that desirable end."



HOYT SHERMAN, son of Charles R. Sherman, Judge of the Supreme Court of Ohio,

was born in Lancaster County, November 1, 1827, and is the younger brother of

John Sherman, the distinguished Ohio statesman, and of General William T.

Sherman of Civil War fame. Until eighteen years of age, Hoyt's time was divided

between school and the printing office. In the spring of 1848 he came to Fort

Des Moines, Polk Co., IA, then far out on the western frontier. In 1849 he was

admitted to the bar and began to practice law, and also engaged in real estate

business. In March of that year he was appointed by President Taylor postmaster

of Des Moines, holding that position until the inauguration of President

Pierce, when he resigned and was elected clerk of the District Court. In 1854 he

was the senior member of the baking house of Hoyt Sherman & Co., and upon the

establishment of the State Bank of Iowa he became cashier of the Des Moines

branch and was one of the directors on part of the State to supervise the system

and guard the public interests. When the Civil War began Mr. Sherman was

appointed by President Lincoln paymaster in the Union army with the rank of major,

holding the position for three years. He was one of the organizers of the

Equitable Life Insurance Company of Iowa and for many years its general manager.

That institution owes much of its stability and high standing to the fine

executive ability and unquestioned integrity of Major Sherman. In 1866, Major

Sherman was a member of the House of the Eleventh General Assembly where he was

chairman of the committee on railroads and a member of the committee of ways

and means. In 1886 he was one of the founders of the Pioneer Lawmakers'

Association and has always been one of its most influential members, serving as

president and long a member of the executive committee. He has contributed

valuable historical articles to the Annals of Iowa on "Early Banking in Iowa," and

on the "State Bank of Iowa." For many years he was the executive officer of

the Associated Charities of Des Moines.

Hoyt initially studied the printing trade in the office of his brothers, Charles and John, in Mansfield, Richland Co., OH, while in school. In 1848, after turning 21, he was able to indulge a long-held dream to visit less-traveled parts of the country. Finding his way to Des Moines, Polk Co., IA, he quickly decided to make it his home. He soon entered public service as a school fund commissioner. His demonstrated business skills in this role earned him appointment to the position of deputy postmaster, which he held until 1849, when he was named postmaster of Des Moines, serving until 1853. As postmaster, he built the city's first dedicated post office building, moving the postal operation out of a barracks building.

In 1849, Hoyt was admitted to the bar, becoming one of the city's most prominent attornies and a clerk of the district court.

He established the bank of Hoyt Sherman and Company, building a reputation for character and integrity which earned it considerable success, particularly in the trust of the company's banknotes, an important factor in the era before the issue of any offical federal currency other than coin. In 1858, a new state constitution allowed the establishment of the State Bank of Iowa with authority to issue note. Hoyt was appointed cashier of the Des Moines branch and one of the State Bank's directors, merging Hoyt Sherman and Company into the new bank.

With the outbreak of the Civil War, President Abraham Lincoln commissioned Hoyt a major and named him a paymaster in the Army. He held the post for three years, without discrepency of even a penny.

After the war, he served in the Iowa legislature in 1866. In 1867, he was an organizer of the Equitable Life Insurance Company of Iowa, serving first as actuary, then secretary, and in Janaury of 1874 beginning a fourteen-year tenure as president.

Actively committed to the development and betterment of his home town, Hoyt was a founder of the Des Moines Water Company in 1871, and 1876, was a founder and president of the Iowa Industrial Exposition Company which sought to establish a museum for arts and industries of the state. Several years after his death, Hoyt's own spacious home, left vacant, began its evolution into the current Hoyt Sherman Place, a major performing arts center and museum.
